11	§ 651. LEGISLATIVE ADVISORY COMMITTEE ON THE STATE
12	HOUSE
13	(a) The Legislative Advisory Committee on the State House is created.
14	(b) The Committee shall be composed of <u>13</u> <u>12</u> members:
15	(1) four three members of the House of Representatives, appointed
16	biennially by the Speaker of the House;
17	(2) four three members of the Senate, appointed biennially by the
18	Committee on Committees;
19	(3) the Chair of the Board of Trustees of the Friends of the Vermont
20	State House;
21	(4) the Director of the Vermont Historical Society;

1	(5) the Director of the Vermont Council on the Arts Council;
2	(6) the Commissioner of Buildings and General Services or designee;
3	and
4	(7) the Sergeant at Arms; and
5	(8) the State Curator.
6	(c) The Committee shall biennially elect a chair from among its legislative
7	members. A quorum shall consist of seven members.
8	(d) The Committee shall meet at the State House at least one time when the
9	General Assembly is in session and at least one time when. When the General
10	Assembly is not in session or at the call of the Chair, the Committee shall meet
11	at least one time, but the Committee and any subcommittees shall not
12	cumulatively meet more than six times per year; provided, however, that the
13	Committee and any subcommittees of the Committee may meet more often
14	with the approval of the Speaker of the House and the President Pro Tempore
15	of the Senate. The Commissioner of Buildings and General Services shall
16	keep minutes of the meetings and maintain a file thereof.
17	(e) The Committee shall have the assistance of the Office of Legislative
18	Counsel and the Office of Legislative Operations.
19	(f) A member of the Committee shall not vote on a matter under
20	consideration by the Committee regarding any activities or duties the member
21	is responsible for discharging.

2	For meetings held during adjournment of the General Assembly, the
3	legislative members of the Committee shall be entitled to per diem
4	compensation and expense reimbursement as provided in subsection 406(a)

7	(a)(1) The Legislative Advisory Committee on the State House shall be
8	consulted on:
9	(1) review, coordinate, and make recommendations on all activities
10	relating to the acquisition collections and care of paintings and art, historic
11	artifacts, and furnishings, and the refurbishing, renovation, preservation, and
12	expansion of the building and its interior-; and
13	(2) The Legislative Advisory Committee on the State House shall
14	develop approve a plan for the acquisition or commission of artwork
15	collections policy for the State House collection that represents Vermont's
16	diverse people and history, including diversity of gender, race, ethnicity,
17	sexuality, and disability status, as developed by the State Curator pursuant to
18	29 V.S.A. § 154a(c).
19	(b) The Sergeant at Arms and the Commissioner of Buildings and General
20	Services, in discharging responsibilities under subdivision 62(a)(6) of this title
21	and 29 V.S.A. §§ 154(a) and 154a, respectively, shall consider the

1	recommendations of the Committee. The Committee's recommendations shall
2	be advisory only.
3	Sec. 2. LEGISLATIVE ADVISORY COMMITTEE ON THE STATE
4	HOUSE; OVERSIGHT AND MANAGEMENT OF STATE HOUSE
5	ART COLLECTION; ROLES AND RESPONSIBILITIES; STUDY
6	The Legislative Advisory Committee on the State House shall review the
7	roles and responsibilities of the Committee, the State Curator, the Sergeant at
8	Arms, and the Friends of the Vermont State House with respect to the
9	oversight and management of the State House art collection. On or before
10	December 15, 2022, the Committee shall submit to the House Committee on
11	Corrections and Institutions and the Senate Committee on Institutions
12	recommendations for legislative action, if any, to clarify these roles and
13	responsibilities.

16	§ 62. LEGISLATIVE DUTIES
17	(a) The Sergeant at Arms shall:
18	(1) execute orders of either house, the Joint Legislative Management
19	Committee, the Committee on Joint Rules, or the House or Senate Committee
20	on Rules;

1	(2) maintain order among spectators and take measures to prevent
2	interruption of either house or any committee thereof;
3	(3) arrange for special meetings and conferences at the State House;
4	(4) provide for the distribution of mail to all legislators;
5	(5) schedule the time for the use of rooms for committee meetings and
6	hearings;
7	(6) maintain the State House and its furnishings in a good state of repair
8	and provide security for all furniture, draperies, rugs, desks, and other
9	furnishings kept in the State House in consultation with the State Curator;
10	(7) provide for the establishment of a cafeteria and supervise its
11	operation;
12	(8) provide security for the State House, pursuant to the responsibilities
13	set forth in 29 V.S.A. § 171; and
14	(9) perform such other duties for the benefit of the legislators as may be

16	(b) He or she or any person in his or her employ shall not accept any
17	compensation or gift for his or her services other than his or her salary. If he

11	(a) Creation. The position of State Curator is created within the
12	Department of Buildings and General Services.
13	(b) Duties. The State Curator's responsibilities shall include:
14	(1) oversight of the general historic preservation of the State House,
15	including maintaining the historical integrity of the State House and works of
16	art in the State House;
17	(2) interpretation of the State House to the visiting public through
18	exhibits, publications, and tours, and other means of communication; and
19	(3) acquisition, management, and care of State collections of art and,
20	historic artifacts, and furnishings, provided that any works of art all items
21	obtained for the State House are acquired pursuant to the requirements of

11	diverse people and history, including a diversity of race, ethnicity, sex, gender
12	identity, sexual orientation, and disability status, and a diversity of artistic
13	media and artists, and celebrates the natural history of the State, and the
14	diversity of the people and stories of Vermont throughout the history of the
15	State. <u>Upon approval of the Legislative Advisory Committee on the State</u>
16	House pursuant to 2 V.S.A. § 653, the State Curator shall adopt the collections
17	policy.
18	(d) Interpretive plan. In coordination with the Friends of the Vermont State
19	House and the Vermont Historical Society, the State Curator shall create an
20	interpretive plan that tells the stories of the State House art collection through

1	accessible written, multimedia, and oral means. The plan shall include
2	appropriate and inclusive training of State House volunteers and staff.

5	This act shall take effect on passage, except that all legislator members
6	serving on the Legislative Advisory Committee on the State House as of the
7	date of enactment of this act shall remain on the Committee through the end of
