11	§ 651. LEGISLATIVE ADVISORY COMMITTEE ON THE STATE
12	HOUSE
13	(a) The Legislative Advisory Committee on the State House is created.
14	(b) The Committee shall be composed of $\frac{13}{12}$ members:
15	(1) four three members of the House of Representatives, appointed
16	biennially by the Speaker of the House;
17	(2) four three members of the Senate, appointed biennially by the
18	Committee on Committees;
19	(3) the Chair of the Board of Trustees of the Friends of the Vermont
20	State House;
21	(4) the Director of the Vermont Historical Society;

1	(5) the Director of the Vermont Council on the Arts Council;
2	(6) the Commissioner of Buildings and General Services or designee;
3	and
4	(7) the Sergeant at Arms <u>; and</u>
5	(8) the State Curator.
6	(c) The Committee shall biennially elect a chair from among its legislative
7	members. A quorum shall consist of seven members.
8	(d) The Committee shall meet at the State House at least one time when the
9	General Assembly is in session and at least one time when. When the General
10	Assembly is not in session or at the call of the Chair, the Committee shall meet
11	at least one time, but the Committee and any subcommittees shall not
12	cumulatively meet more than six times per year; provided, however, that the
13	Committee and any subcommittees of the Committee may meet more often
14	with the approval of the Speaker of the House and the President Pro Tempore
15	of the Senate. The Commissioner of Buildings and General Services shall
16	keep minutes of the meetings and maintain a file thereof.
17	(e) The Committee shall have the assistance of the Office of Legislative
18	Counsel and the Office of Legislative Operations.
19	(f) A member of the Committee shall not vote on a matter under
20	consideration by the Committee regarding any activities or duties the member
21	is responsible for discharging.

2	For meetings held during adjournment of the General Assembly, the
3	legislative members of the Committee shall be entitled to per diem
4	compensation and expense reimbursement as provided in subsection 406(a)

7	(a)(1) The Legislative Advisory Committee on the State House shall be
8	consulted on:
9	(1) review, coordinate, and make recommendations on all activities

11	artifacts, and furnishings, and the refurbishing, renovation, preservation, and
12	expansion of the building and its interior-; and
13	(2) The Legislative Advisory Committee on the State House shall

16	diverse people and history, including diversity of gender, race, ethnicity,

19	(b) The Sergeant at Arms and the Commissioner of Buildings and General
20	Services, in discharging responsibilities under subdivision 62(a)(6) of this title
21	and 29 V.S.A. §§ 154(a) and 154a, respectively, shall consider the

1	recommendations of the Committee. The Committee's recommendations shall
2	be advisory only.
3	Sec. 2. LEGISLATIVE ADVISORY COMMITTEE ON THE STATE
4	HOUSE; ROLES AND RESPONSIBILITIES; STUDY
5	The Legislative Advisory Committee on the State House shall review the
6	roles and responsibilities of the State Curator, the Sergeant at Arms, and the
7	Friends of the Vermont State House. On or before December 15, 2022, the
8	Committee shall submit to the House Committee on Corrections and
9	Institutions and the Senate Committee on Institutions recommendations for
10	legislative action, if any, to clarify these roles and responsibilities.

13	§ 62. LEGISLATIVE DUTIES
14	(a) The Sergeant at Arms shall:
15	(1) execute orders of either house, the Joint Legislative Management
16	Committee, the Committee on Joint Rules, or the House or Senate Committee
17	on Rules;
18	(2) maintain order among spectators and take measures to prevent
19	interruption of either house or any committee thereof;
20	(3) arrange for special meetings and conferences at the State House;
21	(4) provide for the distribution of mail to all legislators;

1	(5) schedule the time for the use of rooms for committee meetings and
2	hearings;
3	(6) maintain the State House and its furnishings in a good state of repair
4	and provide security for all furniture, draperies, rugs, desks, and other
5	furnishings kept in the State House in consultation with the State Curator;
6	(7) provide for the establishment of a cafeteria and supervise its
7	operation;
8	(8) provide security for the State House, pursuant to the responsibilities
9	set forth in 29 V.S.A. § 171; and

8	(a) Creation. The position of State Curator is created within the

12	including maintaining the historical integrity of the State House and works of
13	art in the State House;
14	(2) interpretation of the State House to the visiting public through
15	exhibits, publications, and tours, and other means of communication; and

17	historic artifacts, and furnishings, provided that any works of art all items

7	ensures that the acquisition of art, historic artifacts, and furnishings, and the
8	commissioning of art and furnishings, for the State House reflects Vermont's
9	diverse people and history, including a diversity of race, ethnicity, sex, gender
10	identity, sexual orientation, and disability status, and a diversity of artistic
11	media and artists, and celebrates the natural history of the State, and the
12	diversity of the people and stories of Vermont throughout the history of the
13	State. Upon approval of the Legislative Advisory Committee on the State
14	House pursuant to 2 V.S.A. § 653, the State Curator shall adopt the collections
15	policy.
16	(d) Interpretive plan. In coordination with the Friends of the Vermont State
17	House and the Vermont Historical Society, the State Curator shall create an
18	interpretive plan that tells the stories of the State House art collection through
19	accessible written, multimedia, and oral means. The plan shall include
20	appropriate and inclusive training of State House volunteers and staff.
