RE:	Report on Capital Fund Balances

In accordance with 32 VSA §701a (c)and(d), the Department of Forests, Parks and Recreation (FPR) is reporting on the current capital fund balances authorized two or more years prior to the current legislative session.

FPR remains well positioned and committed to deploying capital appropriations efficiently and quickly with a mix of small to large scale projects which will continue to employ many contractors around the state as we improve and rehabilitate our recreational infrastructure. It remains our goal to encumber or complete spending within two fiscal years of receiving the appropriation. Below please find the expended status as of January 14, 2022, in the State's VISION financial accounting software.

2017 6130991701 State Parks Infrastructure Rehabilitation

The \$15,168 encumbered amount is committed to contractors through purchase orders detailed in the purchase order section below.

2018 6130991801 State Parks Infrastructure Rehabilitation

The \$1,810 encumbered amount is committed to a contractor detailed in the purchase order section below.

2019 6130991901 State Parks Infrastructure Rehabilitation

The \$33,639 encumbered amount is committed to contractors through purchase orders detailed in the purchase order section below.

2019 6130991902 Rustic Cabin Construction

This appropriation is targeted toward rustic cabin construction by Vermont career technical education programs. The COVID pandemic continues to affect this program and cause delays. The cabins are currently being redesigned to provide a structure that students can build using contemporary construction techniques and materials. The original design was deemed unsuitable for teaching contemporary construction skills.

Thus far the collaboration with the Stafford Technical Center in Rutland has been very successful. The Stafford program is designed so that students start work at the source by milling logs provided by FPR into the lumber that will be used to build the cabin structures. While the milling process is adding time and complexity, it is also providing the broad learning opportunity and skills training which inspired this funding. With a more contemporary design and a routine school schedule FPR is confident in the ability to engage additional centers to construct cabins on additional sites.

2019 6130991903 - Forestry Skidder Bridges

The \$3,600 encumbered amount is committed as detailed in the purchase order section below. The remaining \$23,561 reported as unspent balance above has been paid to contractors and will





be reported as spent in VISION when allocating accounting entries are made this month to charge costs to the capital fund.

2020 6130992001 - State Parks Infrastructure Rehabilitation

The \$71,232 encumbered amount is committed to contractors through purchase orders detailed in the purchase order section below.

2020 6130992002 - FPR State Owned Forests

This project work involves identifying projects based on a prioritized list of road and trail Best Management Practices to reduce nutrient and sediment pollution. To support identifying the highest priority projects and quantify phosphorus reduction, FPR collaborated with DEC to develop a Road Erosion Inventory. The development of the methodology and supporting technology took longer than expected. The tool is now complete, \$1.2M of capital funds are committed to projects and staff are currently developing additional projects for implementation this coming field season.
