2 Date: 3 Subject: Education; school construction; funding 4 Statement of purpose of bill as introduced: This bill proposes to: (1) require 5 the Secretary of Education to update school facilities standards, (2) require the 6 State Board of Education to update and adopt the Capital Outlay Formula in 7 State Board Rule 6124.1, (3) direct the Secretary of Education to hire an 8 independent third party to conduct a school facilities conditions analysis, 9 (4) direct the Secretary of Education to submit a report on funding school 10 construction projects, (5) require school districts and supervisory unions to 11 designate a person responsible for facilities management, and (6) require 12 school districts to develop and maintain a capital improvement plan. 13 An act relating to addressing the needs and conditions of school facilities in 14 the State 15 It is hereby enacted by the General Assembly of the State of Vermont: 16 Sec. 1. FINDINGS; INTENT 17 (a) The General Assembly finds that: 18 (1) In 2007 Acts and Resolves No. 52, Sec. 36, the General Assembly 19 suspended State aid for school construction in order to permit the Secretary of

Education and the Commissioner of Finance and Management to recommend a
sustainable plan for State aid for school construction.
(2) In 2008 Acts and Resolves No. 200, Sec. 45, as amended by 2009
Acts and Resolves No. 54, Sec. 22, the General Assembly, in the absence of a
recommendation, extended the suspension until a sustainable plan for State aid
for school construction is developed and adopted.
(3) The State honored its obligation in Fiscal Year 2016 to pay for
projects for which State aid had been committed prior to the suspension.
(b) The General Assembly also finds that:
(1) The State of Vermont is the only state in the Northeast that does not
have a school construction program.
(2) Between 2008 and 2019, school districts in Vermont issued
approximately \$211,000,000.00 in bonds for school construction projects. In
2020, there was an estimated \$445,000,000.00 in bonding planned and
proposed by school districts for future school construction projects statewide.
(c) The General Assembly also finds that the backlog in the State's school
construction projects has resulted in unsafe and unhealthy learning
environments and disparities in the quality of education between wealthier
communities and communities in need across the State.
(d) It is the intent of the General Assembly to develop a plan to address the
needs and conditions of the State's school buildings in order to create better

3	Sec. 2. SCHOOL CONSTRUCTION; FACILITIES STANDARDS;
4	CAPITAL OUTLAY FINANCING FORMULA; AGENCY OF
5	EDUCATION; STATE BOARD OF EDUCATION; UPDATE
6	(a) On or before December 1, 2022, the Secretary of Education, in
7	consultation with the Executive Director of the Vermont Superintendents
8	Association, the Chair of the State Board of Education, and the Commissioner
9	of Buildings and General Services, shall update the school construction
10	facilities standards. The update shall reflect:
11	(1) changes in educational delivery models; and
12	(2) requirements for healthy and resource efficient school facilities,
13	including natural light, fresh air ventilation, and water and energy efficiency.
14	(b) On or before December 1, 2022, the State Board of Education shall
15	update and adopt the Capital Outlay Financing Formula.
16	(1) Pursuant to State Board Rule 6124.1, the Formula shall establish the
17	maximum and minimum square footage parameters by school size and the
18	grade range through a square footage allowance per student or program. The
19	Formula shall also establish an allowable cost per square foot of construction.

1	(2) The State Board may also consider additional factors in the update,
2	including facility condition, capacity and utilization, and energy performance
3	in designing a system of financial support.
4	(c) The State Board is authorized to use not more than \$100,000.00 of the
5	amount appropriated in Sec. 3(d) of this act to hire a consultant to provide
6	technical assistance for the project described in subsection (b) of this section.
7	Sec. 3. SCHOOL FACILITIES CONDITIONS ANALYSIS; AGENCY OF
8	EDUCATION; DEPARTMENT OF BUILDINGS AND GENERAL
9	SERVICES
10	(a) On or before September 1, 2021, the Secretary of Education, in
11	coordination with the Commissioner of Buildings and General Services, shall
12	issue a request for proposal for a school facilities conditions analysis to inform
13	the Agency of Education of the statewide school facilities needs and costs.
14	The analysis shall include:
15	(1) A planning phase that finalizes the evaluation criteria and
16	methodology.
17	(2) A review of school facility conditions, space utilization, and
18	suitability of the facility and its spaces to deliver educational and support
19	services.

1	(3) Sufficient information to assist the General Assembly to establish a
2	ranking system based on categories to prioritize schools with the highest needs
3	for future school construction funding. The categories shall include:
4	(A) capacity and utilization:
5	(B) safety and security infrastructure;
6	(C) technology infrastructure;
7	(D) capacity to deliver STEAM programming; and
8	(E) building systems condition and performance, including energy
9	efficiency improvements.
10	(b) The Secretary of Education shall contract with an independent third
11	party to conduct the analysis described in subsection (a) of this section. The
12	analysis shall be completed on or before July 1, 2022.
13	(c) The Agency of Education shall create a database to enter the
14	information from the analysis described in subsection (a) of this section. This
15	information shall include a school's physical address and GIS coordinates.
16	(d) The Secretary is authorized to use not more than \$2,500,000.00 of the
17	amount allocated to the Agency of Education from the Elementary and
18	Secondary School Emergency Relief Fund pursuant to Sec. 313 from the
19	Consolidated Appropriations Act, 2021, Pub. L. No. 116-260.

1	(e) On or before January 15, 2022, the Secretary of Education shall submit
2	a report to the House and Senate Committees on Education with an update on
3	the status of the request for proposal described in subsection (a) of this section.
4	(f) As used in this section, "school" means a public school, as defined in
5	<u>16 V.S.A. § 11.</u>
6	Sec. 4. SCHOOL CONSTRUCTION FUNDING; AGENCY OF
7	EDUCATION; REPORT
8	(a) On or before December 15, 2022, the Secretary of Education shall
9	submit a report to the General Assembly that shall include the following:
10	(1) an analysis of the challenges and opportunities to the State of
11	funding school construction projects;
12	(2) recommendations for a funding source for school construction
13	projects that are linked to the inventory, needs, and conditions of all Vermont
14	schools; and
15	(3) an analysis of how other states are funding school construction
16	projects.
17	(b) As used in this section, "school" means a public school, as defined in
