



VLCT IT Services RFQ Template Project Overview

The Vermont League of Cities and Towns (VLCT) collaborated with the Leahy Center for Digital Forensic & Cybersecurity (Leahy Center) to create a template IT Services Request for Quotes (RFQ) for small Vermont municipalities. The Leahy Center is a Center of Experience at Champlain College with an educational mission to provide real world experience for students.

To inform the template and make it broadly applicable to small and mid-sized municipalities, the Leahy Center conducted IT assessments for ten municipalities representative of IT infrastructure and service. Participants received a written report and review with Leahy Center staff.

On March 17, Leahy Center staff and students presented the VLCT Board of Directors with project outcomes including:

- IT Services RFQ Template
- IT Services RFQ Template Options Catalog
- Sample Completed RFQ
- Findings and Recommendations Summary

- Human Resources consultation, and many more.





2021 Cyber Insurance Market Constricts

- More difficult and expensive to secure cybersecurity coverage for our members
- VLCT relies on cybersecurity experts - including reinsurers to manage cybersecurity claims
- PACIF issued a Cyber Risk
 Assessment survey to VLCT
 members in 2021 anticipating
 insurance would only be
 offered to members who met
 strict underwriting criteria



According to the 2021 PACIF Cyber Risk Assessment Survey:



VLCT / PACIF Offerings and Resources:

- Offering PACIF members a full reimbursement if they purchase security awareness training and simulated phishing platform from KnowBe4 through May 17, 2022
- VLCT will soon be publishing a model RFQ for IT services and accompanying RFQ instructions as part of the Champlain contract
- Issue articles, online resources, trainings and alerts to members about cybersecurity



- Awaiting DHS/ADS guidance on Bipartisan Infrastructure Law "State and Local Cybersecurity Improvement Act" Grant Program
- Champlain College has named VLCT a partner in a \$756,000 earmark Senator Leahy secured to help nonprofits, municipalities and school districts address cybersecurity
