7	Sec. 1. FINDINGS	
8	The General Assembly finds that:	
9	(1) There is currently no master list of residential construction	
10	contractors operating in the State.	
11	(2) There is no standard process for determining or adjudicating	
12	construction contract fraud complaints either on the part of contractors or	
13	consumers.	
14	(3) Public authorities have no mechanism to contact all contractors	
15	when necessary to provide updates to public health requirements, safe working	
16	protocols, codes and standards, and available trainings and certifications.	
17	(4) Wide dissemination of information on codes, standards, and	
18	trainings is vital to improving construction techniques throughout the State's	
19	construction industry. Since building thermal conditioning represents over	
20	one-quarter of the State's greenhouse gas emissions, improving energy	

1	performance is a key strategy for meeting the requirements of the Global	
2	Warming Solutions Act, 2020 Acts and Resolves No. 153.	
3	(5) While registration is not licensure and confers no assurance of	
4	competence, consumers have no way of knowing whether a contractor is	
5	operating legally or has been subject to civil claims or disciplinary actions.	
6	(6) A noncommercial, standardized public listing will provide	
7	contractors an opportunity to include in their record optional third-party, State-	
8	sanctioned certifications.

11	The Office of Professional Regulation is created within the Office of the

19	CHAPTER 107. RESIDENTIAL CONTRACTORS	
20	Subchapter 1. General Provisions	
21	§ 5501. REGISTRATION REQUIRED	

1	(a) A person shall register with the Office of Professional Regulation prior	
2	to contracting with a homeowner to perform residential construction in	
3	exchange for consideration of more than \$2,500.00, including labor and	
4	materials.	
5	(b) Unless otherwise exempt under section 5502 of this title, as used in this	
6	chapter, "residential construction" means to build, demolish, or alter a	
7	residential dwelling unit, or a building or premises with four or fewer	
8	residential dwelling units, in this State, and includes interior and exterior	
9	construction, renovation, and repair; painting; paving; roofing; weatherization;	
10	installation or repair of heating, plumbing, electrical, water, or wastewater	
11	systems; and other activities the Office specifies by rule consistent with this	
12	chapter.	
13	§ 5502. EXEMPTIONS	
14	This chapter does not apply to:	
15	(1) an employee acting within the scope of his or her employment for a	
16	business organization registered under this chapter;

12	(2) The provisions of 3 V.S.A. § 129a, with respect to a registration,

15	(b) The system of voluntary certification established in this chapter is

10	§ 5505. DUTIES OF THE DIRECTOR	
11	(a) The Director of Professional Regulation shall:	
12	(1) provide information to the public concerning registration,	
13	certification, appeal procedures, and complaint procedures;	
14	(2) administer fees established under this chapter;	
15	(3) receive applications for registration or certification, issue	
16	registrations and certifications to applicants qualified under this chapter, deny	
17	or renew registrations or certifications, and issue, revoke, suspend, condition,	
18	and reinstate registrations and certifications as ordered by an administrative	
19	law officer; and	
20	(4) prepare and maintain a registry of registrants and certificants.	

1	(b) The Director, after consultation with an advisor appointed pursuant to

2	§ 5508. ELIGIBILITY
3	To be eligible for registration, the Director of Professional Regulation shall

6	provision of professional services to a homeowner.
7	§ 5509. REQUIREMENTS OF REGISTRANTS
8	(a) Insurance. A person registered under this chapter shall maintain
9	minimum liability insurance coverage in the amount of \$300,000.00 per claim
10	and \$1,000,000.00 aggregate, evidence of which may be required as a
11	precondition to issuance or renewal of a registration.
12	(b) Writing.
13	(1) A person registered under this chapter shall execute a written
14	contract prior to receiving a deposit or commencing residential construction
15	work if the estimated value of the labor and materials exceeds \$2,500.00.
16	(2) A contract shall specify:
17	(A) Price. One of the following provisions for the price of the
18	contract:
19	(i) a maximum price for all work and materials;
20	(ii) a statement that billing and payment will be made on a time
21	and materials basis, not to exceed a maximum price; or

1	(iii) a statement that billing and payment will be made on a time			
2	and materials basis and that there is no maximum price.			
3	(B) Work dates. Estimated start and completion dates.			
4	(C) Scope of work. A description of the services to be performed and			
5	a description of the materials to be used.			
6	(D) Change order provision. A description of how and when			
7	amendments to the contract may be approved and recorded.			
8	(3) The parties shall record an amendment to the contract in a signed			
9	writing.			
10	(c) Down payment. Unless a contract specifies that billing and payment			
11	will be made on a time and materials basis and that there is no maximum price,			
12	the contract may require a down payment of up to one-half of the contract			
13	price, or of the price of materials, whichever is greater.			
14	§ 5510. PROHIBITIONS AND REMEDIES			
15	(a) A person who does not register pursuant to this chapter when required			
16	engages in unauthorized practice pursuant to 3 V.S.A. § 127.			
17	(b) The Office of Professional Regulation may discipline a registrant or			
18	certificant for unprofessional conduct as provided in 3 V.S.A. § 129a, except			
19	that 3 V.S.A. § 129a(b) does not apply to a registrant.			
20	(c) The following conduct by a registrant, certificant, applicant, or person			
21	who later becomes an applicant constitutes unprofessional conduct:			

1	(1) failure to enter into a written contract when required by this chapter;	
2	(2) failure to maintain liability or workers' compensation insurance as	
3	required by law;	
4	(3) committing a deceptive act in commerce in violation of 9 V.S.A.	
5	<u>§ 2453;</u>	
6	(4) falsely claiming certification under this chapter, provided that this	
7	subdivision does not prevent accurate and nonmisleading advertising or	
8	statements related to credentials that are not offered by this State; and	
9	(5) selling or fraudulently obtaining or furnishing a certificate of	
10	registration, certification, license, or any other related document or record, or	
11	assisting another person in doing so, including by reincorporating or altering a	
12	trade name for the purpose or with the effect of evading or masking revocation.	
13	suspension, or discipline against a registration issued under this chapter.	
14	Sec. 4. IMPLEMENTATION	
15	(a) Notwithstanding any contrary provision of 26 V.S.A. chapter 107:	
16	(1) The initial biennial registration term for residential contractors	
17	pursuant to 26 V.S.A. chapter 107 shall begin on April 1, 2022.	
18	(2) The Secretary of State may begin receiving applications for the	
19	initial registration term on December 1, 2021.	

1	(3)(A) The registration fee for individuals who submit complete
2	registration requests between December 1, 2021 and March 31, 2022 is \$25.00
3	and between April 1, 2022 and March 31, 2023, the fee is \$50.00.
4	(B) The registration fee for business organizations that submit
5	complete registration requests between December 1, 2021 and March 31, 2022
6	is \$175.00 and between April 1, 2022 and March 31, 2023, the fee is \$200.00.
7	(4) Prior to April 1, 2023, the Office of Professional Regulation shall
8	not take any enforcement action for unauthorized practice under 26 V.S.A.
9	§ 5510(a) against a residential contractor who fails to register as required by
10	this act.
11	(b) On or before July 1, 2022, the Director of Professional Regulation shall
12	establish an initial set of voluntary certifications, to include at minimum
13	OSHA standards on construction projects and components of energy-efficient
14	"green" building for insulators, carpenters, and heating and ventilation
15	installers.
16	Sec. 5. CREATION OF POSITIONS WITHIN THE OFFICE OF
17	PROFESSIONAL REGULATION; LICENSING.
18	(a) There are created within the Secretary of State's Office of Professional
19	Regulation one new position in licensing and one position in enforcement.
20	(b) Any funding necessary to support the positions created in subsection (a)
21	of this section and the implementation of 26 V.S.A. chapter 107 created in

1	Sec. 2 of this act shall be derived from the Office's Professional Regulatory
2	Fee Fund and not from the General Fund.
3	Sec. 6. SECRETARY OF STATE; STATUS REPORT
4	On or before January 15, 2023, the Office of Professional Regulation shall
5	report to the House Committee on General, Housing and Military Affairs and
6	on Government Operations and to the Senate Committees on Economic
7	Development, Housing and General Affairs and on Government Operations
8	concerning the implementation of 26 V.S.A. chapter 107, including:
9	(1) the number of registrations and certifications;
10	(2) the resources necessary to implement the chapter;
11	(3) the number and nature of any complaints or enforcement actions;
12	<u>and</u>
13	(4) any other issues the Office deems appropriate.
14	Sec. 7. EFFECTIVE DATE
15	This act shall take effect on July 1, 2021.
