MEMORANDUM FOR RECORD

SUBJECT: Sexual Assault Awareness and Prevention Month (SAAPM)

1. April is when both civilian and military communities observe Sexual Assault Awareness and Prevention Month (SAAPM). This month offers us the opportunity to continue promoting awareness and look for ways to improve outreach and support to victims while also expanding efforts on prevention. All of our members, regardless of rank, duty position, or job specialty, must work to prevent sexual assault, sexual harassment and reprisal against those who report these events. We cannot tolerate it in our formations and we must support our survivors to the best of our ability.
2. Statistics show that sexual assault remains one of the most underreported crimes. While there are many reasons for this, the Vermont National Guard is committed to believing survivors and providing every resource and tool available to reduce the stigma for those who come forward to report. Reporting a sexual assault shows a member of our team trusts the National Guard to hold those who commit sexual assault crimes accountable. When survivors come forward to report these crimes, it may prevent the offenders from harming anyone else and help to decrease the prevalence rate of sexual assaults within our organization. Don't let perpetrators get away with it.
3. Our efforts to combat sexual assaults are effective. According to the Unit Risk Inventories and the Unit Climate Assessments, the Vermont National Guard showed a decrease in negative command climates and an increase in awareness of reporting options and trust in command. Preventing sexual assault, sexual harassment, and retaliation is one of our top priorities, but we still have much work to do. We are holding our leaders accountable and will provide the best training available to ensure they know the most effective ways to prevent, respond, and report sexual assaults.
4. Support your Vermont National Guard SAPR/SHARP team and get involved in this month's Sexual Assault Awareness and Prevention Month activities in person and on social media. Together, we can work to further reduce, with the goal to eliminate, sexual assault from the Vermont National Guard. Our military is one of the most trusted

institutions in America. Committing, or tolerating sexual harassment and sexual assault violates that trust. These aberrant actions must not threaten those who have volunteered to serve – they deserve better.
