6 First: By striking out Secs. 136 through 145 in their entirety and inserting
7 in lieu thereof the following:

18 Second: In Sec. 146, 20 V.S.A. § 1543, by striking out subdivision (2) in its
19 entirety and inserting in lieu thereof a new subdivision (2) to read as follows:

1 (2) ~~the spouses of such~~ service-connected disabled ~~ex-servicemen or~~
2 ~~women as~~ ex-service personnel who have themselves been unable to qualify
3 for any civil service appointment by reason of their disability;

4 Third: By striking out Sec. 177, 20 V.S.A. § 2861, in its entirety and
5 inserting in lieu thereof a new Sec. 177 to read as follows:

6 § 2861. GENERALLY

7 When it may seem to be for the public good, the ~~fire marshal~~ Fire Marshal
8 shall personally visit and investigate any fire in accordance with the provisions
9 of this chapter and ~~he~~ shall be repaid ~~all~~ for any related expenses ~~incident~~
10 ~~thereto~~ out of the funds ~~provided for in section 2687 of this title~~ appropriated
11 to the Division of Fire Safety.

12 Fourth: In Sec. 193, 20 V.S.A. § 3349, by striking out subsection (b) in its
13 entirety and inserting in lieu thereof a new subsection (b) to read as follows:

14 (b) A person who owns or keeps a stallion over one year of age, between
15 April 1 and December 1, in a private enclosure in ~~such~~ a manner ~~as to disturb~~
16 ~~and annoy~~ that disturbs and annoys the owner or occupant of adjoining
17 premises shall be fined \$5.00 for each week ~~he so keeps such~~ that the owner or
18 keeper keeps stallion after ~~he~~ the owner or keeper has received three days'
19 notice from an adjoining owner or occupant to remove ~~such~~ the stallion.
