7 The General Assembly approves the amendments to the charter of the City  
8 of Barre as set forth in this act. The voters approved the proposals of  
9 amendment on March 2, 2021 and March 1, 2022.

13 § 104. GENERAL CORPORATE POWERS

15 (b) The City may purchase real property, or interest in real property, within  
16 or without its corporate limits, for the public benefit. The City may acquire  
17 real property by gift, devise, lease, easement, or condemnation and may sell,  
18 lease, mortgage, hold, convey by easement, manage and control such property  
19 as its interest may require. Any acquisition or conveyance of property through  
20 the means listed in this section shall require approval of the council and shall

1 also be subject to notice as required by 24 V.S.A. § 1061 or any successor  
2 provision.

4 § 105. ORDINANCES - SUBJECT MATTER

5 The general grant of ordinance promulgating authority in section 104 of this  
6 charter shall include the authority:

8 (g) ~~To adopt and enforce ordinances relating to the mediation of landlord~~  
9 ~~tenant issues by the Housing Board of Review~~ Notwithstanding any contrary  
10 provision of general law, to adopt and enforce ordinances establishing a speed  
11 limit of less than 25 miles per hour on specified City streets, or sections  
12 thereof, within City boundaries as may be required for the safety and general  
13 welfare of the City.

15 § 111. BONDING OF CITY OFFICIALS

16 The Mayor, councilors, members of the Police Department, City Manager,  
17 ~~First Constable~~ Finance Director, Superintendent of Public Works, Tax  
18 Collector, and Clerk and Treasurer shall annually be bonded by the City for the  
19 faithful discharge of their respective duties, as provided by State statute, and  
20 the expense of said bonds to be paid by the City.

1 § 205. OFFICERS ELECTED

2 (a)(1) The legal voters shall elect biennially a Mayor, ~~a First Constable~~, and  
3 one person to serve as Clerk and Treasurer.

5 § 307. POWERS OF CITY; POLICY MATTERS; APPOINTMENT OF  
6 CERTAIN OFFICERS

7 All powers of the City and the determination of all matters of policy shall  
8 be vested in the City Council except as otherwise provided by this charter or  
9 by general law. The City Council shall annually appoint a City Attorney, a  
10 ~~City Grand Juror~~, a Library Liaison, and may provide for any Planning Board,  
11 Zoning Board of Adjustment, Recreation Board, or Personnel Board, and may  
12 create commissions or other bodies with advisory powers and may appoint  
13 personnel to serve on said boards or commissions.

17 § 407. APPOINTMENTS

19 (b) There shall be appointed by the City Manager after the annual City  
20 election in the manner as hereinafter provided a Superintendent of Streets, a  
21 Superintendent of Waterworks, a Recreation Director, a City Engineer, a

1 Building Inspector, an Inspector of Electric Wiring, ~~an Inspector of Plumbing,~~  
2 a Tree Warden, and three members of the Board of Health (see section 512 of  
3 this charter, Board of Health). All officers shall hold their offices respectively  
4 for one year or until their successors shall be appointed and qualified. The  
5 City Manager may also appoint such other subordinate officers as may be  
6 elected or appointed in towns. Members of the various boards shall be  
7 appointed in the same manner, who shall hold office as otherwise herein  
8 provided or until their successor shall be appointed and qualified.

10 § 409. CAPITAL IMPROVEMENT PLAN

11 (a) Preparation and submission. The Manager, after consultation with  
12 department heads, shall submit a proposed five-year capital improvement plan  
13 to the council at least three months prior to the annual meeting.

14 (b) Contents. The capital expenditure plan shall include:

15 (1) a clear narrative summary of needs;

16 (2) a list of all capital expenditures to be proposed for the next five years  
17 with appropriate supporting data;

18 (3) actual cost estimates, proposed methods of financing, and necessary  
19 time schedules for each improvement; and

20 (4) estimated annual cost of operating and maintaining the facilities to  
21 be constructed or acquired.



1 § 605. LOCAL SALES, ROOMS, MEALS, AND ALCOHOLIC  
2 BEVERAGES OPTION TAXES

3 Local option taxes are authorized under this section for the purpose of  
4 affording the City an alternative method of raising municipal revenues.

5 Accordingly:

6 (1) The City Council may assess sales, rooms, meals, and alcohol taxes  
7 of one percent.

9 (3) Revenues received through a tax imposed under this section shall be  
10 designated solely for street and sidewalk reconstruction, capital equipment, and  
11 capital improvement needs under section 406a of this charter.
