15	deputy sheriff paid by the State pursuant to 24 V.S.A. § 290(b), including
16	permanent part-time employees, an individual whose work has ceased as a
17	consequence of, or in connection with, any current labor dispute or because of
18	any unfair labor practice, but excluding an individual:
19	(A) exempt or excluded from the State classified service under the
20	provisions of section 311 of this title, except that the State Police in the
21	Department of Public Safety; employees of the Defender General, excluding

10	designee, the Office of the Defender General represented by the Defender
11	General or designee, Vermont State Colleges represented by the Chancellor or
12	designee, and the University of Vermont represented by the President or
13	designee.
14	(B) With respect to employees of State's Attorneys' offices and full-
