

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Health Care to which was referred House Bill No. 279
3 entitled “An act relating to miscellaneous changes affecting the duties of the
4 Department of Vermont Health Access” respectfully reports that it has
5 considered the same and recommends that the bill be amended by striking out
6 all after the enacting clause and inserting in lieu thereof the following:

7 Sec. 1. 33 V.S.A. § 1992 is amended to read:

8 § 1992. MEDICAID COVERAGE FOR ADULT DENTAL SERVICES

9 (a) Vermont Medicaid shall provide coverage for medically necessary
10 dental services provided by a dentist, dental therapist, or dental hygienist
11 working within the scope of the provider’s license as follows:

12 (1) ~~Up to two visits per calendar year for preventive~~ Preventive services,
13 including prophylaxis and fluoride treatment, with no co-payment. These
14 services shall not be counted toward the annual maximum benefit amount set
15 forth in subdivision (2) of this subsection.

19 (a) ~~In connection with the Pharmacy Best Practices and Cost Control~~
20 ~~Program, the Commissioner of Vermont Health Access shall report for review~~
21 ~~by the House Committees on Appropriations, on Health Care, and on Human~~

1 ~~Services and the Senate Committees on Appropriations and on Health and~~
2 ~~Welfare prior to any modifications:~~

3 ~~(1) the compilation that constitutes the preferred drug list or list of drugs~~

19 ~~(e) The Notwithstanding the provisions of 2 V.S.A. § 20(d), the~~

21 ~~October 30 to the House Committees on Appropriations, on Health Care, and~~

1 on Human Services and the Senate Committees on Appropriations and on
2 Health and Welfare concerning the Pharmacy Best Practices and Cost Control
3 Program and the operation of Vermont’s pharmaceutical assistance programs

13 in relation to both drug utilization review efforts and the placement of drugs on
14 the Department’s preferred drug list.

2 benefit manager who has entered into an agreement or engaged in a practice

5 Vermont and does not adversely affect the medical interests of Vermont
6 beneficiaries.

9 ~~(a)~~ The Agency of Human Services shall adopt rules necessary to
10 implement and administer the provisions of this subchapter, including
11 standards and schedules establishing coverage and exclusion of
12 pharmaceuticals and maximum quantities of pharmaceuticals to be dispensed,
13 and to comply with the requirements of the Medicare Modernization Act. ~~The~~
14 ~~Agency of Human Services shall submit the proposed rule to the Health Care~~
15 ~~Oversight Committee. The Health Care Oversight Committee shall review and~~
16 ~~advise on the Agency rules and policies developed under this subsection and~~

1 Sec. 4. SEPARATE INDIVIDUAL AND SMALL GROUP HEALTH
2 INSURANCE MARKETS FOR PLAN YEAR 2023 IF FEDERAL
3 SUBSIDIES EXTENDED

4 (a) Purpose. The purpose of this section is to allow for separate individual
5 and small group health insurance markets for plan year 2023 in the event that
6 Congress extends increased opportunities for federal advanced premium tax
7 credits to include plan year 2023 and that extension is enacted on or before
8 September 1, 2022.

9 (b) Definitions. As used in this section, “health benefit plan,” “registered
10 carrier,” and “small employer” have the same meanings as in 33 V.S.A.
11 § 1811.

12 (c) Separate plans and community rating. Notwithstanding any provision
13 of 33 V.S.A. § 1811 to the contrary, if the Department of Vermont Health
14 Access, after consultation with interested stakeholders, determines on or before
15 September 1, 2022 that Congress has extended the increased opportunities for
16 federal premium assistance originally made available through the American
17 Rescue Plan Act of 2021, Pub. L. No. 117-2 to eligible households purchasing
18 qualified health benefit plans in the individual market to include plan year
19 2023, or has made substantially similar opportunities available, then for plan
20 year 2023, a registered carrier shall:

1 (1) offer separate health benefit plans to individuals and families in the
2 individual market and to small employers in the small group market;

3 (2) apply community rating in accordance with 33 V.S.A. § 1811(f) to
4 determine the premiums for the carrier’s plan year 2023 individual market
5 plans separately from the premiums for its small group market plans; and

6 (3) file premium rates with the Green Mountain Care Board pursuant to
7 8 V.S.A. § 4062 separately for the carrier’s individual market and small group
8 market plans.
