Section 1. Statutory Charge

Section 6 of Act 136 of 2020 requires the Agency of Human Services (AHS) to submit a report to the General Assembly concerning the implementation of the Front-Line Employees Hazard Pay Grant Program (Hazard Pay Grant Program or Program), including:

- A description of the policies and procedures adopted to implement the Program,
- The promotion and marketing of the Program, and
- An analysis of the utilization and performance of the Program.

Section 2. Program Overview

The Hazard Pay Grant Program was authorized by Act 136 of 2020 and amended by Acts 154 and 168 of 2020 to provide grant funding to certain employers whose employees were substantially dedicated to mitigating or responding to the COVID-19 public health emergency or were providing essential services to Vermonters between March 13, 2020 and May 15, 2020. The Program allowed eligible covered employer applicants to request \$1,200 or \$2,000 per employee who met Program criteria, including but not limited to elevated risk of exposure to COVID-19 and minimum number of hours worked. Grants were awarded through an application process and funds were distributed on a first-come, first-served basis. While the first round of the grant application process was limited to certain public safety, public health, health care, and human services employers, the Program was expanded in a second application round to a broader group of covered employer types and employees who provided essential services to Vermonters and former employees of covered employers. In the second application round, covered employer applicants identified potentially eligible former employees in their application submissions in order for the Program to mail each former employee an application and issue payments directly to those eligible individuals that returned the completed application.

Total appropriations in the amount of \$60.6 million were provided to AHS to administer and make grant payments pursuant to the Hazard Pay Grant Program. An estimate of total Program spending by category and total funds that were unused by grant awardees is included in Table 1. AHS administered the first round of the Program and the Department of Financial Regulation (DFR) administered the second round of the Program with support from AHS.

Section 3. Policies and Procedures

AHS developed and adopted procedures for implementing the Program. The procedures were updated for the second round of the Program by DFR, which led the implementation of the Program expansion. The procedures were developed in order to ensure: 1) applications were simple and user-friendly, 2) completed applications were reviewed in a fair, appropriate, and consistent manner, 3) award payments were made in a timely manner, and 4) awardees were accountable for the use of the grant funds.

A. Application Form

The grant application was developed within the Vermont Economic Recovery Grants online portal, which was created to disburse Federal Coronavirus Aid, Relief, and Economic Security (CARES) Act funds. Users of the portal could register one time and access multiple grant opportunities available in the State of Vermont. The application was designed to be simple and capture the necessary information to ensure employer eligibility, ensure the appropriate grant award amount was calculated based on the number of eligible employees, and process award letters and payments in an accurate and timely manner.

Application instructions were posted on the Program's website prior to program golive. These instructions included screenshots, where available, and indicated how to complete the necessary data fields and required attachments that captured information about current and former employees. The instructions covered how to:

- Complete required attachments,
 - o Summary Report of Eligible Employees,
 - o Summary Report of Former Employees (Round 2 only), and
 - o Form W9 (when necessary),
- Complete registration,
- Select the appropriate application from the portal,
- Complete Form W9 tax information data fields,
- Enter contact information,
- Indicate Covered Employer type for eligibility purposes,
- Enter the number of eligible employees,
- Complete certifications, and
- Review and submit the application.

In addition, a webinar was offered to interested employers prior to program go-live to explain the application process and requirements.

The amount of funding requested was calculated within the application based on the data that was input. Staff from AHS, DFR and the Agency of Digital Services (ADS) provided technical assistance to applicants that experienced technical difficulties or had additional questions about the application. Frequently Asked Questions were included in a document posted on the Program website.

B. Application Review

Grant Review Team Procedures were developed to ensure all applications were reviewed in a fair, appropriate, and consistent manner. All reviewers and managers received the procedures and were trained on the use of the online portal and the

procedures. The online portal training ensured all reviewers and managers had the necessary expertise to locate application information, appropriately track applications within the portal, issue recommendations and, for the management team only, issue final determinations. Source materials were included with the procedures for use by the review team where provider lists were available for certain Covered Employer types. Daily check-in opportunities were available for reviewers and managers to discuss applications and procedural questions.

The procedures indicated the roles of subject matter experts (SMEs)/reviewers, and the management team within the two-level review process. Subject matter experts were assigned applications within their area of expertise. The procedures included review criteria and a rubric, which was used to evaluate completeness, accuracy, and appropriateness. Standard documentation procedures were developed and used to communicate recommendations between the SMEs/reviewers and management team and final determinations to the applicant. Procedures indicated that applications were to be reviewed on a first-come, first-served basis in order to ensure funding was only approved up to the available appropriation and to the earliest applicants. All applications were stamped with a submitted date and time and the team reviewed applications within the portal queue in the order of earliest submission.

In Round 2 only, managers provided the Summary Report of Former Employees for each approved application at the time of approval to a specialized team at DFR that mailed applications to each identified Former Employee and processed all returned applications to verify completeness and accuracy and to process payment.

C. Awards and Payments

Procedures were developed to utilize the information in each approved application to generate a Grant Award Letter and payment to each awardee. On a weekly basis, Form W9 information from each newly approved applicant was securely submitted in a batch file to the Department of Finance and Management (F&M) in order to create a Supplier ID number within the payment system for each awardee. This information was matched with applicant information within the application portal in order to generate Grant Award Letters and produce batch payment files. Grant Award Letters were sent to awardees through the application portal and batch payment files were securely provided to F&M for weekly processing. Similarly, batch files were exchanged with F&M to generate Supplier IDs for each eligible former employee and process payments. A Program goal was to distribute grant funds within two weeks of approval due to the processing time required to obtain and upload Supplier ID numbers and create and process batch payment files.

D. Accountability for Grant Funds

All grant awardees were required to report the amount of grant funds used to provide hazard pay to eligible employees within 90 days of receiving the grant award or December 15, 2020, whichever was earlier. Because applications were accepted until November 18th and Congress extended the deadline by which Coronavirus Relief Funds could be used, a grace period for completing the report was provided to grant awardees that received payments after November 24th, 2020 and requested the additional time for report completion. This report was completed through the grant application portal and instructions were posted on the Program website indicating how to access and complete the report. The report calculated the amount of grant funds that were due to be returned based on the award amount and the awardee-reported amount of grant funds disbursed to ensure awardees were aware of how much funding was due to be returned to the State of Vermont at the time of report submission. The application portal was programmed to send reminder notices about the report due date. The first notice was sent to awardees in conjunction with the Grant Award Letter and indicated the reporting requirements, due date, and where to locate the instructions. The second and third notices were sent 30 days and 7 days prior to the grant funds reporting due date. Completion of the grant funds spending report, including the amount of grant funds that were disbursed and the amount of unspent grant funds that were due to be returned to the State of Vermont, if applicable, was tracked within the application portal. When unspent grant fund checks were received by AHS, the amount and check deposit date were entered into the application portal. Awardees that did not return all or some unused funds by December 1, 2020 were sent an additional reminder notice that grant funds were due. Staff followed up with awardees that were not compliant with the timelines by email and phone and provided technical assistance to awardees, as needed. Follow-up is ongoing as several awardees have outstanding grant funds spending reports that are overdue and several additional awardees have not returned their unspent grant funds.

Section 4. Promotion and Marketing of the Program

Several promotion and marketing approaches were utilized to increase participation in the Program. A website was developed as the primary source of information about the Program and to host program guidance documents for employers and employees.⁴ Links to the website were published on the main pages of both AHS and DFR websites and within the Vermont Economic Recovery Grants website.

Email blasts were sent to applicable trade associations whose members were likely to meet the Covered Employer criteria, as well as directly to several types of health and human services providers and licensed entities that potentially qualified as Covered Employers, including licensed wastewater treatment facilities, waste management operations, waste transporters, and security services providers. An email list was developed with over 4,000 contacts including individuals and organizations that expressed interest in the Program or the Health Care Provider Stabilization Program. Notices were sent to the email list prior to the start of the Program and as needed to share updates. Given the high interest in and successful promotion of the Program, staff received and responded to over 5,000 Program inquiries.

Press releases were distributed through the Office of Governor Scott before program go-live for both rounds of funding and updates were provided during Governor Scott's press conferences. In addition, DFR distributed Program information and updates through Twitter, their monthly industry newsletter email, and press releases. Prior to the end of the application period, Governor Scott and DFR contacted several large retailers to encourage them to apply for the Program.

DFR staff attempted contact with eligible former employees initially through direct mail and email with subsequent contact attempted via phone and text message in order to increase the response rate.

Section 5. Utilization and Performance of the Program

A. Utilization

Employer organizations submitted applications to the Hazard Pay Grant Program during two application rounds. Applications in the first round were accepted from August 4th, 2020 through September 29th, 2020. The application was revised to reflect Program changes as a result of the passage of Acts 168 and 154 of 2020 such as expansions to Covered Employer types and Eligible Employee criteria and reopened on October 28th, 2020. Applications were accepted until November 18th, 2020.

A total of 1,192 employer organizations received a Hazard Pay Grant Program grant award to disburse hazard pay to eligible employees. In the first round of the application process, 367 employer organizations received grant awards. An additional 825 grant awards were issued to employer organizations in Round 2. Eighty-five employer organizations met the Covered Employer criteria in Round 2 but only had former employees included in their application.⁵ These applications were approved and the State of Vermont mailed individual applications to the

identified former employees. A total of 538 employer applications were denied after a determination was made that the employer organization did not meet the eligibility criteria.

Each employer applicant selected one or more Covered Employer types on their application. The review team reviewed each application to ensure the applicant met Covered Employer criteria and the employees listed in the required reports worked at eligible worksites. Table 3 below lists the self-reported Covered Employer types, number of awardee organizations in each category and total award amount per category. The total number of awardees and award amounts is duplicated because organizations could list more than one applicable Covered Employer type in the application. It is also important to note that due to the shortened review time and high number of applications in Round 2 of the Program, reviewers ensured that the applicants met Covered Employer criteria but did not require applicants to correct Covered Employer types that were inaccurate in their application. For example, if a cleaning company that contracted with a health care facility selected both the cleaning service category and the health care facility category, they were not required to remove the health care facility selection and resubmit the application. Because of this decision to expedite the review process, some of the Covered Employer Types may be overrepresented.

Award payments were made directly to Covered Employers to distribute to eligible current employees. Beginning in Round 2 of the Program, the State of Vermont paid former employees of approved Covered Employers directly. Approximately \$60 million of the \$60.6 million appropriation was distributed to Covered Employers and former employees. Table 4. indicates the amount distributed to each applicant type. An additional \$335,413 was utilized for Round 2 ADS costs and payments to the online portal contractor that developed and operated the online application and for ARIS Solutions to administer an application process for independent direct support providers and issue payments.⁶

As further described above in Section 3, DFR staff mailed applications to every former employee identified by an approved Covered Employer. Follow-up was also conducted by phone, email, and text message where contact information was available. Because some former employees had terminated employment months before the Program was operational, not all addresses and phone numbers were accurate. In addition, some former employees were determined to be not eligible when the application was reviewed because the individual received more than one week of unemployment benefits. Despite challenges associated with inaccurate contact information and the determination that a subset of the former employees did not meet the eligibility criteria, over two-thirds of potentially eligible former employees returned an application and received payments.

As described in Section 3.D, grant awardees were required to return any unspent grant funds that were not disbursed to eligible employees. As of the writing of this report, awardees reported over \$2.8M in unspent grant funds. This includes ~\$1M that was awarded to ARIS Solutions (22% of the total grant award) based on available payroll data that was ultimately not disbursed subsequent to completion of the eligibility confirmation process. Most of the funds that were unspent by employers were due to employees leaving employment prior to the awardee receiving payment. Many of these former employees were paid directly by the State of Vermont. Six awardees returned their full award for reasons such as determining that their employees did not meet the eligibility requirements that they had attested to in the application upon subsequent review of the Grant Award Letter and Program Guidance.

B. Performance

AHS identified and adopted critical success factors, measurable goals and performance measures for the Program. Table 6 contains goals and performance measures of the Program by critical success factor.

Ease of Use

All employer applicants were required to complete a survey question within the application portal prior to submitting their application. The survey question asked: "Overall, how easy or difficult was it to complete this application?." Applicants were provided with five response options: very easy, easy, neither, difficult, and very difficult. The performance target was for 80% of approved applicants to indicate that the application was easy or very easy to use. Overall, 73% of approved applicants indicated that the application was easy or very easy to use. Seventeen percent of approved applicants indicated that the application was neither easy nor difficult. Ten percentage of approved applicants indicated that the application was difficult or very difficult. There was only slight variation in responses between Round 1 and Round 2 even though the Round 2 application required applicants to submit additional files and information about unemployment benefits and former employees.

Program staff became aware of technical challenges experienced by some applicants during the process. Among these applicants, some were uncomfortable using an online application and spreadsheets while others had difficulties due to the use of certain web browsers or because they did not know or remember their username. Some applicants did not receive emailed registration information from the application portal indicating their username or password reset because of their organization's spam filter. Program and ADS staff spent considerable time assisting applicants with entering the application portal and navigating the application. Although the survey did not ask the applicant the reason for the selection of their

response option, the difficulty experienced by 10% of approved applicants was likely due to user comfort with technology and technology-related issues. It is also important to recognize that the first-come, first-served nature of the program which was required by statute had the potential to disadvantage applicants that had limited technology skills and/or limited English proficiency and favored larger organization applicants that had available staff who could analyze payroll data and submit the application at the time the portal was opened.

Timely Distribution

Batch payments were made to approved applicants on a weekly basis, per procedures developed by the Department of Finance and Management (F&M). The procedures for issuing payments included a process for securely sharing batch files with F&M to establish a Supplier ID for each approved applicant using each applicant's Form W9. Once completed Supplier IDs were received from F&M on a weekly basis, the data was uploaded into the Salesforce platform in order to generate the batch payment file, which was securely shared with F&M. Because of the multi-step procedure to first obtain a Supplier ID from F&M and submit a payment file for weekly batch payments, AHS established a timely distribution goal of issuing payments within ten business days of application approval. Ninety percent of payments were issued within ten business days of application approval.¹¹0 Nine percent of payments were issued within 11 and 14 business days from date of approval. All of the 109 payments that were issued over ten business days after approval were issued in September. Process improvements were completed in

September that resolved the primary cause of the extended timeline. During the first weeks of the Program, the application was automatically populating the Supplier ID associated with the registered user from data within the Vermont Economic Recovery Grants system, when available, and automatically changing the status of the application to awarded upon application approval. This created challenges with generating files for F&M and completing quality checks in an efficient and timely manner. Due to these early challenges, changes were made to the system to disable the automatic status change. Following this change, 100% of payments were made within the target timeframe of ten business days from grant approval.

Accurate Distribution

A goal of the Program was to provide employers with accurate distribution of grant monies throughout the life of the Program. Over 99.8% of payments made to approved Covered Employers were accurate. Factors that contributed to the success of this measure include the use of an online application tool with efficient reporting capability, the two-level application review process that included procedures for Program staff to confirm application completeness and accuracy, and the payment process with F&M that included additional review of data by F&M staff. Grant payments were made to 1,192 approved employer applicants. A total of 0.17% of grant payments or 2 out of 1,192 payments were made incorrectly. The root causes of these errors were a typographical error by an applicant and the use of the incorrect DBA associated with a sole proprietor with multiple DBAs when issuing payment.

Section 6. Lessons Learned

\$60 million in Hazard Pay Grant Program grant payments were made to certain employers whose employees were substantially dedicated to mitigating or responding to the COVID-19 public health emergency or were providing essential services to Vermonters between March 13, 2020 and May 15, 2020 and their former employees who worked during that time period. Overall, the Program was successful in promoting participation and making timely and accurate payments. Although the Program was intended to recognize and compensate employees who kept Vermonters safe during the height of the public health crisis, it is important to note that the COVID-19 public health emergency has continued and this approach

was limited to only a portion of the time of the sustained crisis. An important consideration for future hazard pay programs is the long-term nature of the COVID-19 public health emergency and ongoing workforce needs.

Appendix A. Approved Hazard Pay Applicants

Approved Hazard Pay Grant Program applicants by round are indicated below. Approved applicants include both employer applicants that received a grant award to disburse funding directly to their eligible employees as well as employer applicants that only submitted lists of potentially eligible former employees and did not receive direct funding or a grant award. Applicants could be approved in both rounds of the Program if the covered employer identified new eligible employees or potentially eligible former employees as a result of the expansion of the Program. Sole proprietors who applied in their individual names are excluded from the tables below. This includes 7 applicants in Round 1 and 27 applicants in Round 2.
