1 section shall be construed to limit or restrict the right to discover or use in any
2 civil or criminal proceedings information or records that are available from
3 another source and entirely outside the Team’s review. The Team shall not use
4 the information or records generated during the course of its review for
5 purposes other than those described in this section.

6 (B) The Department may share deidentified data produced or
7 acquired by the Team with other states that have child fatality review panels,
8 provided access under such agreements is consistent with the privacy, security,
9 and disclosure protections in this chapter.

17 necessary and in the interest of public health, welfare, and safety, or in

20 Medical Examiner’s direction. Upon completion of the autopsy, the Chief
21 Medical Examiner shall submit a report to such State’s Attorney and the

1 Attorney General and shall submit a report of death to the State Registrar.
2 Upon the written request of a federal prosecutor or a prosecutor in another
3 state, the Chief Medical Examiner shall submit a report of a death to the
4 requesting office.
