Question received from Rep Yacovone:

how much the benefit would be reduced if a person received an extra \$50 in UI? We ran some different scenarios for you in response to this question since each household's benefit amount can vary depending on income and expenses and other variables.

Background info for the info below: The Maximum Shelter expense allowed is \$586. For these scenarios we used \$1000 to drive the max benefit calculation and the households below also received the utility allowance. For Shelter costs, as income increases, the allowable shelter deduction can decrease causing a larger decrease in benefits. So for a household whose UIC income increases, it may also cause a change to their shelter deduction, which causes a decrease in benefits. Other variables that could affect these households and their benefits size would be childcare, child support payments and disability status which allows for uncapped shelter.

Here is an example for someone receiving \$450/wk in UIC.

Benefit with Max Shelter \$261

Benefit with No Shelter \$85

All budgets below are a household of 3; 1 adult and 2 children:

\$400/wk of unemployment- maximum shelter expense (\$1000), eligible for \$325 in 3SVT.

\$450/wk of unemployment- maximum shelter expense, eligible for \$261 in 3SVT.

\$500/wk of unemployment- maximum shelter expense, eligible for \$196 in 3SVT.

\$600/wk of unemployment- may be eligible for a small benefit depending on their shelter cost. The household with the max shelter has a \$67 benefit, the other was a zero benefit household if categorically eligible.

\$650 wk unemployment- The HH with limited shelter cost was a zero benefit. The household with the max shelter was eligible for a \$3 benefit.

\$700/wk unemployment- would receive a zero benefit if they are categorically eligible.
