

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on Judiciary to which was referred House Bill No. 534  
3 entitled “An act relating to sealing criminal history records” respectfully  
4 reports that it has considered the same and recommends that the bill be  
5 amended by striking out all after the enacting clause and inserting in lieu  
6 thereof the following:

12 criminal history record related to a conviction under the following  
13 circumstances:

14 (A) The person was convicted of an offense for which the underlying  
15 conduct is no longer prohibited by law or designated as a criminal offense.

16 (B) The person was convicted of a qualifying crime or qualifying  
17 crimes arising out of the same incident or occurrence.

18 (C) The person was convicted of a violation of 23 V.S.A. § 1201(a)  
19 related to operating under the influence of alcohol or other substance, provided  
20 that:

21 (i) the violation did not:

1                    (I) result in serious bodily injury or death to any person other  
2 than the operator;

3                    (II) involve operating a school bus with a blood alcohol  
4 concentration of 0.02 or more;

5                    (III) involve operating a commercial vehicle with a blood  
6 alcohol concentration of 0.04 or more; and

7                    (ii) the person is not licensed as a commercial driver pursuant to

18 (B) if the person committed a subsequent offense, the date on which  
19 the person satisfied the judgement for the subsequent offense, whichever is  
20 later.

1           (2) Any restitution and surcharges ordered by the court for any crime of  
2           which the person has been convicted has been paid in full, provided that  
3           payment of surcharges shall not be required if the surcharges have been waived

3 (a) Order and notice. Upon entry of an order to seal, the order shall be  
4 legally effective immediately and the person whose record is sealed shall be  
5 treated in all respects as if ~~he or she~~ the person had never been arrested,  
6 convicted, or sentenced for the offense and that its effect is to annul the record  
7 of arrest, conviction, and sentence. The court shall provide notice of the  
8 sealing to the respondent, Vermont Crime Information Center (VCIC), the  
9 arresting agency, the Restitution Unit of the Vermont Center for Crime Victim  
10 Services, and any other entity that may have a record related to the order to  
11 seal. The VCIC shall provide notice of the sealing to the Federal Bureau of

17 ~~filing or citing to that decision shall ensure that information regarding the~~  
18 ~~identity of the defendant in the sealed record is redacted.~~

19           (3) For sentencing in subsequent offenses, the court and parties in a  
20 criminal case shall have access to sealed records as follows:

1           (A) nonpredicate misdemeanors and offenses that are no longer  
2 prohibited by law for three years;

3           (B) qualifying DUI offenses for seven years;

4           (C) burglary into an occupied dwelling committed when person was  
5 25 years of age or under for 10 years;

6           (D) qualifying felony property offenses and selling, dispensing, or  
7 transporting a regulated drug offenses for seven years.

8           (4) The Department of Corrections shall have access to sealed records  
9 for the purpose of conducting risk assessments and making supervision  
10 decisions as follows:

11           (A) misdemeanors and offenses that are no longer prohibited by law  
12 for three years;

13           (B) qualifying DUI offenses for seven years;

14           (C) burglary into an occupied dwelling committed when person was  
15 25 years of age or under for 10 years; and

16           (D) qualifying felony property offenses and selling, dispensing, or  
17 transporting a regulated drug offenses for seven years.

18           (5) The State's Attorney and Attorney General may disclose information  
19 contained in a sealed criminal history record when required to meet their  
20 otherwise legally required discovery obligations.

1           (6) Upon request, the Victim’s Compensation Program shall be provided  
2           with a copy, redacted of all information identifying the offender, of the  
3           affidavit for the sole purpose of verifying the expenses in a victim’s  
4           compensation application submitted pursuant to section 5353 of this title.

5           (7) The sealing of a criminal record shall not affect the authority of the  
6           Restitution Unit to enforce a restitution order in the same manner as a civil  
7           judgment, pursuant to 5362(c)(2) of this title.

8           (d) Exceptions; dismissed charges. The prosecution shall have access to  
9           cases dismissed without prejudice for three years. The prosecution may object  
10           to the loss of access at three years by proving that the loss of access would  
11           pose a “significant risk to public safety.”

12           (e) Process.

13           (1) The court shall bar viewing of the sealed offense in any accessible  
14           database that it maintains.

15           (2) Until all charges on a docket have been sealed, the case file shall  
16           remain publicly accessible.

17           (3) When all charges on a docket have been sealed, the case file shall  
18           become exempt from public access.

19           ~~(e)~~(f) Special index.

20           (1) The court shall keep a special index of cases that have been sealed  
21           together with the sealing order. The index shall list only the name of the

1 person convicted of the offense, ~~his or her~~ the person's date of birth, the docket  
2 number, and the criminal offense that was the subject of the sealing.

3 (2) The special index and related documents specified in subdivision (1)  
4 of this subsection shall be confidential and shall be physically and  
5 electronically segregated in a manner that ensures confidentiality and that  
6 limits access to authorized persons.

7 (3) Except as provided in ~~subsection~~ subsections (c) and (d) of this  
8 section, inspection of the sealing order may be permitted only upon petition by  
9 the person who is the subject of the case. The Chief Superior Judge may  
10 permit special access to the index and the documents for research purposes  
11 pursuant to the rules for public access to court records.

12 (4) The Court Administrator shall establish policies for implementing

15 § 7611. UNAUTHORIZED DISCLOSURE

16 A state or municipal employee or contractor or any agent of the court,  
17 including an attorney and an employee or contractor of the attorney, who in the  
18 course of their official duties, knowingly discloses sealed criminal history  
19 record information without authorization shall be assessed a civil penalty of  
20 not more than \$1,000.00. Each unauthorized disclosure shall constitute a  
21 separate civil violation.

2 § 2002. EXPUNGEMENT OF MUNICIPAL VIOLATION RECORDS

3 (a) Expungement. **Three** years following the satisfaction of a judgment  
4 resulting from an adjudication of a municipal violation, the Judicial Bureau  
5 shall make an entry of “expunged” and notify the municipality of such action  
6 provided the person has not been adjudicated for any subsequent municipal  
7 violations during that time. The data transfer to the municipality shall include  
8 the name, date of birth, ticket number, and offense. Violations of **24 V.S.A.**  
9 **chapter 117** shall not be eligible for expungement under this section.

10 (b) Effect of expungement.

11 (1) Upon entry of an expungement order, the order shall be legally  
12 effective immediately and the individual whose record is expunged shall be  
13 treated in all respects as if the individual had never been adjudicated of the  
14 violation.

15 (2) Upon an entry of expunged, the case will be accessible only by the

13          (2) On or before November 15, 2022, the Committee shall submit  
14          proposed legislation to the General Assembly.

15          (d) Assistance. For purposes of scheduling meetings and preparing  
16          recommended legislation, the Committee shall have the assistance of the  
17          Office of Legislative Operations, the Office of Legislative Counsel, and the  
18          Joint Fiscal Office.

19          (e) Meetings.

20          (1) The Office of Legislative Counsel shall call the first meeting of the  
21          Committee on or before August 1, 2022.

1           (2) The Committee shall select a chair from among its members at the  
2           first meeting.

3           (3) A majority of the membership shall constitute a quorum.

4           (4) The Committee shall cease to exist on December 31, 2022.

5           (g) Compensation and reimbursement. For attendance at meetings during  
6           adjournment of the General Assembly, a legislative member of the Committee  
7           shall be entitled to per diem compensation and reimbursement of expenses  
8           pursuant to 2 V.S.A. § 23 for not more than four meetings. These payments  
9           shall be made from monies appropriated to the General Assembly.
