Madame Chair:

Below please find the answers to your questions.

What information is currently needed from an adopted person to receive their original birth certificate?

Vital Records Office needs authorization from the Adoption Registry or a court to release the original birth certificate and the date of birth and registrant's name on original birth certificate to find the original record.

If the Registry's requirements were amended, it would be a frictionless change for Vital Records.

Is there always an amended birth certificate linked with the original in the Department of Health's vital records database?

No. There are many different reasons, but the primary one being that we have switched from a manual/paper world, to a digital one. So, yes or no. In this case, no.

What would be required of an adopted person if the law is amended to repeal 15A § 6-105(b)?

The adoptee would need to provide their date of birth and name as given on the original birth certificate in order for VDH to find the record. Adoptees would need to include valid identification that reflects information on their current Vermont birth certificate so it is clear the request is coming from the adoptee.

In short, they would be treated like any other person seeking their birth certificate.

Does VDH have enough information to work directly with adoptees if the adoptee is only seeking access to their original birth certificate?

Yes.

Good morning David,

I have a few more questions from Chairwoman Grad regarding access to original birth certificates. She would like to know what information is currently needed from an adopted person to receive their original birth certificate.

She would also like to know if there is always an amended birth certificate linked with the original in the Department of Health's vital records database. Lastly, what would be required of an adopted person if the law is amended to repeal 15A § 6-105(b)? The intent behind this proposal is to remove the barrier of the adopted person first having to go to the Registry to receive identifying information. Does VDH have enough information to work directly with adoptees if the adoptee is only seeking access to their original birth certificate?
