19	Families and the Department of Corrections shall report propose a plan to the

1	Institutions, and Human Services on to ensure the availability of secure
2	placements and transitional housing for 18- and 19-year-olds persons 18 years
3	of age and older who are subject to juvenile and youthful offender proceedings.
4	The report plan shall include:
5	(A) both data on the number and location of current secure
6	placements, and a plan for how current and future options for secure
7	placements will be accomplished;
8	(B) a plan to provisions ensuring that the placements are available for

11	(D) a recommendation as to whether dual custody with the
