Municipalities that receive designation collaborate with local non-profit downtown organizations supporting efforts through funding, staff, partnerships and volunteers.








#### **Better Connections Grant Program**

The Better Connections Grant Program is a multiagency partnership that aligns state and local investments to increase transportation options, build resilience, and strengthen economic vitality in Vermont communities.



#### VERGENNES DOWNTOWN-BASIN MASTER PLAN

Over the past year, the City of Vergennes and the Addison County Regional Planning Commission have been developing a Master Plan for the Downtown and Basin. This project has been funded largely through a Strong Communities. Better Connections grant from the Vermont Agency of Transportation (VTrans) and the Vermont Agency of Commerce & Community Development (ACCD).

#### What is the Master Plan supposed to do?

A master plan is a general plan that outlines the projects that a City would undertake over the next to to a oyears in order to achieve a shared community vision. The process for developing a master plan is typically led by a steering committee and involves gathering public input, identifying existing issues and opportunities, and recommending solutions to address the issues and achieve the vision, It is essentially a roadmap from Point A (existing conditions) to Point B (the envisioned scenario).

The Vergennes Downtown-Basin Master Plan is a direct outgrowth of the 2014 Vergennes Community Visit by the Vermont Council on Rural Development (VCRD) and has the following vision:

To realize the economic potential of Vergennes' assets by strengthening the connection between the Downtown and Otter Creek Basin, improving multi-modal opportunities, street design, and recreational opportunities.



Design concepts were demonstrated on Saturday, September 26, 2015.
