Re: H.655 In-state and out-of-state Licensee Numbers

Dear House Committee on Ways and Means,

In testimony this week you requested the total number of Vermont licensees by profession and the subset of Vermont licensees who do not list a Vermont address. In reviewing this data, it is important to remember that addresses are self-reported by the licensee and may not reflect where a licensee lives or works. This is due to:

- Failure to update their address after a move or change of practice location.
- The use of a business address that is unrelated to where they are practicing, such as a credentialing company that manages their licenses or the location of a telehealth company that is not where the licensee or the patients are located.

The following table shows the total number of active licenses by profession and the subset of licensees with a non-Vermont address.
