HEALTH CARE PROVIDER STABILIZATION GRANT PROGRAM ADMINISTRATION

Number of Applications Received in Application Cycle 1 and Cycle 2

The first application cycle resulted in **351** applications received from eligible providers by the deadline. The second application cycle resulted in **272** applications again received from a broad array of provider types and organizations including primary care, mental health, specialists, dental, chiropractic, physical therapy, family centers, hospitals, and designated/specialized service agencies. In accordance with the legislative requirements of Act 136 (2020), Appendix I provides the specific grant award amounts by each provider recipient of funds under the Health Care Provider Stabilization Grant program.¹

Payments Distributed to Eligible Providers through December 30, 2020

In the first application cycle of the Health Care Provider Stabilization Grant Program, **\$87,007,181.66** was awarded and funding awards were issued as one lump sum grant payment. The payments were distributed to eligible providers beginning in September for the applications received by August 15, 2020. As of October 20th, the first application cycle was complete and \$85,118,535.15 had been paid by the Department of Finance and Management/AHS to providers determined to be eligible under the Health Care Provider Stabilization Grant Program. In addition, another \$1,888,646.51 of funds appropriated to the HCS Grant Program had been paid to the Agency of Commerce and Community Development for grant awards the Agency of Commerce and Community Development made to eligible health care and human service providers under their Program.

In the second application cycle of the Program, **\$58,695,286** was awarded and funding awards were issued as one lump sum grant payment. The payments were distributed to eligible providers beginning in December for applications received by November 24, 2020; payments were awarded under the second application cycle on December 21, 2020. Of this awarded amount, \$796,940 was for health care providers that received grants from the Agency of Commerce and Community Development's Economic Recovery program. Some providers that submitted applications did not qualify for funding awards because of state or federal financial relief already received and because business disruptions were not as significant as during the Cycle 1 eligibility period.

Emerging Issue

Subsequent to the recent surge in COVID-19 cases in Vermont, several long-term care facilities have faced staffing and supply crises as they have battled COVID-19 outbreaks. As such, the Agency of Human Services started an Emergency Financial Relief Program aimed

to provide minimal but critical assistance to these facilities. Eligibility requirements include:

- 1. Must have at least one positive COVID-19 patient and/or essential staff;
- 2. Must be a residential facility or crisis response service;
- 3. Must have a current and identifiable need that cashflow can reasonably be able to solve in the near term; and
- 4. Must attest to a financial hardship.

To date, the Agency of Human Services has issued five awards valued at **\$332,000**.

Ensuring Providers Submit Applications in the First and Second Application Cycles The Agency of Human Services provided time for applicants to make requested changes and corrections to applications during the administration of the first application cycle; this additional time resulted in providers resubmitting over 100 applications with amended information to be considered for funding awards in round 1. A small number applications were not resubmitted; others were resubmitted without fully addressing all requested changes or corrections. These applications were eligible to be considered for funding in the second application cycle.

The second application cycle of the Health Care Provider Stabilization Grant Program opened on October 19, 2020 and remained open through November 6, 2020. During the second application cycle, it was identified that providers required extra time for application submission; as a result, the application period for the second cycle was reopened on Tuesday, November 17, 2020 and extended through November 24, 2020, to allow additional time for application submission.

State Auditor Informs AHS of Decision to Conduct a Risk Assessment of the Health Care Provider Stabilization Grant Program

Subsequent to the notification from the State Auditor's Office that a risk assessment of the Health Care Provider Stabilization Grant Program was to be conducted in order to determine whether the risks associated with the Program 'warrant conducting a performance audit' as included in the last progress update for the Program, the State Auditor's Office officially announced a full audit of the Program on December 30, 2020. The State Auditor's Office indicated the preliminary objectives of the audit are:

- To assess whether and how the Agency of Human Services ensured that only those providers meeting state and federal requirements received payments under the HCS Grant Program; and
- To determine whether selected payments made to providers under the HCS Grant Program were supported and did not duplicate payments made under other government COVID-19 programs.

The entrance conference, a meeting to formally begin the full audit, has been scheduled to occur on January 14, 2021.

BACKGROUND AND EARLY PROGRAM IMPLEMENTATION

In accordance with Act 136 (H.965) of 2020, the Agency of Human Services shall submit a final report on the administration of the Health Care Provider Stabilization Program as established within the Act to the House Committees on Appropriations, Health Care and Human Services and the Senate Committees on Appropriations and Health and Welfare on or before January 15, 2021 with information on the specific grant amount or amounts awarded to each recipient of funds under the Health Care Provider Stabilization Grant Program. After several reallocations, the Program is authorized to utilize up to an amended amount, \$156,427,182, from the federal Coronavirus Relief Fund to provide direct cash grants to eligible health care and human service providers who have lost revenue and/or observed increased expenses due to the novel coronavirus disease 2019 (COVID-19) public health emergency following enactment of H.969 (Act 154).²

The Agency of Human Services launched the Health Care Provider Stabilization ("HCS") Grant Program on Friday, July 17, 2020. A broad spectrum of health and human service provider types, spanning self-employed practitioners to peer services providers to hospitals are eligible for the grant program. To ensure equity in the process and to encourage all eligible providers to seek funding, applicants had four weeks to complete the application, with the first round of applications due to the Agency by August 15, 2020 at 11:59PM EST. The process was intentionally designed to award funding only after all grant applications for an application cycle had been received. This ensured that awards were made in accordance with the total need demonstrated by eligible health care and human service providers in the applications submitted to the Agency, subject to available funding, and awards were not made on a first come, first served basis. The Agency administered two application cycles: the first that opened on July 17, 2020 with applications due by August 15, 2020, and the second that opened on October 19, 2020 with applications originally due by November 6, 2020 at 11:59PM EST.³ The second application cycle was re-opened on November 17, 2020 through November 24, 2020 to allow additional time for providers to submit applications for consideration of funding awards.

Initial federal legislation for Coronavirus Relief Fund expenditures required that funds must be expended by December 30, 2020; however, the passage of H.R. 133 (Consolidated Appropriations Act, 2021) and the President's signature on December 27, 2020, extended the deadline for Coronavirus Relief Fund expenditures to December 31, 2021.⁴ While the deadline for Fund expenditure was extended, the Health Care Provider Stabilization Grant Program executed its expenditures in accordance with the original deadline as detailed with the state legislation (Act 136 (H.965) of 2020).

Purpose of the Health Care Provider Stabilization Grant Program

The Health Care Provider Stabilization Grant Program was designed to ensure a stabilized system of care that can continue to serve Vermonters by providing financial assistance to a broad array of health care and human service providers who experienced financial hardship due to the COVID-19 public health emergency. The Program was authorized to utilize up to \$156,427,182 from the federal Coronavirus Relief Fund to provide direct cash grants to eligible health care and human service providers who had lost revenue and/or observed increased expenses due to the COVID-19 public health emergency. The Program was administered in accordance with the requirements of Act 136 of 2020, as well as with the Federal Coronavirus Relief, and Economic Security (CARES) Act that governs the permissible use of Coronavirus Relief Funds.

HCS Online Application Portal for Electronic Application Submission

As part of administering the Health Care Provider Stabilization ("HCS") Grant Program, the Agency of Human Services needed to develop an online application portal in order to support providers in applying for the Program and submitting required documentation for the application through an electronic means.⁵ The HCS Grant Program online application portal opened on July 17, 2020 for the first application cycle and providers had through August 15, 2020 at 11:59PM EST to submit their applications for grant funding for the time period of March 1, 2020 – June 15, 2020. This 4-week opening for applications to be submitted was intended to ensure that even Vermont's smallest providers had sufficient time to complete their applications; it also ensured that the grant funding was not awarded on a first come, first served basis but rather with consideration for the total need demonstrated in applications received.

The second application cycle opened on October 19, 2020 and providers initially had until November 6, 2020 at 11:59PM EST to submit applications for the time period of March 1 – September 15, 2020; however, the application period was extended to provide additional

time for application submission (November 17, 2020 – November 24, 2020). Providers that applied for funding in the first application cycle were eligible to apply again during the second application cycle.

Program Overview for Applicants & Additional Guidance Documents

The Agency developed an overview document for providers that describes the Program in one-page, including objectives of the Program, eligible provider organizations, documentation required, grant application process and timeline, and conditions of grant funding.6 The one-page overview included the required information regarding grant fund expenditures by December 30, 2020 pursuant to the initial Fund expenditure requirement, that grant funds must be used to cover costs and lost revenues associated with the coronavirus disease 2019 (COVID-19) disaster, and that any grant funded with federal funds is subject to the requirements of a Single Audit.⁷ The one-page Program overview was publicly posted on the same day that the HCS Online Application Portal opened in order to support providers in understanding Program process and requirements. In addition, guidance documents including a Frequently Asked Questions, Application Readiness & Documentation Upload Guide, Expenditures Guide, Peer Support & Program Pre-Approval Certification, Revenue Changes Guide, and Financial Assistance To Date Guide were all developed and published on DVHA's public-facing COVID-19 website, with a link that directs all interested individuals to the full Program information at: https://dvha.vermont.gov/health-care-provider-stabilization-grant-program.

Outreach & Education for Eligible Providers

In addition to the Governor of Vermont including information about the HCS Grant Program in his twice weekly press conferences, the Governor's Office issuing subsequent press releases about the Program and the Agency developing a sign-up list for providers to receive programmatic announcements and updates, the Agency also developed an online submission form to receive any questions related to the HCS Grant Program.⁸ Questions received from potential applicants were reviewed and compiled into the Frequently Asked Questions document to ensure information was shared broadly with providers of all types and sizes.

Building on the lessons learned regarding the effectiveness of the Agency of Commerce and Community Development's webinar for potential grant applicants, the Agency of Human

Services offered a series of webinars scheduled for the first week after the HCS Grant Program online application portal opened on July 17, 2020. The webinars were well attended, with some garnering participation from over 100 individuals throughout the State of Vermont, and offerings included: General Overview of the Program, Completing Revenue Expenses, Claiming COVID-19-related Expenses and a webinar designed specifically for designated agency and specialized service agency applicants. All presentations in the HCS Grant Program webinar series were recorded and posted publicly at: <u>https://dvha.vermont.gov/health-care-provider-stabilization-grant-program</u>. A total of 198 questions were received from potential applicants, with all questions answered before the first application cycle closed.

For the second application cycle, a call center was established to provide additional support; providers were able to reach the call center from 8AM – 4:30PM EST through November 24, 2020 with any questions related to the Health Care Provider Stabilization Grant Program. Questions could also be submitted using the <u>Online Question Submission form</u> at any time, allowing providers to seek information after business hours and on weekends.

Eligibility Requirements for Applicants

The first page of the HCS Grant Program online application portal provided the following eligibility requirements to ensure applicants were aware of the minimum requirements, including that providers must have been/be:

- Domiciled in Vermont;
- Operating on or before February 1, 2020;
- Considered a "billing provider"9;
 - if not a billing provider, complete <u>the pre-approval certification</u> and receive approval before beginning the application.
- Committed to maintaining participation in value-based payment initiatives, as applicable, through calendar year 2021, if already participating in calendar year 2020. Participation in a value-based payment initiative will not affect an entity's award amount;
- In agreement with the terms and conditions of the Grant.

Successes and Challenges of Administering the HCS Grant Program

Building on previous experience providing financial relief to health care providers, the Agency of Human Services and Department of Vermont Health Access were successful in quickly opening a new online application portal and developing an application process to reflect the requirements of Act 136 of 2020. Only 15 days after Governor Scott signed Act 136, the Program application process and new online portal were opened.

Agency and Department staff demonstrated incredible flexibility and dedication by quickly orienting themselves to the new stream of work and executing it to the same high standard as their routine assignments and while responding to the COVID-19 public health emergency. Early on, technical issues were identified related to AHS' adaptation of ACCD's existing grant application platform, but solutions and workarounds were quickly developed. Agency staff were accessible and responsive to incoming questions in order to provide tailored technical assistance during the time the first application cycle was open, as permitted by existing staff capacity. During the second application cycle, more information was available and accessible regarding state and federal funding awards from other programs and internal processes were developed that allowed for improved efficiency in validation of provider reported information. State staff were able to use available information to verify state and federal funding awards, improving the accuracy of funding awards made under the HCS Grant Program.

The complexity of the required information for funding awards necessitated a review team being convened. The review team validated application inputs using applicants' supporting documentation to ensure that funding recommendations were consistent with the expectations of the Health Care Provider Stabilization Grant Program. As the Health Care Provider Stabilization Grant Program was funded with federal funds, grant award recipients are subject to the requirements of a Single Audit. Thus, careful review, validation, and quality control were key elements utilized by the review team to minimize risk to the State of Vermont, Agency of Human Services and Vermont's providers.

Finally, the evolving nature of the COVID-19 pandemic resulted in evolving federal requirements and guidance for the use of the funds provided under the Coronavirus Relief Fund and required states to adapt program administration based on revised guidance for appropriate Fund expenditures. In Vermont, this resulted in the Agency of Human Services issuing retroactive grant agreements for the financial relief provided under the Agency's earliest efforts to financially stabilize Vermont's health care and human service providers. As of January 5, 2021, 328 retroactive grant agreements had been sent to providers receiving financial relief in the early months of the pandemic response (April, May, June and July 2020), with a total of 252 providers having already signed the retroactive grant agreements. Any providers who received the COVID-19-specific Medicaid Retainer, the COVID-19 Sustained Monthly Retainer, or COVID-19 Extraordinary Financial Relief for Nursing Homes and Private Non-Medical Institution Payments were informed that:

- Coronavirus Relief Funds (CRF) were used to cover the awards issued;
- As Coronavirus Relief Funds are federal dollars, recipients of funding awards are subject to a single audit;
- Providers were reminded that they were only allowed to use the funds to

cover eligible COVID-19-related revenue losses and/or expenses and they are required to maintain documentation;

 The retroactive grant agreements remove the potential for the 10% recoupment based on quality performance that accompanied earlier Retainer payments.

The State requested all providers submit documentation to validate the awards. The Agency will begin to call each of the remaining 76 providers that have not yet responded and/or acknowledged the Agency's request for the executed grant agreement during the week of January 11, 2020.
