9	(a) The Commissioner of Labor shall develop and implement changes to
10	the unemployment insurance mainframe software necessary to implement on
11	July 1, 2024 the changes to the unemployment insurance weekly benefit
12	amount enacted pursuant to Sec. 6 of this act. The changes shall be developed
13	and implemented in a manner that minimizes risk to the operation of the
14	mainframe and the functions of the unemployment insurance program.
15	(b) The Commissioner of Labor shall, on or before January 15, 2023 and
16	January 15, 2024, submit a written report to the House Committee on
17	Commerce and Economic Development, the Senate Committee on Economic
