

1 TO THE HOUSE OF REPRESENTATIVES:

2 The Committee on General, Housing, and Military Affairs to which was  
3 referred Senate Bill No. 79 entitled “An act relating to improving rental  
4 housing health and safety” respectfully reports that it has considered the same  
5 and recommends that the House propose to the Senate that the bill be amended  
6 by striking out all after the enacting clause and inserting in lieu thereof the  
7 following:

17 § 2729. GENERAL PROVISIONS; FIRE SAFETY; CARBON MONOXIDE

18 (a) A person shall not build or cause to be built any structure that is unsafe  
19 or likely to be unsafe to other persons or property in case of fire or generation  
20 and leakage of carbon monoxide.

1 (b) A person shall not maintain, keep or operate any premises or any part  
2 thereof, or cause or permit to be maintained, kept, or operated, any premises or  
3 part thereof, under his or her control or ownership in a manner that causes or is  
4 likely to cause harm to other persons or property in case of fire or generation  
5 and leakage of carbon monoxide.

6 (c) On premises under a person’s control, excluding single family owner-  
7 occupied houses and premises, that person shall observe rules adopted under  
8 this subchapter for the prevention of fires and carbon monoxide leakage that  
9 may cause harm to other persons or property.

10 (d) Any condominium or multiple unit dwelling using a common roof, or  
11 row houses so-called, or other residential buildings in which people sleep,  
12 including hotels, motels, and tourist homes, excluding single family owner-  
13 occupied houses and premises, whether the units are owned or leased or rented,  
14 shall be subject to the rules adopted under this subchapter and shall be  
15 provided with one or more carbon monoxide detectors, as defined in 9 V.S.A.  
16 § 2881(3), properly installed according to the manufacturer’s requirements.

17 § 2730. DEFINITIONS

18 (a) As used in this subchapter, “public building” means:

19 \* \* \*

1 (D) a building in which people rent accommodations, whether  
2 overnight or for a longer term, including “rental housing” as defined in  
3 subsection (f) of this section;

4 \* \* \*

5 (2) Use of any portion of a building in a manner described in this  
6 subsection shall make the entire building a “public building” for purposes of  
7 this subsection. For purposes of this subsection, a “person” does not include  
8 an individual who is directly related to the employer and who resides in the  
9 employment-related building.

10 (b) The term “public building” does not include:

11 (1) An owner-occupied single family residence, unless used for a  
12 purpose described in subsection (a) of this section.

17 (f) “Rental housing” means housing that is leased or offered for lease and  
18 includes a “dwelling unit” as defined in 9 V.S.A. § 4451 and a “short-term  
19 rental” as defined in 18 V.S.A. § 4301.

20 § 2731. RULES; INSPECTIONS; VARIANCES

21 (a) Rules.



1           (iii) provides notice that the landlord is prohibited from renting the  
2           affected unit to a new tenant until the violation is corrected; and

3           (iv) provides notice in plain language that the landlord or agents of  
4           the landlord must have access to the rental unit to make repairs as ordered by  
5           the Commissioner consistent with the access provisions in 9 V.S.A. § 4460;

6           (B) provide a copy of the inspection report to the landlord, to the

5                    § 2733. ORDERS TO REPAIR, REHABILITATE, OR REMOVE  
6                    STRUCTURE

7                    (a)(1) Whenever the ~~commissioner~~ Commissioner finds that premises or  
8                    any part of them does not meet the standards adopted under this subchapter,  
9                    the ~~commissioner~~ Commissioner may order it repaired or rehabilitated.

10                    (2) If ~~it~~ the premises is not repaired or rehabilitated within a reasonable  
11                    time as specified by the ~~commissioner~~ Commissioner in his or her order, the  
12                    ~~commissioner~~ Commissioner may order the premises or part of them closed, if  
13                    by doing so the public safety will not be imperiled; otherwise he or she shall  
14                    order demolition and removal of the structure, or fencing of the premises.

15                    (3) Whenever a violation of the rules is deemed to be imminently  
16                    hazardous to persons or property, the ~~commissioner~~ Commissioner shall order  
17                    the violation corrected immediately.

18                    (4) If the violation is not corrected, the ~~commissioner~~ Commissioner  
19                    may ~~then~~ order the premises or part of them immediately closed and to remain  
20                    closed until the violation is corrected.

1 (b) Whenever a structure, by reason of age, neglect, want of repair, action  
2 of the elements, destruction, either partial or total by fire or other casualty or  
3 other cause, is so dilapidated, ruinous, decayed, filthy, unstable, or dangerous  
4 as to constitute a material menace or damage in any way to adjacent property,  
5 or to the public, and has so remained for a period of not less than one week, the  
6 ~~commissioner~~ Commissioner may order such structure demolished and  
7 removed.

8 (c) Orders issued under this section shall be served by certified mail with  
9 return receipt requested or in the discretion of the ~~commissioner~~  
10 Commissioner, shall be served in the same manner as summonses are served  
11 under the Vermont Rules of Civil Procedure promulgated by the ~~supreme court~~  
12 Supreme Court, to all persons who have a recorded interest in the property  
13 recorded in the place where land records for the property are recorded, and to  
14 all persons who will be temporarily or permanently displaced by the order,  
15 including owners, tenants, mortgagees, attaching creditors, lien holders, and  
16 public utilities or water companies serving the premises.

17 § 2734. PENALTIES

18 (a)(1) A person who violates any provision of this subchapter or any order  
19 or rule issued pursuant thereto shall be fined not more than \$10,000.00.

20 (2) The ~~state's attorney~~ State's Attorney of the county in which such  
21 violation occurs shall prosecute the violation and may commence a proceeding

1 in the ~~superior court~~ Superior Court to compel compliance with such order or  
2 rule, and such court may make orders and decrees therein by way of writ of  
3 injunction or otherwise.

4 (b)(1) A person who fails to comply with a lawful order issued under  
5 authority of this subchapter in case of sudden emergency shall be fined not  
6 more than \$20,000.00.

7 (2) A person who fails to comply with an order requiring notice shall be  
8 fined \$200.00 for each day's neglect commencing with the effective date of  
9 such order or the date such order is finally determined if an appeal has been  
10 filed.

11 (c)(1) The ~~commissioner~~ Commissioner may, after notice and opportunity  
12 for hearing, assess an administrative penalty of not more than \$1,000.00 for  
13 each violation of this subchapter or any rule adopted under this subchapter.

14 (2) Penalties assessed pursuant to this subsection shall be based on the  
15 severity of the violation.

16 (3) An election by the ~~commissioner~~ Commissioner to proceed under  
17 this subsection shall not limit or restrict the ~~commissioner's~~ Commissioner's  
18 authority under subsection (a) of this section.

1 (d) Violation of any rule adopted under this subchapter shall be prima facie  
2 evidence of negligence in any civil action for damage or injury ~~which~~ that is  
3 the result of the violation.

5 § 2736. MUNICIPAL ENFORCEMENT

6 (a)(1) The legislative body of a municipality may appoint one or more  
7 trained and qualified officials and may establish procedures to enforce rules  
8 and standards adopted under subsection 2731(a) of this title.

9 (2) After considering the type of buildings within the municipality, if the  
10 ~~commissioner~~ Commissioner determines that the training, qualifications, and  
11 procedures are sufficient, he or she may assign responsibility to the  
12 municipality for enforcement of some or all of these rules and standards.

13 (3) The ~~commissioner~~ Commissioner may also assign responsibility for  
14 enforcement of the rules of the access board adopted under section 2902 of this  
15 title.

16 (4) The ~~commissioner~~ Commissioner shall provide continuing review,  
17 consultation, and assistance as may be necessary.

18 (5) The assignment of responsibility may be revoked by the  
19 ~~commissioner~~ Commissioner after notice and an opportunity for hearing if the  
20 ~~commissioner~~ Commissioner determines that the training, qualifications, or  
21 procedures are insufficient.

1           (6) The assignment of responsibility shall not affect the ~~commissioner's~~  
2           Commissioner's authority under this subchapter.

3           (b) If a municipality assumes responsibility under subsection (a) of this  
4           section for performing any functions that would be subject to a fee established  
5           under subsection 2731(a) of this title, the municipality may establish and  
6           collect reasonable fees for its own use, and no fee shall be charged for the  
7           benefit of the ~~state~~ State.

8           (c)(1) Subject to rules adopted under section 2731 of this title, municipal  
9           officials appointed under this section may enter any premises in order to carry  
10          out the responsibilities of this section.

11          (2) The officials may order the repair, rehabilitation, closing,  
12          demolition, or removal of any premises to the same extent as the ~~commissioner~~  
13          Commissioner may under section 2732 of this title.

14          (d) Upon a determination by the ~~commissioner~~ Commissioner that a  
15          municipality has established sufficient procedures for granting variances and  
16          exemptions, such variances and exemptions may be granted to the same extent  
17          authorized under subsection 2731(b) of this title.

18          (e) The results of all activities conducted by municipal officials under this  
19          section shall be reported to the ~~commissioner~~ Commissioner periodically upon  
20          request.

1 (f) Nothing in this section shall be interpreted to decrease the authority of  
2 municipal officials under other laws, including laws concerning building codes  
3 and laws concerning housing codes.

5 § 2738. FIRE PREVENTION AND BUILDING INSPECTION SPECIAL  
6 FUND

7 (a) The fire prevention and building inspection special fund revenues shall  
8 be from the following sources:

9 (1) fees relating to construction and inspection of public building and  
10 fire prevention inspections under section 2731 of this title;

11 (2) fees relating to boilers and pressure vessels under section 2883 of  
12 this title;

13 (3) fees relating to electrical installations and inspections and the  
14 licensing of electricians under 26 V.S.A. §§ 891-915;

15 (4) fees relating to cigarette certification under section 2757 of this title;  
16 and

17 (5) fees relating to plumbing installations and inspections and the  
18 licensing of plumbers under 26 V.S.A. §§ 2171-2199.

19 (b) Fees collected under subsection (a) of this section shall be available to  
20 the ~~department of public safety~~ Department of Public Safety to offset the costs  
21 of the ~~division of fire safety~~ Division of Fire Safety.

17           (A) may disclose data it collects pursuant to this section to other  
18           State, municipal, or regional government entities; to nonprofit organizations; or  
19           to other persons for the purposes of protecting public health and safety;

20           (B) shall not disclose data it collects pursuant to this section for a  
21           commercial purpose; and

1           (C) shall require, as a condition of receiving data collected pursuant  
2           to this section, that a person to whom the Department discloses the data takes  
3           necessary steps to protect the privacy of persons whom the data concerns, to  
4           protect the data from further disclosure and to comply with subdivision (B) of  
5           this subsection (d).

7           § 2479. RENTAL HOUSING REGISTRATION

8           (a) Except as provided in subsection (c) of this section, the owner of a  
9           dwelling unit, as defined in 9 V.S.A. § 4501, that is leased or offered for lease  
10           shall:

11           (1) file with the Department of Taxes the landlord certificate required  
12           for the renter's rebate or the renter credit program; and

13           (2) within 30 days of filing the certificate, register, provide the  
14           information required by subsection 2478(b) of this title, and pay to the  
15           Department of Housing and Community Development an annual registration  
16           fee of \$35.00 per rental unit, unless the owner has within the preceding  
17           12 months:

18           (A) registered the unit pursuant to subsection (b) of this section; or

19           (B) registered the unit with a municipal, district, or other local  
20           government entity that operates a rental housing health and safety program  
21           with a rental registry that complies with subsection 2478(b) of this title.

1        (b) Except as provided in subsection (c) of this section, an owner of a  
2        short-term rental, as defined in 18 V.S.A. § 4301, shall, annually, within  
3        30 days of renting a unit, register, provide the information required by  
4        subsection 2478(b) of this title, and pay to the Department of Housing and  
5        Community Development an annual registration fee of \$35.00 per rental unit,  
6        unless the owner has within the preceding 12 months:

7                (1) registered the unit pursuant to subsection (a) of this section; or

8                (2) registered the unit with a municipal, district, or other local  
9        government entity that operates a rental housing health and safety program  
10        with a rental registry that complies with subsection 2478(b) of this title.

11        (c)(1)(A) An owner of a mobile home lot within a mobile home park who  
12        has registered the lot with the Department of Housing and Community  
13        Development and who does not own a mobile home on the lot is exempt from  
14        registering the lot pursuant to this section.

15                (B) An owner of a mobile home lot within a mobile home park who  
16        has registered the lot with the Department and who owns a mobile home on the  
17        lot that is available for rent or rented shall register the property with the  
18        Department and pay a fee equal to the fee required by subdivision (a)(2) of this  
19        section less any fee paid within the previous 12 months pursuant to 10 V.S.A.  
20        § 6254(c).

1           (C) An owner of a mobile home who rents the mobile home, whether  
2           or not located in a mobile home park, shall register pursuant to this section.

3           (2) The registration requirements of this section do not apply to housing  
4           that an owner provides to another person, whether or not for consideration, if,  
5           and only to the extent that, the owner does not otherwise make such housing  
6           available for lease to the general public, and includes:

7           (A) housing provided to a member of the owner’s family or personal  
8           acquaintances;

9           (B) housing provided to a person who is not related to a member of  
10           the owner’s household and who occupies the housing as part of a nonprofit  
11           homesharing program; and

12           (C) housing provided to a person who provides personal care to the  
13           owner or a member of the owner’s household.

14           (3) An owner of housing that is provided as a benefit of farm  
15           employment, as defined in 9 V.S.A. § 4469a(a)(3), is exempt from the  
16           registration requirements imposed in this section.

17           (d) An owner who fails to register pursuant to this section shall pay a late  
18           registration fee of \$100.00 per unit if the registration is more than 15 days late  
19           and may be subject to an administrative penalty not to exceed \$5,000.00 for  
20           each violation.

1       (e) The Department of Housing and Community Development shall  
2       maintain the registration fees collected pursuant to this section in a special  
3       fund entitled the Rental Housing Safety Special Fund, the proceeds of which  
4       the Department shall use:

5               (1) to hire authorized staff to administer the registry and registration  
6       requirements imposed in this section and in section 2478 of this title; and

7               (2) to provide funding to the Department of Public Safety to hire  
8       authorized staff to conduct inspections and regulate rental housing pursuant to  
9       20 V.S.A. chapter 173, subchapter 2.

18       subchapter 2.

19       (b) In fiscal year 2022, the amount of \$100,000.00 is appropriated from the  
20       General Fund to the Department of Public Safety as one-time startup funding

1 to hire one or more Inspector positions authorized pursuant to subsection (a) of  
2 this section.

3 (c) The Department may hire additional Inspectors authorized by this  
4 section to the extent funds become available from the Rental Housing Safety  
5 Special Fund created and maintained pursuant to 3 V.S.A. § 2479.

6 Sec. 5. DEPARTMENT OF HOUSING AND COMMUNITY  
7 DEVELOPMENT; POSITIONS

8 (a) The Department of Housing and Community Development is  
9 authorized to create one full-time classified position and one half-time  
10 classified position to administer and enforce the registry requirements created  
11 in 3 V.S.A. § 2478.

12 (b) In fiscal year 2022, the amount of \$300,000.00 is appropriated from the  
13 General Fund to the Department of Housing and Community Development as  
14 one-time startup funding to hire one or more of the positions authorized  
15 pursuant to subsection (a) of this section.

16 (c) The Department may hire additional staff authorized by this section to  
17 the extent funds become available from the Rental Housing Safety Special  
18 Fund created and maintained pursuant to 3 V.S.A. § 2479.

10           investigation;

11                           (2) enforce the provisions of this title, the rules promulgated, and

7 discovery of such violation or hazard and of any action taken by the officer.

5 PROVISIONS

6 (a) Notwithstanding any provision of law to the contrary:

7 (1) Until the Commissioner of Public Safety adopts rules governing  
8 rental housing health and safety pursuant to 20 V.S.A. § 2731, the Department  
9 of Health, local officials authorized by law, and the Department of Public  
10 Safety have concurrent authority to enforce the Vermont Rental Housing  
11 Health Code adopted by the Department of Health pursuant to 18 V.S.A.  
12 § 102, 3 V.S.A. § 3003(a), and 3 V.S.A. § 801(b)(11).

13 (2) The Commissioner of Public Safety may immediately adopt a rule  
14 incorporating the Rental Housing Health Code without following the  
15 procedures otherwise required for general rulemaking in 3 V.S.A. chapter 25.

16 (3) Except as provided in subdivision (2) of this subsection, the  
17 Commissioner of Public Safety shall comply with the requirements for general

12                   (3) a grant and loan management system that ensures accountability for

5           (e) Outreach. Recognizing that Black, Indigenous, and Persons of Color
