#### Testimony update (Bill Sheets and Bill Sorrell)

- House and Senate Government Operations
  - o S. 124
  - o VCJC as it relates to the Agency of Public Safety Concept.
    - Mid-January the Governor issued an order to create an agency of public safety.
       S-124 created the current 24 person Vermont Criminal Justice Council that operates autonomously from the Academy.
      - 1. How does the council feel about remaining generally independent and not under any wing of state Government?
      - 2. If majority view is independent, then how independent and should the Council continue to have the role of hiring an Executive Director and mid-level Directors going forward.
  - Open for questions and comments:
    - Chief Brickell Representative of Chiefs Association on Council –Supportive of Agency model because it is sustainable as functioning for the Academy, but Council should be autonomous.
    - Sheriff Mark Anderson: In my opinion, an agency model makes sense. Sheriff's Association is neutral on Agency of Public Safety except as it pertains to the Academy and the Council. Council should be memorialized in statute and retain authority. Administrative benefits being incorporated into Agency of Public Safety for budgetary and administrative purposes makes sense. We have not contemplated assignment of the Executive Director but at this point we will remain neutral. As Co-Chair for the hiring committee, while I am appreciative of the process in finding a new Executive Director, the elimination of some of the effort to bring in a new Executive Director under an agency, I think makes sense.
    - Trevor Whipple –Unanimous support of agency model specifically to funding and budget of the Academy. The philosophy of the VLCT and my opinion the Council should be working on training models up to and including the hiring of the Executive Director, who will implement those policies as designed.
    - Q&A between Interim Director Bill Sheets and Council Member Brian Searles related to budgetary advantages.
    - Council member Karen Tronsgard-Scott –A long time ago consolidation was brought up and is needed but I also think independence is necessary.

# **Council Meeting Minutes**

- Commissioner Schirling The original modernization framework conversations began 12/2019, it has always been envisioned that the Council would remain autonomous. To ensure diversity and to ensure that services that are provided to Vermonters go beyond a single Agency and retains that representative function.
- Council member Karim Chapman It is really refreshing to hear the
  overwhelming support in diversity and voices, the bigger picture is the
  community needs to know that it's not just law enforcement, but others have a
  voice in the picture.
- o Proposed language for Senate Government Operations
- o Consensus on authority of appointment of Executive Director
  - Brian Searles pertaining to Council carrying responsibility of the Executive
    Director: The person in the Executive Director chair is representative of all Law
    Enforcement in the state. It was important when speaking to the legislature to be
    viewed as independent and not controlled by any one department or agency.
  - Chief Brickell The Council being autonomous, and appointing is a healthier choice and model.
- Affirmative sentiments are representative of the council on retaining autonomous status.
   No member of the council voiced in favor of a reduced independence of the council.
