In connection with our testimony on S. 198, we offer the background information below. In addition, we have attached testimonials from seven of our agency partners as well as the annual statewide diapers and wipes budget of the Junior League of Champlain Valley Diaper Bank.

History of the JLCV Diaper Bank

The Junior League of Champlain Valley (JLCV), affiliated with the Association of Junior Leagues International (AJLI), is a group of women committed to civic leadership and promoting and perpetuating social change for Vermont communities. The geographic scope of our mission is designed to extend only to communities in the Champlain Valley region. JLCV is not practically designed to serve all counties statewide, nor would such a geographic scope be permitted by AJLI.

In 2018, JLCV established Chittenden County's first diaper bank and began distributing diapers to local food shelves from its South Burlington headquarters. In January 2019, the JLCV Diaper Bank became the first Vermont bank affiliated with the National Diaper Bank Network. **The JLCV Diaper Bank is 100% volunteer operated.**

"Diaper Need" in Vermont

"Diaper Need" impacts one in three U.S. families and the wellbeing of our country's babies and toddlers. Before the JLCV Diaper Bank was established, Burlington's Feeding Chittenden reported that 6-10 people per day requested diapers, a need that Feeding Chittenden could not meet. It can cost up to \$75 per month to diaper a child and no state or federal safety-net program allocates dollars for the purchase of diapers. Without diapers, infants and toddlers cannot attend childcare or participate in early childhood education—and without childcare, parents cannot attend work or school.

According to the National Diaper Bank Network, 43% of births in the state are covered by Medicaid. Every day in every county in Vermont, families are experiencing diaper need.

<u>JLCV Diaper Bank Furnishing Food Shelves and Parent-Child Centers With Diapers</u> Statewide

Due to the increased challenges facing families statewide due to the COVID-19 global pandemic, the JLCV Diaper Bank worked to temporarily expand its scope statewide. The volunteers of the JLCV Diaper Bank stretched themselves from a 2019 distribution of about 100,000 diapers in three counties to more than 1.3 million diapers in 13 out of 14 counties since the start of the pandemic. It became clear that the diaper need experienced in Chittenden County that inspired us to start the JLCV Diaper Bank is a perpetual problem that exists statewide.

Financial Support of the JLCV Diaper Bank

JLCV received \$50,000 in 2020 and \$82,000 in 2021 of CARES Act funding from the Vermont Legislature to support its expanded distribution statewide. The Diaper Bank has also received generous grants from The Hoehl Family Foundation, Target's Community Engagement Funds, and the Northfield Savings Bank Community Giving Program. These funds have been used to purchase, store, and distribute diapers to Vermont babies and toddlers in need across the state. In anticipation of the question, what is the cost of providing diapers statewide, we have attached a very basic spreadsheet.

However, the JLCV Diaper Bank was never built to support statewide service. By the end of this year, this additional support will be depleted, and, without intervention by the Legislature, the JLCV Diaper Bank will be forced to discontinue service beyond the Champlain Valley region and reduce the number of diapers provided to partners within that region. This will leave families served by over 60 local agencies without diapers.

S.198, An act relating to the Diaper Need Working Group

Members of JLCV have continuously networked with stakeholders to devise a solution to the problem of diaper need in Vermont. What we have learned is while all stakeholders readily agree that diaper need is an urgent problem, there is no consensus as to a solution. Possible approaches include:

- Allocating more dollars to families receiving funds through Reach-Up or WIC. For example, the State of California's CalWorks program provides \$30/month to federal grant recipients with children under 3;
- Spinning off the JLCV Diaper Bank as a separate, adequately funded non-profit that could serve counties statewide, similar to the Vermont Foodbank;
- Providing financial support to the Vermont Foodbank to utilize their distribution network to direct a diaper program; or
- A multi-pronged approach that combines elements of these.

Ideally, the stakeholders could identify and agree on one statewide solution to diaper need. Absent that consensus, however, the JLCV proposes the establishment of a working group to create space for the dialogue and further education needed to achieve a unifying recommendation to the Legislature.

Conclusion

A Diaper Need Working Group would create space for a dialogue about the best solution for diaper need in Vermont so that stakeholders can present a unified solution to the Legislature. Without legislative intervention, by the end of this year, deliveries of diapers to low-income families outside of the Champlain Valley region will end and operations in the Champlain Valley will be scaled down to pre-pandemic levels.
