RE: Extension of Expiring Act 6 COVID-Related Flexibilities

Thank you for inviting me to testify before you this morning.

Act 6 has allowed the Office of Professional Regulation (OPR) to partner in the State's COVID response, it has enabled OPR to license people who were otherwise precluded from licensure, and it has allowed for the Office to take action to protect the public from dangerous activity. Today's testimony occurs when COVID numbers are skyrocketing and the healthcare workforce is facing significant challenges. The flexibility of Act 6 is still required today and OPR is recommending a few modifications that are informed from our experience since March of 2020, Act 21 telehealth work, or changes in the regulatory landscape.
