13	than one year or fined not more than \$1,000.00, or both.
14	(c) This section shall not apply to a firearm possessed by a federal law
15	enforcement officer or a law enforcement officer certified as a law
16	enforcement officer by the Vermont Criminal Justice Training Council
17	pursuant to 20 V.S.A. § 2358, for legitimate law enforcement purposes.
18	(d) Notice of the provisions of this section shall be posted conspicuously at
19	each public entrance to each hospital.
20	(e) As used in this section:

1	(1) "Firearm" has the same meaning as in subsection 4017(d) of this

3	(2) "Hospital" has the same meaning as in 18 V.S.A. § 1902.
4	Sec. 2. CAPITOL COMPLEX SECURITY ADVISORY COMMITTEE;
5	REPORT ON FIREARMS IN STATE HOUSE
6	On or before December 1, 2021, the Capitol Complex Security Advisory
7	Committee shall report to the Joint Justice Oversight Committee on the
8	regulation of firearms in the Capitol Complex as defined in 29 V.S.A. § 182.
9	The report shall:
10	(1) summarize how the possession of firearms at the Capitol Complex is
11	currently regulated, including pursuant to Rule 26 of the Joint Rules of the
12	Senate and House of Representatives;
13	(2) describe situations when persons have impermissibly possessed
14	firearms at the Capitol Complex in the past and how these situations are
15	typically handled; and
16	(3) recommend whether and how the issue of firearms at the Capitol
17	Complex should be addressed in legislation.
18	Sec. 3. EFFECTIVE DATE
19	This act shall take effect on July 1, 2021.
20	and that after passage the title of the bill be amended to read: "An act
21	relating to prohibiting possession of firearms within hospital buildings"
