#### 2019 Implementation Report Plan

- Developed by DCF, in conjunction with the Columbia Justice Lab's Emerging Adult Justice Project to support the enacted 201 "Raise the Age" initiative.
- The Act requires DCF, in consultation with Juvenile Justice Stakeholder Agencies to submit annual status reports outlining progress of the initiative.
- DCF submitted a status report in November of 2020 which identified challenges to implementation, and general areas of needed supports.
- ▶ DCF is currently drafting the 2021 report, due for submission to the Legislature on November 1, 2021.

# Impact of COVID 19

Many service and placement resources are stretched, and with reduced capacity

Service interruption (especially residential programming)

Program staffing nationally is at unprecedented lows (both vacancy and turnover)

Limited Court Docket time

Resource reallocation (development of protocols and practices)

### Other Unplanned Challenges

- Coordination of FFPSA initiative
- New federal compliance guidance
- Judiciary data systems transition
- 18+ youths sharing resources with other juveniles
- Shifting trends in case mix, including youthful offender
