18	(a) When satisfied as to the condition and use of the vehicle, the
19	Commissioner shall issue and may revoke, for cause, permits for sirens of and
20	colored signal lamps in the following manner:

2	(2)(A) Sirens and red or red and white signal lamps may be authorized
3	for all ambulances, fire apparatus and other emergency medical service (EMS)
4	vehicles, vehicles owned or leased by a fire department, vehicles used solely in
5	rescue operations, or vehicles owned or leased by, or provided to, volunteer
6	firefighters and voluntary rescue squad members, including a vehicle owned by
7	a volunteer's employer when the volunteer has the written authorization of the
8	employer to use the vehicle for emergency fire or rescue activities.
9	(B) One blue signal lamp may be authorized for all EMS vehicles or
10	vehicles owned or leased by a fire department, provided that the Commissioner
11	shall require the lamp be mounted so as to be visible primarily from the rear of
12	the vehicle and only used when the vehicle is parked.
13	(3) No vehicle may be authorized a permit for more than one of the
14	combinations described in subdivisions (1) and (2) of this subsection.

18	§ 1255. EXCEPTIONS
19	(a) The provisions of section 1251 of this title shall not apply to directional

signal lamps of a type approved by the Commissioner of Motor Vehicles.

Sec. 3. EFFECTIVE DATE

This act shall take effect on July 1, 2021.

(b) All persons with motor vehicles equipped as provided in subdivisions 1252(a)(1) and (2) of this title shall use the sirens or colored signal lamps, or both, only in the direct performance of their official duties. When any person other than a law enforcement officer is operating a motor vehicle equipped as provided in subdivision 1252(a)(1) of this title, the colored signal lamps shall be either removed, covered, or hooded. When any person, other than an authorized ambulance emergency medical service vehicle operator, firefighter, or authorized operator of vehicles used in rescue operation operations is operating a motor vehicle equipped as provided in subdivision 1252(a)(2) of this title, the colored signal lamps shall be either removed, covered, or hooded unless the operator holds a senior operator license.
