20	previous quarter that qualifies as a paid breakfast under the federal school
21	breakfast program or as a paid lunch under the federal school lunch program.

1	(B) The reimbursement amount shall be a sum equal to the federal
2	reimbursement rate for a free school breakfast or lunch less the federal
3	reimbursement rate for a paid school breakfast or lunch, using rates identified
4	annually by the Agency of Education from payment levels established annually
5	by the U.S. Department of Agriculture. These rates shall include performance-
6	based cash reimbursement as determined by the U.S. Department of
7	Agriculture.
8	(C) Notwithstanding subsection 4025(d) of this title, reimbursement
9	amounts paid under this subdivision (2) shall be paid from the Education Fund
