About Farm Share

Now entering its 27th year, the NOFA-VT Farm Share program provides low income Vermonters (185% FPL) with subsidized CSA shares, while ensuring the farm receives the full cost of the share. In prior years, the participants have paid 50% of the share cost and the other 50% of the cost is split between NOFA-VT and the participating farms who solicit donations from their communities. Participants may pay their portion of the share using 3SquaresVT benefits and can often set up payment installments with most farms. We typically have about 50 participating farms. They are paid for the full value of their crops and are able to serve low income community members for whom the full cost of a CSA share is prohibitive. In this way, the Farm Share Program supports both food security and farm viability.

Previously, NOFA-VT has raised funds through a statewide fundraising event with restaurant partners called *Share The Harvest*, as well as through small grants and donations from our membership. In 2020, the *Share the Harvest* revenue was dramatically reduced because of the economic hardship faced by so many of our restaurant partners. However, in response to the COVID-19 pandemic, we received a subgrant of \$75,000 in CARES Act funds from the Vermont Foodbank. This allowed us to not only make up for the lost revenue from our traditional fundraising program, but we were also able to scale the program up at a time of significantly heightened food insecurity, increasing the number of fall and winter shares by 86% and the number of individuals served by 85%. The additional funds allowed us to eliminate the farm match for our fall season and increase participation by 200% compared to the fall season in 2019.

A \$75,000 appropriation would allow us to more than double the number of subsidized shares we can offer, and expand the number of participating farms compared to what we project we will be able to do for 2021. This means NOFA-VT could serve 1404 Vermonters versus 630. The \$75,000 we are requesting would translate into \$251,000 in revenue for small farmers in Vermont. We know from decades of experience that Farm Share participants increase their consumption of fresh fruits and vegetables, feel more connected to their communities and save scarce income to be spent on other necessities. We hope the legislature will invest in our small farms and our low income neighbors.
