



Some Basics:

- "Entrepreneurs Seed Capital Fund" formed during 2008-9 financial crises in response to acute risk capital needs and to enable faster recovery.
- Competitive RFP process by VEDA that selected VCET team & organization.
- One time funds created an evergreen Fund as "Capital Infrastructure"
- Investors:
 - VEDA / State: \$4.13 M (ARRA and one time special funds)
 - VCET: <u>\$1.00 M</u> (HUD-EDI)
 - Capitalization: \$5.13 M







Why Recapitalization Matters Today

- Vermont's business model is ENTREPRENEURSHIP and the personal income taxes generated to support our state. We must support more!
- Acute startup equity need in Vermont exacerbated by COVID
 - Identified +/- 100 capital seekers
 - All sectors, types and locations
 - First time founders and first outside capital dried up in large part
 - Pulled Term Sheets, Predatory pricing/terms and Angels hesitant
 - State Economic Recovery Grants not accessible to many
- Fund impacted by two expected returns delay in 2020 from COVID.
- Demand is for \$500k to \$1 million a year forward. Not all get \$.
- The Ask: Invest one time state resources into high potential companies, teams and new high income jobs in front of us today via recapitalization.
- Supporters include: VTTA, LCRCC, VEDA, VT Technology Council and 300 Recapitalization Petitioners (Sept 2020) and dozens of startup founders.

Fund Impact Objectives

1. Returns to Revolve the Fund

- Goal: 16 Results: 23 so far
- Cumulative IRR: -2.3% (management fee + legal)

2. Capital Leverage

- Goal: 2x Results: 7x initially, 42x lifetime
- \$4.3M invested leveraged into \$183 million

3. Payroll Impacts

- Goal: >150 Results: 284
- \$68,000 VT salary average; \$125 million in payroll (all offices)

4. Other Factors

- Energy sector, synergy with Higher Education, supports natural resources, support underrepresented founders, etc
- 35% female owner / executive. 9% BIPOC including 2 of last 4 fundings
