Budget Adjustment: Fiscal Year 2022

Overview

- Budget Adjustment Act increases unduplicated appropriations by \$358.6 million, which is 4.9% over the budget passed in May.
- Reflects one-time General Funds currently available in the FY 2022 forecast, appropriating an additional \$113 million.
- Bill allocates \$106.3 million more in ARPA State Fiscal Recovery (SFR) funds.
- Federal matching funds in Medicaid and other smaller special funds adjustments make up the balance of the total increase.

Refresher:

- Act 9 was the COVID Relief Bill and Act 74 was the "Big Bill" as passed for FY2022.
- Act 9 was passed in addition to Act 74 last year and the Budget Adjustment bill this year is in addition to Act 74.

G. 400 Housing and Homelessness Related Investments – House Highlights

- House proposal provides \$25 million ARRA-SFR funds and \$30 million GF increase for VHCB to provide housing and increase shelter capacity. GF is intended to maximize federal low-income housing tax credits. This in total is \$5 million over the Governor's \$50 million BAA proposal which was entirely in ARPA-SFR funds.
- House concurs with recommendation to add \$20 million to the Vermont Housing Improvement Program VHIP.
- House declined to provide funding at this time to VHFA 'Missing Middle' home builder program. This \$5 million of ARPA-SFR was redirected to VHCB in House proposal.
- Total Housing investment increase in BAA is \$75 million from all funds



G.300 Investments in Vermont's Economy, Workforce and Communities – House Highlights

ARPA State Fiscal Funding

- +\$12.8 million funding for VDOL Unemployment Insurance program expenses.
 - Previously recommended by the Governor using GF dollars in section B.400. This is on top of \$5.5 million provided through CRF funds in the Summer/Fall of 2021
- +\$7.35 million for Vermont State Colleges critical occupations scholarship which funds them through second year.
 - Funds scholarships through second year.
 - Governor's recommendation was for \$2.4 million which covered the second semester of this year since the \$5 million initial allocation was over subscribed.



G.300 Investments in Vermont's Economy, Workforce and Communities – House Highlights continued...

ARPA State Fiscal Funding

- +\$1 million for up to two free classes in a calendar year at UVM for VT residents seeking a transition to a new career or to enhance job skills.
- +\$500,000 for three public independent career technical education centers.
- +\$6 million in retention payments for Childcare workforce.

Other: \$60 million Healthcare and social service retention program. \$26 million from ARPA funds, \$16 million from Medicaid GCF and \$18 million in HCBS Federal funding increase funds.



Miscellaneous One-time Appropriations – House Highlights

- General Fund:
 - +\$250,000 to ACCD for Municipal Planning Grants.
