1	TO THE HONORABLE SENATE:
2	The Committee on Education to which was referred House Bill No. 703
3	entitled "An act relating to promoting workforce development" respectfully
4	reports that it has considered the same and recommends that the Senate
5	propose to the House that the bill be amended as follows:
6	Sec. 1. PURPOSE; IMPLEMENTATION
7	(a) The purpose of this act is to expand opportunities for workforce
8	education, training, and development for Vermonters and to make meaningful
9	investments to support and expand the workforce across the State.
10	(b) It is the intent of the General Assembly that each recipient of funding
11	through this act shall conduct significant outreach to ensure that all
12	Vermonters, and particularly populations that have experienced unequal acces
13	to public or private economic benefits due to geography, socioeconomic status
14	disability status, gender or gender identity, age, immigration or refugee status,
15	or race, have the opportunity to benefit from the financial and programmatic
16	benefits made available through this act.
17	Sec. 1a. IMMEDIATE STRATEGIES AND FUNDING FOR EXPANDING
18	THE LABOR FORCE; INCREASING THE NUMBER OF
19	PARTICIPANTS AND PARTICIPATION RATES;
20	APPROPRIATIONS

1	(a) In fiscal year 2023, the following amounts are appropriated from the
2	General Fund to the following recipients for the purposes specified:
3	(1) \$2,500,000.00 to the University of Vermont Office of Engagement,
4	in consultation with the Vermont Student Assistance Corporation, to
5	administer a statewide forgivable loan program of \$5,000.00 per graduate for
6	recent college graduates across all Vermont higher education institutions who
7	commit to work in Vermont for two years after graduation.
8	(2) \$387,000.00 to Vermont Technical College to develop a skilled meat
9	cutter training and apprenticeship facility.
10	(b) In fiscal year 2023, the amount of \$500,000.00 is appropriated from the
11	American Rescue Plan Act (ARPA) – Coronavirus State Fiscal Recovery
12	Funds to the Agency of Human Services to provide grants, which may be
13	administered through a performance-based contract, to refugee- or New
14	American-focused programs working in Vermont to support increased in-
15	migration or retention of recent arrivals.
16	Sec. 1b. MENTAL HEALTH AND SUBSTANCE USE DISORDER
17	TREATMENT PROFESSIONALS; HIGHER EDUCATION;
18	CONTINUING EDUCATION CREDITS
19	(a) In order to increase the supply of mental health and substance use
20	disorder treatment professionals in Vermont, the Office of Professional
21	Regulation, in coordination with public and private institutions of higher

1	education in this State, shall identify new and existing educational
2	opportunities available to certified alcohol and drug counselors and apprentice
3	addiction professionals, completion of which could provide both continuing
4	education credits toward the requirements of their current professions and
5	credits toward the course requirements for attaining an advanced degree in the
6	field of mental health or of substance use disorder treatment, or both.
7	(b) On or before January 15, 2023, the Office of Professional Regulation
8	shall report to the House Committees on Health Care, on Human Services, on
9	Education, and on Government Operations and the Senate Committees on
10	Health and Welfare, on Education, and on Government Operations on the
11	opportunities identified pursuant to subsection (a) of this section and any new
12	programs to be established as a result.
13	Sec. 1c. AGENCY OF HUMAN SERVICES; EMPLOYEE EDUCATION
14	PROGRAMS
15	On or before January 15, 2023, the Agency of Human Services shall
16	catalogue all educational programs and opportunities it makes available to its
17	employees, including identifying which programs and opportunities are offered
18	to which employees, and report those findings to the House Committees on
19	Health Care and on Human Services and the Senate Committee on Health and
20	Welfare.

2	Sec. 3. FUNDING AND GOVERNANCE STRUCTURES OF
3	CAREER TECHNICAL EDUCATION IN VERMONT
4	(a) There is appropriated to the Joint Fiscal Office Agency of Education for
5	fiscal year 2023 the amount of \$180,000.00 from the General Fund to contract
6	for services to:
7	(1) complete a systematic examination of the existing funding structures
8	of career technical education (CTE) in Vermont and how these structures
9	impede or promote the State's educational and workforce development goals;
10	(2) examine CTE governance structures in relationship to those funding
11	structures;
12	(3) examine the implications of the existing funding and governance
13	structures for kindergarten through grade 12 schools and adult education;
14	(4) examine the funding and alignment of early college and dual
15	enrollment;
16	(5) consider the CTE funding and governance structures in other states
17	in relation to Vermont's unique system of funding education; and
18	(6) identify and prioritize potential new models of CTE funding and
19	governance structures to reduce barriers to enrollment and to improve the
20	quality, duration, impact, and access to CTE statewide.

1	(b) In performing its work, the contractor shall consult with the consultant
2	and any other stakeholders involved in completing the report on the design,
3	implementation, and costs of an integrated and coherent adult basic education,
4	adult secondary education, and postsecondary career and technical education
5	system pursuant to 2021 Acts and Resolves No. 74, Sec. H.3.
6	(c) On or before March 1, 2023, the Joint Fiscal Office Agency of
7	Education shall issue a written report to the House and Senate Committees on
8	Education, the House Committee on Commerce and Economic Development,
9	the Senate Committee on Economic Development, Housing and General
10	Affairs, the House Committee on Ways and Means, and the Senate Committee
11	on Finance on the work performed pursuant to subsection (a) of this section.
12	(d)(1) The Agency of Education shall consider the work performed by the
13	contractor and report issued pursuant to subsection (c) of this section and shall
14	develop an implementation plan, including recommended steps to design and
15	implement new funding and governance models.
16	(2) On or before July 1, 2023, the Agency shall issue a written report to
17	the House and Senate Committees on Education, the House Committee on
18	Commerce and Economic Development, the Senate Committee on Economic
19	Development, Housing and General Affairs, the House Committee on Ways
20	and Means, and the Senate Committee on Finance that describes the results of

1	its work under this subsection and the implementation plan and makes
2	recommendations for legislative action.
3	* * *
4	[Sec. 4a]. EDUCATOR WORKFORCE DEVELOPMENT;
5	APPROPRIATION; REPORT
6	(a) Purpose. The purpose of this section is to encourage and support the
7	development and retention of qualified and effective Vermont educators. To
8	combat the growing educator shortage throughout the State and meet the needs
9	of Vermont students, it is necessary to invest in nontraditional educator
10	training programs.
11	(b) Grant program.
12	(1) Program creation. In fiscal year 2023, there is established the Peer
13	Review Support Grant Program, to be administered by the Agency of
14	Education, to provide grants to expand support, mentoring, and professional
15	development to prospective educators seeking licensure through the Agency of
16	Education's peer review process, with the goal of increased program
17	completion rates.
18	(2) Program administration. The Agency shall adopt policies,
19	procedures, and guidelines necessary for implementation of the Program
20	described in subdivision (1) of this subsection.

1	(3) Eligibility criteria. The Agency shall issue grants to organizations or
2	school districts with programs designed to provide prospective educators in the
3	peer review program the support necessary for successful completion of the
4	peer review process by providing:
5	(A) support through the Praxis exam process;
6	(B) local educator lead seminars designed around the Vermont
7	licensure portfolio themes;
8	(C) local educator mentors;
9	(D) support in completing the peer review portfolio and licensing
10	process; and
11	(E) continued professional development support within the first year
12	of licensure.
13	(4) Report. On or before January 15, 2023, the Agency of Education
14	shall report to the Senate and House Committees on Education on the status of
15	the implementation of the Peer Review Support Grant Program and a summary
16	and performance review of the programs to which grants were awarded. The
17	report shall include any metrics used in the performance review, the number of
18	program participants, endorsement areas of participants, feedback from
19	participants and mentors, and any recommendation for legislative action.
20	(c) Appropriation. Notwithstanding 16 V.S.A. § 4025(d), the sum of
21	\$712,500.00 is appropriated from the Education Fund to the Agency of

1	Education in fiscal year 2023 for the purpose of funding the Peer Review
2	Support Grant Program.
3	* * *
4	Sec. 16. CTE CONSTRUCTION AND REHABILITATION
5	EXPERIENTIAL LEARNING PROGRAM; REVOLVING LOAN
6	FUND
7	(a) Purpose. This section authorizes and provides funding for the CTE
8	Construction and Rehabilitation Experiential Learning Program and Revolving
9	Loan Fund, the purposes of which are to:
10	(1) expand the experiential and educational opportunities for high school
11	and adult CTE students to work directly on construction projects;
12	(2) build community partnerships among CTE centers, housing
13	organizations, government, and private businesses;
14	(3) beautify communities and rehabilitate buildings that are
15	underperforming assets;
16	(4) expand housing access to Vermonters in communities throughout the
17	State; and
18	(5) improve property values while teaching high school and adult
19	students trade skills.
20	(b) Appropriation; creation of fund; administration.

1	(1) In fiscal year 2023, the amount of \$15,000,000.00 is appropriated
2	from the Education Fund to the Vermont Housing and Conservation Board to
3	create and administer the CTE Construction and Rehabilitation Experiential
4	Learning Program and Revolving Loan Fund pursuant to this section.
5	(2) The Board may use not more than five percent of the Fund for its
6	costs of administration.
7	(c) Proposals; applications; funding.
8	(1) A regional CTE center, working in collaboration with one or more
9	housing and community partners, private businesses, nonprofit organizations,
10	or municipalities, shall identify construction projects that would be relevant
11	and appropriate for CTE students enrolled in construction, electrical,
12	plumbing, design, business management, or other CTE programs, including:
13	(A) rehabilitation of residential properties that are blighted or not
14	code-compliant;
15	(B) new residential construction projects or improvements to land in
16	cases of critical community need; and
17	(C) commercial construction projects that have substantial
18	community benefit.
19	(2) Prior to or during the application process, a CTE center and its
20	partners may shall consult with the Board and other organizations to identify

1	and consider potential funding partners to leverage amounts available through
2	the Fund.
3	(3) A CTE center and its partners shall apply to the Board for funding
4	by submitting a project application that includes the information required by
5	the Board and addresses the following:
6	(A) the educational benefits for students and fit with the CTE
7	curriculum;
8	(B) the community benefits for the neighborhood, municipality, or
9	region in which the project is located; and
10	(C) the partners with whom the CTE center is collaborating and the
11	respective responsibility for the aspects of a project, including:
12	(i) educational instruction and academic credit;
13	(ii) project management;
14	(iii) insurance coverage for students and the property;
15	(iv) compensation and benefits, including compliance with labor
16	laws, standards, and practices; and
17	(v) property acquisition, ownership, and transfer.
18	(4) A CTE center may use funding for, and shall specify in its
19	application the allocation of costs associated with:
20	(A) acquisition, design, permitting, construction, marketing, and
21	other building-related expenses; and

1	(B) costs for labor, including for student wages and for instructor
2	compensation during the academic year as well as for summer or other work
3	that is not otherwise budgeted during the academic year.
4	(d) Eligibility; review; approval. The Board may approve an application
5	that includes the information required by subsection (c) of this section and
6	provide funding for a project that meets the following eligibility criteria:
7	(1) The project involves the rehabilitation of one of the following types
8	of property that require repair and improvement:
9	(A) blighted or otherwise non-code compliant residential property
10	that results in a building with not more than four dwelling units that are
11	affordable to seniors, households with lower income, or other communities that
12	need access to affordable housing;
13	(B) municipal facilities; or
14	(C) school buildings or related educational facilities
15	(D) commercial construction projects that have substantial
16	community benefit.
17	or new residential construction projects or improvements to land in
18	cases of critical need,
19	(2) The project includes a weatherization component.
20	(3) Students working on the project receive academic credit, a
21	competitive wage, or both.

1	(e) Affordability; flexibility. If appropriate in the circumstances, the Board
2	may shall condition funding for a project on the inclusion of one or
3	mechanisms addressing the affordability of the property upon rent or sale.
4	(f) Funding; proceeds; revolving loans.
5	(1) The Board shall provide funding for projects from the amounts
6	available in the Fund in the form of zero-interest loans, in an amount, for a
7	period, and upon terms specified by the Board.
8	(2) If a completed project results in a gain for a CTE Center, upon the
9	sale or transfer of a completed project, or upon completion of any
10	rehabilitation work, the CTE Center shall return any loan proceeds and any
11	profits realized to the Board to provide funding for future projects through the
12	Fund.
13	(3) If a completed project results in a loss for the CTE Center, upon the
14	sale or transfer of a completed project, or upon completion of any
15	rehabilitation work, the Board shall hold the CTE Center harmless for the
16	amount of the loss and the CTE Center shall return any remaining loan funds
17	to the Board to provide funding for future projects through the Fund.
18	(g) Report. The Board shall address the implementation of this section in
19	its annual report to the General Assembly.
