10	The Department of Mental Health, in consultation with the Agencies of

12	inventory all mental health crisis response programs that utilize State funds.	
13	On or before January 15, 2023, the Department shall submit the inventory to	
14	the House Committee on Health Care and to the Senate Committee on Health	
15	and Welfare.

18	Sec. 2. GRANTS TO EXPAND MENTAL HEALTH SERVICES TO	
19	YOUTH IN <mark>SCHOOL AND</mark> AFTERSCHOOL PROGRAMMING	
20	(a) In fiscal year 2023, \$4,000,000.00 is appropriated from the federal	
21	Elementary and Secondary School Emergency Relief Fund (ESSER Fund) to	

1	the Agency of Education, which shall work collaboratively with the
2	Department of Mental Health, to establish and administer a two-year program
3	that ensures continuous support to children and youth in school and afterschool
4	settings by providing grants to:
5	(1) expand existing school-based counseling services provided by
6	designated and specialized service agencies in underserved districts of the
7	State;
8	(2) develop either school-based or community-based afterschool
9	programs, operating in a variety of settings outside the school day and over the
10	summer, including before and after school, in-service days, and school
11	vacation week, that support the mental health and wellness needs of students,
12	families, and staff.
13	(b) The Agency shall adopt policies, procedures, and guidelines necessary
14	for implementation of the program described in subsection (a) of this section.
15	(c) The Agency shall issue grants to in-school counseling programs and
16	afterschool programs in geographically diverse regions on a first-come, first-
17	served basis until funds are depleted when the applicant meets all of the
18	eligibility criteria listed in subdivision (1) of this subsection and at least one
19	eligibility criterion listed in subdivision (2) of this subsection:
20	(1) Mandatory eligibility criteria.

1	(A) The applicant uses evidence-based strategies to address students'
2	social, emotional, mental health, and wellness needs.
3	(B) The applicant collects data to demonstrate the effectiveness of the
4	mental health and wellness supports and interventions utilized in the program.
5	(C) The applicant connects to and aligns with statewide initiatives,
6	including Building Flourishing Communities, Youth Thrive, and the Vermont
7	Youth Project.
8	(2) Additional eligibility criterion.
9	(A) The applicant works in close partnership with classroom teachers
10	and school guidance counselors to coordinate supports, communication, and
11	strategies.
12	(B) The applicant uses specially trained staff to provide one-on-one
13	and small group supports and resilience sessions for children and youth,
14	including addressing specific needs, such as suicide prevention, social
15	isolation, anxiety, and substance use.
16	(C) The applicant provides participating families with assistance in
17	navigating behavioral health resources in their communities.
18	(D) The applicant provides opportunities for children and youth to
19	participate in activities that heal and prevent social isolation, such as outdoor
20	activities, art therapy, recreation, and time in nature.

1	(E) The applicant consults with local pediatricians to provide	
2	referrals for support.	
3	(F) The applicant provides staff training on Youth Mental Health	
4	First Aid and other evidence-based techniques and approaches to crisis	
5	prevention and intervention, such as trauma-responsive practices, adolescent	
6	brain development, and how to build a culture of connection.	
7	(d) On or before January 15, 2025, the Agency, in collaboration with the	
8	Department, shall submit a report to the House Committees on Education and	
9	on Human Services and to the Senate Committees on Education and on Health	
10	and Welfare summarizing the afterschool programs to which grants were	
11	awarded and recommending a model for the integration of mental health and	
12	in-school and afterschool programming that provides consistency and	
13	reliability to children and youth, is fiscally sustainable, and does not create	
14	further workforce capacity challenges for afterschool organizations, the	
15	Agency, or the Department.	
16	Sec. 3. VERMONT INTERAGENCY AFTERSCHOOL YOUTH TASK	
17	FORCE; REPORTING	
18	The Vermont Interagency Afterschool Youth Task Force established	
19	pursuant to Executive Order No. 08-21 shall submit to the House Committees	
20	on Education and on Human Services and to the Senate Committees on	
21	Education and on Health and Welfare copies of its bimonthly progress reports	

1	on achieving expanded universal afterschool and	d summer programming. The	
2	Task Force shall also provide advice and recommendations to the General		
3	Assembly upon request.
