**Overview.** The technical corrections in this bill include:

- correcting grammar and typographical errors;
- formatting lists;
- making changes for consistency and to conform to Vermont Statutes Annotated (V.S.A.) style;
- eliminating legalese and gendered pronouns and removing language reflecting repealed provisions of Vermont law;
- correcting references, including cross-references to repealed or recodified laws;
- updating and correcting names of public entities and officers; and
- correcting terminology for administrative rulemaking.
