

1 TO THE HONORABLE SENATE:

2 The Committee on Judiciary to which was referred Senate Bill No. 7
3 entitled “An act relating to expanding access to expungement and sealing of
4 criminal history records” respectfully reports that it has considered the same
5 and recommends that the bill be amended by striking out all after the enacting
6 clause and inserting in lieu thereof the following:

16 § 7602. EXPUNGEMENT AND SEALING OF RECORD,
17 POSTCONVICTION; PROCEDURE

18 (a)(1) A person may file a petition with the court requesting expungement
19 or sealing of the criminal history record related to the conviction if:

20 (A) the person was convicted of a qualifying crime or qualifying
21 crimes arising out of the same incident or occurrence;

1 (B) the person was convicted of an offense for which the underlying
2 conduct is no longer prohibited by law or designated as a criminal offense;

3 (C) pursuant to the conditions set forth in subsection (g) of this
4 section, the person was convicted of a violation of 23 V.S.A. § 1201(a) related
5 to operating under the influence of alcohol or other substance, excluding a
6 violation of that section resulting in serious bodily injury or death to any
7 person other than the operator, or related to operating a school bus with a blood
8 alcohol concentration of 0.02 or more or operating a commercial vehicle with a
9 blood alcohol concentration of 0.04 or more; or

10 (D) pursuant to the conditions set forth in subsection (h) of this

9 would not be in the interests of justice, the court shall grant the petition and
10 order that the criminal history record be expunged or sealed in accordance with
11 section 7606 or 7607 of this title if the following conditions are met:

12 (1) At least 15 years have elapsed since the date on which the person
13 ~~successfully completed the terms and conditions of the sentence~~ satisfied the
14 judgment for the conviction, or the person has ~~successfully~~ completed the
15 ~~terms and conditions~~ of an indeterminate term of probation that commenced at

3 (i) Qualifying felony property offenses and selling, dispensing, or
4 transporting regulated substances offenses. For petitions filed to expunge or
5 seal a criminal history record of a qualifying felony property offense or a
6 violation of 18 V.S.A. § 4230(b), 4231(b), 4232(b), 4233(b), 4234(b),
7 4234a(b), 4234b(b), 4235(c), or 4235a(b):

8 (1) The court shall grant the petition and order that the criminal history
9 record be sealed pursuant to section 7607 of this title if the following
10 conditions are met:

11 (A) At least eight years have elapsed since:

12 (i) the date on which the person satisfied the judgment for the
13 conviction; or

14 (ii) if the person committed a subsequent offense, the date on
15 which the person satisfied the judgment for the subsequent offense, whichever
16 is later.

17 (B) Any restitution ordered by the court for any crime of which the
18 person has been convicted has been paid in full.

19 (C) After considering the particular nature of any subsequent offense,
20 the court finds that expungement of the criminal history record for the
21 qualifying crime serves the interests of justice.

1 (2) A criminal history record sealed pursuant to this subsection (i) shall
2 be eligible for expungement pursuant to section 7606 of this title eight years
3 after the date on which sealing order is issued if the person ~~does not commit~~
4 any criminal offense subsequent to the sealed offense is not convicted of a
5 subsequent offense listed in 13 V.S.A. § 5301(7) within the 7 years prior to
6 petitioning for expungement or has not been convicted of an offense not listed
7 in 13 V.S.A. § 5301(7) within 3 years of petitioning for expungement.

8 (3) If the respondent stipulates to a petition filed prior to, on, or after the
9 date the offense is eligible for sealing as provided in this subsection, the court
10 may grant the petition to seal or expunge without a hearing.

11 (j) Qualifying felonies. For petitions filed to expunge or seal a criminal
12 history record of any other qualifying felony offense not specified in
13 subsection (f), (h), or (i) of this section:

14 (1) The court shall grant the petition and order that the criminal history
15 record be sealed pursuant to section 7607 of this title if the following
16 conditions are met:

17 (A) At least 10 years have elapsed since the date on which the person
18 satisfied the judgment for the conviction or, if the person committed a
19 subsequent offense, 10 years from the date on which the person satisfied the
20 judgment for the subsequent offense, whichever is later.

1 (B) Any restitution ordered by the court for any crime of which the
2 person has been convicted has been paid in full.

3 (2) A criminal history record sealed pursuant to this subsection (j) shall
4 not be eligible for expungement pursuant to section 7606 of this title unless the
5 respondent stipulates to the expungement.

6 (3) If the respondent stipulates to a petition to seal filed prior to, on, or
7 after the date the offense is eligible for sealing as provided in this subsection,
8 the court may grant the petition to seal without a hearing.

9 Sec. X. 13 V.S.A. § 7607 is amended to read:

10 § 7607. EFFECT OF SEALING

11 (a) Order and notice. Upon entry of an order to seal, the order shall be
12 legally effective immediately and the person whose record is sealed shall be
13 treated in all respects as if he or she had never been arrested, convicted, or
14 sentenced for the offense and that its effect is to annul the record of arrest,
15 conviction, and sentence. The court shall provide notice of the sealing to the
16 respondent, Vermont Crime Information Center (VCIC), the arresting agency,
17 and any other entity that may have a record related to the order to seal. The
18 court shall also make a reasonable effort to notify the person whose record is
19 sealed that, pursuant to section 7602 of this title, they may be eligible for a
20 subsequent expungement after a required waiting period. “Reasonable effort”
21 means attempting to contact the person by first-class mail at the person’s last

1 known address and by telephone at the person's last known phone number.

2 The VCIC shall provide notice of the sealing to the Federal Bureau of
3 Investigation's National Crime Information Center.

6 § 5119. SEALING OF RECORDS

7 * * *

8 (e)(1) Except as provided in subdivision (2) of this subsection, upon the
9 entry of an order sealing such files and records under this section, the
10 proceedings in the matter ~~under this act~~ shall be considered never to have
11 occurred, all general index references ~~thereto~~ to the sealed record shall be
12 deleted, and the person, the court, and law enforcement officers and
13 departments shall reply to any request for information that no record exists
14 with respect to such person upon inquiry in any matter. Copies of the order
15 shall be sent to each agency or official named in the order.

16 (2)(A) Any court, agency, or department that seals a record pursuant to
17 an order under this section may keep a special index of files and records that
18 have been sealed. This index shall only list the name and date of birth of the
19 subject of the sealed files and records and the docket number of the proceeding
20 which was the subject of the sealing. The special index shall be confidential

1 and may be accessed only for purposes for which a department or agency may
2 request to unseal a file or record pursuant to subsection (f) of this section.

3 (B) Access to the special index shall be restricted to the following
4 persons:

5 (i) the commissioner and general counsel of any administrative
6 department;

7 (ii) the secretary and general counsel of any administrative agency;

8 (iii) a sheriff;

9 (iv) a police chief;

10 (v) a State's Attorney;

11 (vi) the Attorney General;

12 (vii) the Director of the Vermont Crime Information Center; and

13 (viii) a designated clerical staff person in each office identified in

14 § 2303. EXPUNGEMENT OF VIOLATION RECORDS

15 (a) Automatic expungement. The Judicial Bureau shall automatically enter
16 an expungement order for convictions or adjudications of the following
17 violations on the two-year anniversary of the satisfaction of the judgment:

18 (1) section 301 of this title (operating an unregistered vehicle);

19 (2) subsection 307(a) of this title (failing to possess registration);

20 (3) section 611 of this title (failing to possess license);

21 (4) subsection 676(a) of this title (operating after suspension);

1 (5) section 601 of this title (operating without a license);

2 (6) section 800 of this title (operating without insurance); and

3 (7) subsection 1222(c) of this title (operating an uninspected vehicle).

4 (b) Effect of expungement.

5 (1) Upon entry of an expungement order, the order shall be legally
6 effective immediately and the individual whose record is expunged shall be
7 treated in all respects as if he or she had never been convicted or adjudicated of
8 the violation. This includes the expungement of any points accumulated
9 pursuant to chapter 25 of this title.

10 (2) The Judicial Bureau shall report the expungement to the Department
11 of Motor Vehicles within 14 days.

12 (3) The Judicial Bureau shall keep a special index of cases that have
13 been expunged together with the expungement order. The index shall list only
14 the name of the individual convicted or adjudicated of the violation, his or her
15 date of birth, the docket number, and the violation that was the subject of the
16 expungement. All other court documents and records that are subject to an
17 expungement order, whether held by the Judicial Bureau or the Department of
18 Motor Vehicles, shall be destroyed.

19 (4) Upon receiving an inquiry from any person regarding an expunged
20 record, the Judicial Bureau and Department of Motor Vehicles shall respond
21 that “NO RECORD EXISTS.”
