7	Statement of purpose of bill as introduced: This bill proposes to regulate
8	surface water withdrawals and interbasin transfers of surface water occurring
9	in the State.
10	An act relating to surface water withdrawals and interbasin transfers
11	It is hereby enacted by the General Assembly of the State of Vermont:
12	Sec. 1. 10 V.S.A. chapter 41 is amended to read:
13	CHAPTER 41. REGULATION OF STREAM FLOW
14	* * *
15	§ 1002. DEFINITIONS
16	Wherever used or referred to in this chapter, unless a different meaning
17	clearly appears from the context:
18	(1) "Artificial regulation of stream flow" means the intermittent or
19	periodic manipulation of water levels and the intermittent or periodic
20	regulation of discharge of water into the stream below the dam.

1	(2) "Banks" means that land area immediately adjacent to the bed of the
2	stream, which is essential in maintaining the integrity thereof.
3	(3) "Basin" means the third-level, 6-digit unit of the hydrologic unit
4	hierarchy as defined by the U.S. Geological Survey (USGS), Federal Standards
5	and Procedures for the National Watershed Boundary Dataset, Chapter 3 of
6	Section A, Book 11. "Basin" is also referred to as "Hydrologic Unit Code 6"
7	or "HUC-6."
8	(4) "Bed" means the maximum area covered by waters of the stream for
9	not less than 15 consecutive days in one year.
10	(5) "Berm" means a linear fill of earthen material on or adjacent to the
11	bank of a watercourse that constrains waters from entering a flood hazard area
12	or river corridor, as those terms are defined in subdivisions 752(3) and (11) of
13	this title.
14	(4)(6) "Board" means the Natural Resources Board.
15	(7) "Capacity" means the maximum volume of water capable of being
16	withdrawn by the water withdrawal system.
17	(5)(8) "Cross section" means the entire channel to the top of the banks.
18	(6)(9) "Dam" applies to any artificial structure on a stream, or at the
19	outlet of a pond or lake, that is utilized for holding back water by ponding or
20	storage together with any penstock, flume, piping, or other facility for
21	transmitting water downstream to a point of discharge, or for diverting water
22	from the natural watercourse to another point for utilization or storage.

1	(7)(10) "Department" means the Department of Environmental
2	Conservation.
3	(8)(11) "Existing surface withdrawal" means a surface water withdrawal
4	that exists prior to January 1, 2023.
5	(12) "Frequency" means how often water will be withdrawn from a
6	surface water over a period of time.
7	(13) "Instream material" means:
8	(A) all gradations of sediment from silt to boulders;
9	(B) ledge rock; or
10	(C) large woody debris in the bed of a watercourse or within the
11	banks of a watercourse.
12	(14) "Interbasin transfer" means the conveyance of surface water
13	withdrawn from a basin for use in another basin.
14	(15) "Large woody debris" means any piece of wood within a
15	watercourse with a diameter of 10 or more inches and a length of 10 or more
16	feet that is detached from the soil where it grew.
17	(9)(16) "Person" means any individual; partnership; company;
18	corporation; association; unincorporated association; joint venture; trust;
19	municipality; the State of Vermont or any agency, department, or subdivision
20	of the State; any federal agency; or any other legal or commercial entity.
21	(17) "Rate of withdrawal" means the volume of surface water that is
22	withdrawn over a period of time, as reported in gallons per minute.

1	(18) "Reasonable and feasible" means available and capable of being
2	implemented after consideration of cost, existing technology, logistics in light
3	of the overall project purpose, environmental impact, and ability to obtain all
4	necessary approvals for implementation.
5	(11)(19) "Secretary" means the Secretary of Natural Resources, or the
6	Secretary's duly authorized representative.
7	(20) "Surface water" means all rivers, streams, creeks, brooks,
8	reservoirs, ponds, lakes, springs, and all bodies of surface waters that are
9	contained within, flow through, or border upon the State or any portion of it.
10	"Surface water" does not include the following:
11	(A) groundwater as defined in section 1391 of this title;
12	(B) artificial waterbodies as defined under section 29A-101(d) of the
13	Vermont Water Quality Standards;
14	(C) waste treatment systems, including waste management systems
15	constructed as part of a best management practice approved under 6 V.S.A.
16	chapter 215;
17	(D) treatment ponds, lagoons, or wetlands created solely to meet the
18	requirements of a permit issued for a discharge; and
19	(E) constructed ponds or other impoundments that are used for
20	irrigation or watering of livestock and that are not subject to the Vermont
21	Water Quality Standards.

1	(21) "Vermont Water Quality Standards" means the standards adopted
2	pursuant to chapter 47 and subdivision 6025(d)(3) of this title.
3	(10)(22) "Watercourse" means any perennial stream. "Watercourse"
4	shall does not include ditches or other constructed channels primarily
5	associated with land drainage or water conveyance through or around private
6	or public infrastructure.
7	(23) "Watershed" means a region containing waters that drain into a
8	particular brook, stream, river, or other body of water.
9	(24) "Withdrawal" means the intentional diversion from a surface water
10	by pumping, gravity, or other method for the purpose of being used for
11	irrigation, industrial uses, snowmaking, livestock watering, water supply,
12	aquaculture, or other off-stream uses. "Withdrawal" does not include
13	hydroelectric projects that are regulated by the Federal Energy Regulatory
14	Commission or the Public Utility Commission. "Withdrawal" does not include
15	direct consumption of surface water by livestock.
16	(12) "Berm" means a linear fill of earthen material on or adjacent to the
17	bank of a watercourse that constrains waters from entering a flood hazard area
18	or river corridor, as those terms are defined in subdivisions 752(3) and (11) of
19	this title.
20	(13) "Large woody debris" means any piece of wood within a
21	watercourse with a diameter of 10 or more inches and a length of 10 or more

2	Subchapter 4. Surface Water Withdrawals and Interbasin Transfers
3	§ 1041. POLICY ON SURFACE WATER WITHDRAWALS FOR OFF-
4	STREAM USES OTHER THAN SNOWMAKING
5	(a) This subchapter is intended to establish policy and standards for surface
6	water withdrawals that are consistent with section 1001 and chapter 47 of this
7	title, including the Vermont Water Quality Standards.
8	(b) The policy established under this subchapter is to:
9	(1) assure the protection, maintenance, and restoration of the chemical,
10	physical, and biological water quality, including water quantity, necessary to
11	sustain aquatic communities and stream function;
12	(2) help to provide for and enhance the viability of those sectors and
13	industries that rely on the use of surface waters and are important to Vermont's
14	economy;
15	(3) permit surface water withdrawals and the construction of
16	appurtenant facilities and related systems for uses other than snowmaking,
17	based on an analysis of the need for water and the consideration of alternatives.
18	and consistent with this and related policies and other applicable laws and
19	rules; and
20	(4) recognize that existing users of the State's waters for off-stream uses
21	that may have an adverse effect on water quality should have time and
22	opportunity to improve water quality.

1	§ 1042. REGISTRATION AND REPORTING; EXCEPTIONS
2	(a) Registration. Beginning on January 1, 2023, any person withdrawing
3	5,000 gallons or more of surface water within a 24-hour period shall register
4	with the Secretary. Registration shall be made on a form provided by the
5	Secretary and shall include the following information:
6	(1) the location of each withdrawal, including each impacted surface
7	water;
8	(2) the frequency and rate of each withdrawal;
9	(3) a description of the use or uses of the water to be withdrawn;
10	(4) the capacity of the system to be used for the withdrawal; and
11	(5) a schedule for the withdrawal.
12	(b) Report. Beginning on January 1, 2023, a person that is required to
13	register a surface water withdrawal pursuant to subsection (a) of this section
14	shall file an annual report with the Secretary. Reports shall be filed annually
15	by January 15 of the following year. The report shall be made on a form
16	provided by the Secretary and shall include all of the following information:
17	(1) the total amount of water withdrawn each month;
18	(2) the location of each withdrawal, including each impacted surface
19	water;
20	(3) the daily maximum withdrawal for each month;
21	(4) the date of daily maximum withdrawal; and
22	(5) any other information required by the Secretary.

1	(c) Methods of estimating withdrawals. The following methods shall be
2	used to report the amounts of withdrawn surface water required to be reported
3	under subsection (b) of this section:
4	(1) Withdrawals of between 5,000 and 50,000 gallons of surface water
5	in a 24-hour period shall either provide an estimate of total volume or provide
6	meter data. The report shall describe how any estimate was calculated.
7	(2) Withdrawals of more than 50,000 gallons of surface water in a 24-
8	hour period shall provide meter data.
9	(d) Exceptions. The following withdrawals shall not be subject to the
10	requirements of subsection (a) or (b) of this section:
11	(1) surface water withdrawals for fire suppression or other public
12	emergency response purposes;
13	(2) surface water withdrawals required to report under subchapter 3 of
14	this chapter for snowmaking uses;
15	(3) surface water withdrawals approved pursuant to chapter 56 of this
16	title on public water supply and the rules adopted thereunder for use as a public
17	drinking water supply; and
18	(4) a surface water withdrawal reported to the Secretary under any
19	project that requires the reporting of substantially similar data.
20	§ 1043. PERMIT REQUIREMENT; PROGRAM DEVELOPMENT

I	(a) Program development. On or before July 1, 2026, the Secretary shall
2	implement a surface water withdrawal permitting program that is consistent
3	with section 1041 of this subchapter. The program shall be developed to:
4	(1) require a permit or other authorization for surface water withdrawals
5	based on potential impacts to surface waters or other factors, and establish
6	conditions of operation necessary to protect surface waters and the Vermont
7	Water Quality Standards;
8	(2) consider surface water withdrawal registration and reporting
9	information submitted pursuant to section 1042 of this subchapter in the
10	establishment of permitting thresholds and other permitting requirements;
11	(3) require efficient use and conservation of surface water;
12	(4) ensure that withdrawals comply with the Vermont water quality
13	standards;
14	(5) establish limitations on withdrawals based on low flow or drought
15	conditions and the development of potential alternatives to meet surface water
16	withdrawal needs in such cases; and
17	(6) require assessment of any reasonable and feasible alternatives to
18	proposed withdrawals that may have less of an impact on surface water quality.
19	(b) Application. Application for a permit to withdraw surface water under
20	the program established under subsection (a) of this section shall be made on a
21	form provided by the Secretary and shall include the following information:

1	(1) the location of each withdrawal, including the identification and type
2	of each impacted surface water;
3	(2) a description of the use or uses of the water to be withdrawn;
4	(3) a description of the proposed method of water withdrawal;
5	(4) the frequency and rate of the withdrawal;
6	(5) an estimated schedule for the withdrawal;
7	(6) the capacity of the system to be used for the withdrawal;
8	(7) the location of the proposed return flow of the withdrawn water and
9	whether the withdrawal is an interbasin transfer;
10	(8) an estimate of the volume of water needed for the proposed use or
11	uses;
12	(9) a description of the alternative means considered for the proposed
13	uses of water that will have less of an impact on surface water quality; and
14	(10) any other information required by the Secretary.
15	(c) Permits. The Secretary may issue a general permit to authorize certain
16	withdrawal activities. A permit issued under this subchapter shall be for a
17	period of not longer than 10 years from the date of issuance.
18	(d) Exceptions. A permit required under this subchapter shall not be
19	required for surface water withdrawals for fire suppression or other public
20	emergency response purposes.
21	(e) Existing surface water withdrawals.

1	(1) Snowmaking withdrawals. Existing withdrawals approved pursuant
2	to subchapter 3 of this chapter for snowmaking shall be reviewed pursuant to
3	subdivision (f)(1) of this section.
4	(2) Nonsnowmaking withdrawals.
5	(A) A permit required under this subchapter shall not be required
6	until July 1, 2030 for an existing surface water withdrawal for nonsnowmaking
7	purposes, provided that:
8	(i) the existing surface water withdrawal is both registered and
9	reported to the Secretary pursuant to section 1042 of this title on an annual
10	basis; and
11	(ii) no expansion of the existing surface water withdrawal occurs
12	on or after January 1, 2023.
13	(B) For purposes of this subdivision, an expansion includes an
14	increase in reported surface water withdrawal rate or volume or increase in
15	reported capacity of the system.
16	(f) Surface water withdrawals for snowmaking.
17	(1) Existing withdrawals. Existing surface water withdrawals for
18	snowmaking purposes that have been reviewed and approved pursuant to
19	subchapter 3 of this chapter shall not require additional technical review by the
20	Secretary under this subchapter, provided that the approved snowmaking
21	activity is operated in compliance with the terms and conditions of the

1	Secretary's approval. For such activities, the Secretary may issue a permit
2	under the rules adopted pursuant to this subchapter.
3	(2) New withdrawals. Proposed surface water withdrawals for new
4	snowmaking activities that require review pursuant to subchapter 3 of this
5	chapter shall be reviewed by the Secretary in accordance with the rules
6	adopted pursuant to section 1032 of this title. If the Secretary determines that
7	the proposed activity is consistent with those rules, the Secretary shall issue a
8	permit required by this section for that activity.
9	(g) Circumvention. The Secretary may require a person to obtain a permit
10	under this subchapter when the Secretary, in the Secretary's discretion,
11	determines that a withdrawal or other action circumvents the requirements of
12	this subchapter.
13	§ 1044. INTERBASIN TRANSFERS OF SURFACE WATERS
14	(a) Review of HUC 6 interbasin transfers. The Secretary shall review any
15	interbasin transfer pursuant to the Vermont Water Quality Standards and other
16	requirements of State law listed in subdivision 1253(h)(1) of this title. This
17	review shall be in addition to any applicable standards and permitting
18	requirements adopted pursuant to subsection 1043(a) of this title.
19	(b) Review of other transfers likely to violate Vermont Water Quality
20	Standards. The Secretary may review any other surface water withdrawal that
21	includes the transfer of surface water from one watershed to another watershed
22	under the requirements of subsection (a) of this section if the Secretary

2	Water Quality Standards. The Secretary shall make a determination under this
3	subsection based on a review of information set forth under subsection 1043(b)
4	of this title that is readily available to the Secretary.

7	subchapter.
