Just Transitions Sub Committee Origins

Develop Principles to guide and evaluate the work of other Subcommittees to ensure that recommendations *benefit and support all residents of the State fairly and equitably.*

“...ensure that strategies consider the disproportionate impact of climate change on rural, low income and marginalized communities and that programs and incentives for building resilience are designed to be accessible to all Vermonters and do not unfairly burden any groups, communities, geographic locations or economic sectors.... May adopt a measurement tool to assess the equitability of programs and strategies considered by the Council.” 10 V.S.A. § 591(c)(3)

Sub Committee Charge

In service to all VCC sub-committees

Rely on an environmental justice framework, and work to uncover underlying assumptions that may have historically contributed to and produced differential exposure and unequal protection

Policy decisions must acknowledge past harms done and seek a path forward which is reparative and restorative

Establish guiding principles, and:

- Offer tools or processes for evaluating recommendations
- Participate in other Sub-committees to help fully integrate Principles into the Work
- Review recommendations from other Sub Committees (e.g., consult)

Leading role in designing and guiding public participation, with attention to engaging rural, low-income and marginalized communities meaningfully.

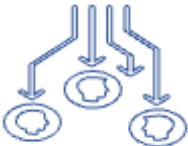

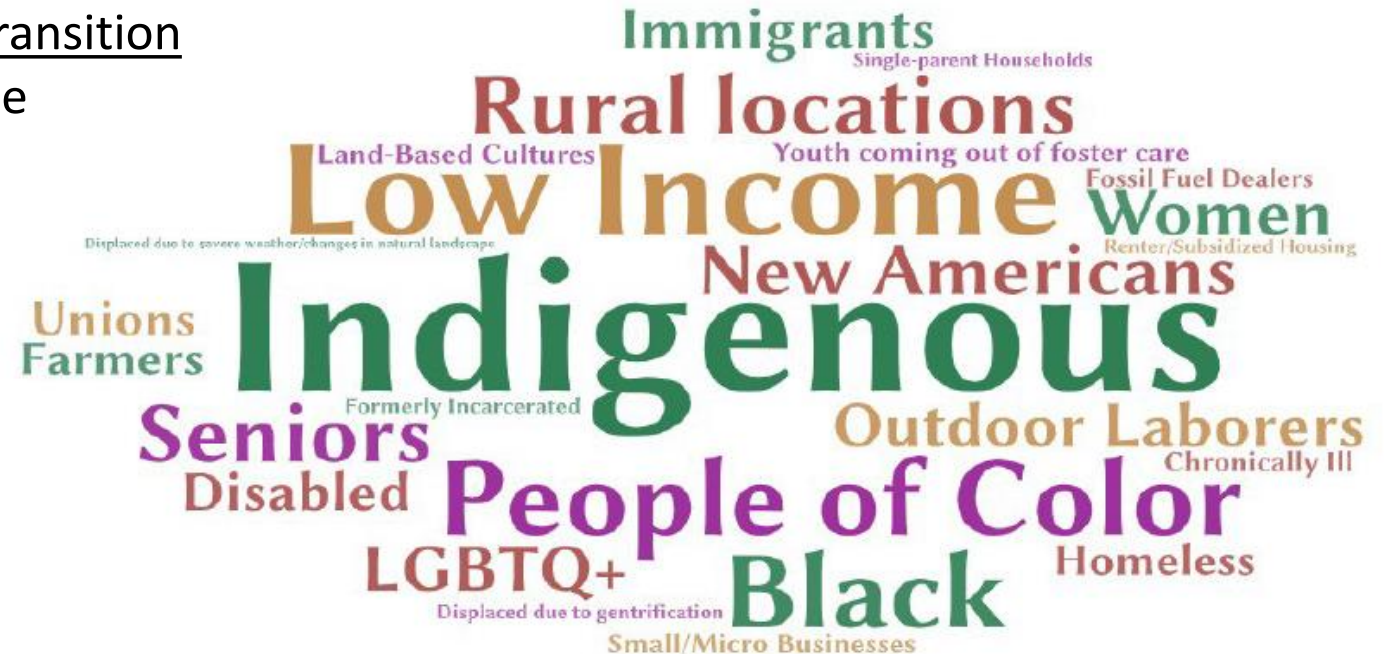

Key Criteria

Those who ...

- Are highly exposed to climate risks, such as health impacts, flooding, and extreme temperatures;
- Experience oppression and racism, are excluded from opportunities, or have less resources to adapt to climate and economic change;
- Bear the brunt of pollution and negative effects from today's fossil fuel and extractive economies; and
- Are more likely to experience a job transition as Vermont addresses climate change
