Commonalities at all Airports:

- Hangar Sizes Typically for Permitting
 - Large Hangars 120 ft by 120ft
 - Water and Sewer Service
 - Assumed maximum 24 people
 - Medium Hangars 80 ft by 60 ft
 - Small Hangars 60 ft by 60 ft
- Some Infrastructure will be necessary
- Operational Stormwater design
- Partial Findings for Act 250 (must have all other permits in place prior to applying)



VTrans Aviation Master Permitting

Steps:

- Start with infrastructure locations including hangars (began end of 2019 due to S.162 requirements)
- Environmental impact review
- Field work to collect geotechnical data
- Stormwater design (Publicly noticed)
- Water and wastewater design
- Act 250 application and coordination
 - Reviewed by ACT 250 staff
 - Publicly noticed to Statutory Parties
 - Issued Partial findings
- Local permits such as Building Permit would be up to future developer
