7	(a) As used in this section:
8	(1) "Area median income" means the county or Metropolitan Statistical
9	Area median income published by the federal Department of Housing and
10	Urban Development.
11	(2) "Multi-unit affordable housing" means a multi-unit dwelling where:
12	(A) at least 50 percent of the units are or will be occupied by
13	households whose income does not exceed 100 percent of the greater of the
14	State or area median income; or
15	(B) all units are affordable to households earning between 60 and 120
16	percent of area median income.
17	(3) "Multi-unit dwelling" means a housing project, such as cooperatives,
18	condominiums, dwellings, or mobile home parks, with 10 or more units

3	(b) The Agency of Transportation shall establish and administer, through a

7	unit dwelling owned by a nonprofit and build upon the existing VW EVSE
8	Grant Program that the Department of Housing and Community Development
9	has been administering on behalf of the Department of Environmental

11	(c) In fiscal year 2022, the Agency is authorized to spend up to
12	\$1,000,000.00 in one-time Transportation Fund monies on the pilot program
