

BEST MANAGEMENT PRACTICES CONSTRUCTION


Funding for municipalities to construct best management practices (BMPs) on municipal roads in compliance with the Municipal Roads General Permit (MRGP)

On-site technical assistance provided by RPCs with assistance from DEC and VTrans









BEST MANAGEMENT PRACTICES CONSTRUCTION

204 Road Miles Improved (FY 18-21)

235 of 261 Eligible Municipalities Enrolled over 4 years

750+ on-site technical assistance visits by RPC staff

EQUIPMENT PURCHASE PROGRAM

- Managed by VTDEC, Administered by NRPC
- Eligibility statewide over several years
- 68 equipment purchases to date
- 42 pending in FY 22, 38 on waitlist for FY 23












FY 18-21 COST

- \$10.6 million FY 18-21
- Average number of segments completed per town was 5 segments.
- Average cost per segment was \$4,563 and the median cost per segment was \$4,680
- The program required 20% match- on average towns documented 32% match.

Average Cost Allocation FY 18-21




GRANT IN AID BENEFITS

- Water Quality Benefits-Targets hydrologically connected roads, constructed projects count towards Municipal Road General Permit compliance and TMDL targets
- Enhanced Resilience and Cost Savings BMPs reduce storm damage and decrease maintenance costs
- Municipal Education- Pre-construction meetings, water quality education and technical assistance enhanced municipal capacity to understand and complete Municipal Roads General Permit requirements and standards
- Accountability- Post-project field verification and reporting assistance to track and account for results
- RPC Capacity and Knowledge- Staff in each RPC trained in MRGP and best management practices on local roads



GRANT IN AID CHALLENGES

- Municipal capacity- staff shortages and managing competing project priorities
- Materials supply- Several regions experienced challenges with the culvert and equipment manufacturing supply chains
- Training- ongoing need for municipal training on the MRGP requirements and emerging reporting tools and technology






WHAT'S NEXT?

NRPC Recommendations:

- Utilize RPC expertise and continue municipal support
- Reasonable expectations for municipal responsibilities
- Simplify administration by adding funds to the Town Highway Aid
 Program rather than a grant program



IDENTIFYING AND FIXING EROSION ISSUES ON PRIVATE AND PARK ROADS IN THE LAKE CARMI WATERSHED

- Lake Champlain Basin Program Grant to NRPC
- Pilot project to assess private and state park roads using MRGP methodology
- Landowner education workshops
- Construct 2-3 pilot projects
