2	An act relating to aquatic nuisance control
3	It is hereby enacted by the General Assembly of the State of Vermont:
4	Sec. 1. AQUATIC NUISANCE CONTROL STUDY COMMITTEE;
5	REPORT
6	(a) Creation. The Aquatic Nuisance Control Study Committee is created to
7	assess the environmental and public health effects of the use of pesticides,
8	chemicals other than pesticides, biological controls, and other controls in
9	comparison to the efficacy of their use in controlling aquatic nuisances.
10	(b) Membership. The Aquatic Nuisance Control Study Committee shall be
11	composed of the following members:
12	(1) one current member of the House of Representatives, who shall be
13	appointed by the Speaker of the House;
14	(2) one current member of the Senate, who shall be appointed by the
15	Committee on Committees;
16	(3) the Commissioner of Health or designee;
17	(4) a scientist from the Department of Fish and Wildlife, appointed by
18	the Commissioner of Fish and Wildlife;
19	(5) a scientist from the Department of Environmental Conservation,
20	appointed by the Commissioner of Environmental Conservation; and
21	(6) two scientists or researchers from the University of Vermont,
22	appointed by the President of the University of Vermont, one with expertise in

1	the potential human health impacts related to invasives and control eradication
2	and one with expertise in aquatic biology, including flora, fauna, and
3	ecosystem health.
4	(c) Powers and duties. The Aquatic Nuisance Control Study Committee
5	shall submit to the Vermont General Assembly recommendations regarding
6	whether and when pesticides, chemicals other than pesticides, or biological
7	controls should be used to control aquatic nuisances in Vermont. The
8	recommendations of the Committee shall include:
9	(1) a summary of the use of pesticides, chemicals other than pesticides,
10	and biological controls in the lakes and ponds of Vermont since January 1,
11	2000, including the types of pesticides, chemicals other than pesticides, and
12	biological controls approved for use and why they were approved instead of
13	nonchemical controls;
14	(2) an assessment of the use of pesticides, chemicals other than
15	pesticides, or biological controls on the nontarget environment or nontarget
16	species; and
17	(3) recommended legislative changes to the aquatic nuisance control
18	requirements under 10 V.S.A. chapter 50 to:
19	(A) implement the use of pesticides, chemicals other than pesticides,
20	or biological controls in a more precautionary manner that ensures the

1	protection of State waters and is designed to protect fish, reptiles, amphibians,
2	and all other aquatic biota;
3	(B) establish the appropriate standard for approval of the use of
4	pesticides, chemicals other than pesticides, and biological controls for aquatic
5	nuisance control;
6	(C) amend the process for the application of an aquatic nuisance
7	control permit in a manner that improves the opportunity for interested parties
8	to participate in the permitting process and that ensures full transparency in the
9	permitting process; and
10	(D) provide other changes that the Study Committee determines are
11	necessary or appropriate for implementation of effective aquatic nuisance
12	control in the State.
13	(d) Assistance. The Aquatic Nuisance Control Study Committee shall have
14	the administrative, technical, and legal assistance of the Agency of Natural
15	Resources.
16	(e) Report. On or before December 15, 2023, the Aquatic Nuisance
17	Control Study Committee shall submit a written report to the House
18	Committee on Environment and Energy and the Senate Committee on Natural
19	Resources and Energy with its findings and recommendations.
20	(f) Meetings.

1	(1) The Commissioner of Environmental Conservation or designee shall
2	call the first meeting of the Aquatic Nuisance Control Study Committee to
3	occur on or before September 1, 2023.
4	(2) The Committee shall select a chair from among its members at the
5	first meeting.
6	(3) A majority of the membership shall constitute a quorum.
7	(4) The Aquatic Nuisance Control Study Committee shall cease to exist
8	on April 1, 2024.
9	(g) Compensation and reimbursement.
10	(1) For attendance at meetings during adjournment of the General
11	Assembly, a legislative member of the Aquatic Nuisance Control Study
12	Committee serving in the member's capacity as a legislator shall be entitled to
13	per diem compensation and reimbursement of expenses pursuant to 2 V.S.A.
14	§ 23 for not more than eight meetings. These payments shall be made from
15	monies appropriated to the General Assembly.
16	(2) Other members of the Study Committee shall be entitled to per diem
17	compensation and reimbursement of expenses as permitted under 32 V.S.A. §
18	1010 for not more than eight meetings. These payments shall be made from
19	monies appropriated to the General Assembly.
20	(h) Definitions. As used in this section:
21	(1) "Aquatic nuisance" has the same meaning as in 10 V.S.A. § 1452.
