15	(a) The possession of lighted tobacco products or use of tobacco substitutes
16	in any form is prohibited in:

2	transient traveling or public vacationing, such as resorts, hotels, and motels,

6	(4) any other area within 25 feet of a place of public access, including
7	all State-owned buildings and offices, except that to the extent that any portion
8	of the 25 foot zone is not on State property, smoking is prohibited only in that
9	portion of the zone that is on State property unless the owner of the adjoining
10	property chooses to designate his or her property smoke free; and
11	(5) any area within 25 feet of any entrance, exit, window, or vent of a
12	multiunit dwelling.
13	(b) The possession of lighted tobacco products or use of tobacco substitutes
14	in any form is prohibited on the grounds of any hospital or secure residential
15	recovery facility owned or operated by the State, including all enclosed places
16	in the hospital or facility and the surrounding outdoor property.
17	(c) Nothing in this section shall be construed to restrict the ability of
18	residents of the Vermont Veterans' Home to possess lighted tobacco products
19	or use tobacco substitutes in the indoor area of the facility in which smoking is

1	(d) Nothing in this chapter shall be construed to prohibit the use of tobacco
2	substitutes in a business that does not sell food or beverages but is established
3	for the sole purpose of providing a setting for patrons to purchase and use
4	tobacco substitutes and related paraphernalia.
