12	(2) provides harm reduction supplies, including sterile injection

15	(3) provides drug-checking services;
16	(4) answers questions on safer consumption practices;
17	(5) administers first aid, if needed, and monitors and treats potential
18	overdoses;
19	(6) provides referrals to addiction treatment, medical services, and social

21	(7) educates participants on the risks of contracting HIV and viral
22	hepatitis, wound care, and safe sex education;

7	eligibility criteria for program participants; and
8	(12) trains staff members to deliver services offered by the program.
9	(b) The Department of Health, in consultation with stakeholders and health
10	departments of other jurisdictions that have overdose prevention centers, shall
11	develop operating guidelines for overdose prevention centers not later than
12	September 15, 2024. The operating guidelines shall include the level of staff
13	qualifications required for medical safety and treatment and referral support
14	and require an overdose prevention center to staff trained professionals during
15	operating hours who, at a minimum, can provide basic medical care, such as
16	CPR, overdose interventions, first aid, and wound care, as well as have the
17	ability to perform medical assessments with program participants to determine
18	if there is a need for emergency medical service response. Overdose
19	prevention center staff may include peers, case managers, medical
20	professionals, and mental health counselors.

1	(c)(1) The following persons are entitled to the immunity protections set
2	forth in subdivision (2) of this subsection for participation in or with an
3	approved overdose prevention center that is acting in the good faith provision
4	of overdose prevention services in accordance with the guidelines established
