16	(b) The Board of Supervisors shall review the proposed budget in light of
17	the oral comments received at hearings and written comments received up to
18	and including the day of the public hearing and shall prepare a final budget to
19	be acted upon by the Board of Supervisors by January 15th to be acted upon at
20	the annual meeting of the District.
21	(c) If the annual budget for any fiscal year is not approved as of the
22	beginning of that fiscal year, the District shall continue to operate on the

1	budget for the immediately preceding fiscal year until a new budget is
2	approved.
3	(d) Notwithstanding any disapproval of the budget, the District shall be
4	obligated to pay the principal of and interest on bonds, notes, and other
5	evidence of indebtedness of the District; to satisfy any other obligations
6	relating to the bonds, notes, and other evidence of indebtedness; and to pay
7	obligations under any long-term contracts. To the extent provided by the terms
8	of the bonds, notes, other evidence of indebtedness, or long-term contracts,
9	each member municipality shall be obligated to pay its share of the
10	indebtedness and obligations under long-term contracts. Unless otherwise
11	provided in the vote authorizing the same, a municipality's share of
12	indebtedness shall be determined by the Board of Supervisors and shall be in
13	an amount proportionate to the actual or estimated tonnage or volume of solid
14	waste generated by that municipality as determined by the Board of
15	Supervisors pursuant to section 404 of this charter.
