2	An act relating to the Vermont basic needs budget
3	It is hereby enacted by the General Assembly of the State of Vermont:
4	Sec. 1. BASIC NEEDS BUDGET TECHNICAL ADVISORY COMMITTEE;
5	REPORT
6	(a) Creation. The Basic Needs Budget Technical Advisory Committee is
7	created to update the methodology utilized in calculating the basic needs
8	budget pursuant to 2 V.S.A. § 526.
9	(b) Membership. The Committee shall be composed of the following
10	members:
11	(1) two current members of the House of Representatives, not all from
12	the same political party, who shall be appointed by the Speaker of the House;
13	(2) two current members of the Senate, not all from the same political
14	party, who shall be appointed by the Committee on Committees;
15	(3) the Secretary of Human Services or designee;
16	(4) one member, appointed by the Vermont Sustainable Jobs Fund;
17	(5) one member, appointed by the Society for Human Resources
18	Management, Vermont State Council; and
19	(6) one member, appointed by Capstone Community Action.
20	(c) Duties.

1	(1)(A) On or before November 1, 2023, the Committee shall study the
2	topics set forth in subdivision (B) of this subdivision (1) and submit a written
3	report to the Joint Fiscal Committee, the House Committee on General and
4	Housing, and the Senate Committee on Economic Development, Housing and
5	General Affairs that details the Committee's findings and provides
6	recommendations for revisions to the methodology for determining the basic
7	needs budget pursuant to 2 V.S.A. § 526. The report may also include
8	recommendations for legislative action.
9	(B) In preparing the report required pursuant to subdivision (A) of
10	this subdivision (1), the Committee shall study the following topics:
11	(i) the current methodology for calculating the basic needs budget
12	and determining what constitutes a livable wage;
13	(ii) potential changes to the methodology for calculating the basic
14	needs budget and determining what constitutes a livable wage, including the
15	identification of not more than seven household configurations to be utilized in
16	future determinations of the basic needs budget and livable wage; and
17	(iii) potential changes to 2 V.S.A. § 526 to account for public
18	policy changes, data availability, or any other factors that have had an impact
19	on any aspects of the basic needs budget calculation or the cost to Vermonters
20	of basic needs as that term is defined in 2 V.S.A. § 526(a)(1).
21	(2) The Committee shall:

1	(A) take testimony from subject-matter experts to assist with data
2	analysis and methodological considerations; and
3	(B) take testimony from a variety of stakeholders, including
4	employers and employees and organizations that represent employers and
5	employees.
6	(d) Assistance. The Committee shall have the administrative and technical
7	assistance of the Joint Fiscal Office, the technical assistance of the Department
8	of Labor's Economic and Labor Market Information Division, and the legal
9	assistance of the Office of Legislative Counsel.
10	(e) Meetings.
11	(1) The Joint Fiscal Office shall call the first meeting of the Committee
12	to occur on or before August 15, 2023.
13	(2) The Committee shall select a chair from among its members at the
14	first meeting.
15	(3) A majority of the membership shall constitute a quorum.
16	(4) The Committee shall cease to exist on January 30, 2025.
17	(f) Compensation and reimbursement.
18	(1) For attendance at meetings during adjournment of the General
19	Assembly, a legislative member of the Committee shall be entitled to per diem
20	compensation and reimbursement of expenses pursuant to 2 V.S.A. § 23 for
21	not more than five meetings.

1	(2) Other members of the Committee who are not State employees shall
2	be entitled to per diem compensation and reimbursement of expenses as
3	permitted under 32 V.S.A. § 1010 for not more than five meetings.
4	(g) Appropriations.
5	(1) The sum of \$7,000.00 is appropriated to the General Assembly from
6	the General Fund in fiscal year 2024 for per diem compensation and
7	reimbursement of expenses for members of the Committee.
8	(2) The sum of \$10,000.00 is appropriated to the Joint Fiscal Office
9	from the General Fund in fiscal year 2024 for costs related to retaining experts
10	and other services provided to the Committee by the Joint Fiscal Office.
11	Sec. 2. 2025 BASIC NEEDS BUDGET REPORT; METHODOLOGY
12	Notwithstanding any provision of 2 V.S.A. § 526(c) to the contrary, in
13	preparing the basic needs budget report due January 15, 2025, the Joint Fiscal
14	Office shall utilize the methodology and household configurations
15	recommended by the Basic Needs Budget Technical Advisory Committee
16	established pursuant to section 1 of this act.
17	Sec. 3. EFFECTIVE DATE
18	This act shall take effect on July 1, 2023.
