4	It is hereby enacted by the General Assembly of the State of Vermont:
5	Sec. 1. LEGISLATIVE FINDING
6	According to the Crimes Against Children Research Center, child sexual
7	abuse is tragically widespread with one in five girls and one in 20 boys
8	experiencing sexual abuse before 18 years of age. In over 90 percent of
9	incidents of child sexual abuse, the perpetrator is someone known and trusted
10	by the child and the child's family.
11	Sec. 2. PURPOSE
12	(a) Behavior commonly referred to as "grooming" is a tactic in which
13	someone methodically builds a trusting relationship with a child or young
14	adult, the child's or young adult's family, and the child's or young adult's
15	community with intent to manipulate, coerce, or force the child or young adult
16	to engage in sexual activities.
17	(b) Manipulating a child to engage in sexual activity may include behaviors
18	in which the perpetrator:
19	(1) engages in boundary violations involving touching of the child;
20	(2) exposes the perpetrator's naked body to the child or observes the
21	child undressing or while naked;

1	(3) shows the child obscene or indecent materials as defined in 13
2	V.S.A. chapter 63;
3	(4) physically or emotionally separates or isolates the child from peers,
4	family, or other support systems;
5	(5) provides the child with alcohol or drugs; or
6	(6) develops a trusting relationship with the child through behaviors that
7	are excessive or inappropriate for the context or relationship, including the
8	provision of attention; affection; compliments; or rewards, privileges, or gifts.

10	§ 2828. LURING A CHILD
11	(a) No person shall knowingly solicit, lure, manipulate, or entice, or to
12	attempt to solicit, lure, manipulate, or entice, a child under 16 years of age or
13	another person believed by the person to be a child under 16 years of age, to
14	engage in a sexual act as defined in section 3251 of this title or engage in lewd
15	and lascivious conduct as defined in section 2602 of this title.
16	(b) This section applies to solicitation, luring, <u>manipulating</u> , or enticement
17	by any means, including in person, through written or telephonic
18	correspondence, or through electronic communication.
19	(c) This section shall not apply if the person is less than 19 years of age, the
20	child is at least 15 years of age, and the conduct is consensual.

2	§ 3258. SEXUAL EXPLOITATION OF A MINOR
3	(a) No person shall engage in a sexual act <u>as defined in section 3251 of this</u>
4	title or sexual conduct as defined in section 2821 of this title with a minor if:
5	(1) the actor is at least 48 months older than the minor; and
6	(2) the actor is in a position of power, authority, or supervision over the
7	minor by virtue of the actor's undertaking the responsibility, professionally or
8	voluntarily, to provide for the health or welfare of minors, or guidance,
9	leadership, instruction, or organized recreational activities for minors.
10	(b) No person who is prohibited from engaging in a sexual act as defined in
11	section 3251 of this title or sexual conduct as defined in section 2821 of this
12	title with a minor pursuant to subsection (a) of this section shall knowingly
13	solicit, lure, manipulate, or entice, or to attempt to solicit, lure, manipulate, or
14	entice, such minor or another person believed by the person to be such a minor
15	to engage in sexual conduct.
16	$\underline{(c)(1)}$ A person who violates subsection (a) of this section shall be
17	imprisoned for not more than one year or fined not more than \$2,000.00, or
18	both.
19	(e)(2) A person who violates subsection (a) of this section and who abuses
20	his or her the person's position of power, authority, or supervision over the
21	minor in order to engage in a sexual act as defined in section 3251 of this title

1	or sexual conduct as defined in section 2821 of this title shall be imprisoned
2	for not more than five years or fined not more than \$10,000.00, or both.
3	(d)(1) A person who violates subsection (b) of this section shall be
4	imprisoned for not more than six months or fined not more than \$1,000.00, or
5	both.
6	(2) A person who violates subsection (b) of this section and who abuses
7	the person's position of power, authority, or supervision over the minor in
8	order to engage in a sexual act as defined in section 3251 of this title or sexual
9	conduct as defined in section 2821 of this title shall be imprisoned for not more
10	than two years or fined not more than \$5,000.00, or both.
