2	An act relating to the creation of the Cybersecurity Advisory Council
3	It is hereby enacted by the General Assembly of the State of Vermont:
4	Sec. 1. 20 V.S.A. chapter 208 is added to read:
5	CHAPTER 208. CYBERSECURITY
6	§ 4661. DEFINITIONS
7	As used in this chapter:
8	(1) "Critical infrastructure" has the same meaning as in 11 V.S.A.
9	<u>§ 1701.</u>
10	(2) "Cybersecurity" means the practice of deploying people, policies,
11	processes, and technologies to protect organizations, their critical systems, and
12	sensitive information from digital attacks.
13	(3) "Essential supply chain" means supply chains for the production, in
14	sufficient quantities, of the following articles:
15	(A) medical supplies, medicines, and personal protective equipment;
16	(B) articles essential to the operation, manufacture, supply, service,
17	or maintenance of critical infrastructure;
18	(C) articles critical to infrastructure construction after a natural or
19	manmade disaster;
20	(D) articles that are critical to the State's food systems, including
21	food supplies for individuals and households and livestock feed; and
22	(E) articles that are critical to the State's thermal systems and fuels.

l	§ 4662. CYBERSECURITY ADVISORY COUNCIL
2	(a) Creation. There is created the Cybersecurity Advisory Council to
3	advise on the State's cybersecurity infrastructure, best practices,
4	communications protocols, standards, training, and safeguards.
5	(b) Membership. The Council shall be composed of the following
6	members:
7	(1) the Chief Information Officer, who shall serve as the Chair or
8	appoint a designee from the Council to serve as the Chair;
9	(2) the Chief Information Security Officer;
10	(3) a representative from a distribution or transmission utility, appointed
11	by the Commissioner of Public Service;
12	(4) a representative from a State municipal water system, appointed by
13	Secretary of Natural Resources;
14	(5) a representative from a Vermont hospital, appointed by the President
15	of the Vermont Association of Hospitals and Health Systems;
16	(6) a person representing a Vermont business related to an essential
17	supply chain, appointed by the Chair of the Vermont Business Roundtable;
18	(7) the Director of Vermont Emergency Management or designee;
19	(8) the Governor's Homeland Security Advisor or designee;
20	(9) the Vermont Adjutant General or designee;
21	(10) the Attorney General or designee; and

1	(11) the President of Vermont Information Technology Leaders or
2	designee.
3	(c) Powers and duties. The Council shall have the following duties:
4	(1) develop a strategic plan for protecting the State's public sector and
5	private sector information and systems from cybersecurity attacks;
6	(2) evaluate statewide cybersecurity readiness and develop and share
7	best practices for policies and procedures to strengthen administrative,
8	technical, and physical cybersecurity safeguards as a resource for State
9	government, Vermont businesses, and the public;
10	(3) build relationships and conduct outreach within State government
11	and to federal government and the private sector to ensure the resilience of
12	electronic information systems;
13	(4) build strong partnerships with local universities and colleges in order
14	to leverage cybersecurity resources; and
15	(5) conduct an inventory and review of cybersecurity standards and
16	protocols for critical sector infrastructures and make recommendations on
17	whether improved or additional standards and protocols are necessary; and
18	(6) identify and advise on opportunities to:
19	(A) ensure Vermont promotes, attracts, and retains a highly skilled
20	cybersecurity workforce;
21	(B) raise citizen awareness through outreach and public service

1	announcements;
2	(C) provide technical capabilities, training, and advice to local
3	government and the private sector;
4	(D) provide recommendations on legislative action to the General
5	Assembly to protect critical assets, infrastructure, services, and personally
6	identifiable information;
7	(E) advise on strategic, operational, and budgetary impacts of
8	cybersecurity on the State;
9	(F) engage State and federal partners in assessing and managing risk;
10	(G) investigate ways the State can implement a unified cybersecurity
11	communications and response, including recommendations for establishing
12	statewide communication protocols in the event of a cybersecurity incident;
13	<u>and</u>
14	(H) access cyber-insurance, including how to increase availability
15	and affordability of cyber-insurance for critical industries.
16	(d) Assistance. The Council shall have the administrative and technical
17	assistance of the Agency of Digital Services.
18	(e) Working groups and consultations.
19	(1) The Council may establish interagency working groups to support its
20	charge, drawing membership from any State agency or department.
21	(2) The Council may consult with private sector and municipal, State,

1	and federal government professionals for information and advice on issues
2	related to the Council's charge.
3	(f) Meetings.
4	(1) A majority of the membership shall constitute a quorum.
5	(2) The Council shall meet at least quarterly.
6	(3)(A) In addition to 1 V.S.A. § 313, the Council is authorized to enter
7	into an executive session to consider:
8	(i) testimony from a person regarding details of a cybersecurity
9	incident or response to that incident, the disclosure of which would jeopardize
10	public safety; or
11	(ii) any evaluations, recommendations, or discussions of
12	cybersecurity standards, protocols, and incident responses, the disclosure of
13	which would jeopardize public safety.
14	(B) Members of the Council and persons invited to testify before the
15	Council shall not disclose to the public information, records, discussions, and
16	opinions stated in connection to the Council's work if the disclosure would
17	jeopardize public safety.
18	(g) Reports. On or before January 15 each year, the Council shall submit a
19	written report to the House Committees on Commerce and Economic
20	Development, on Environment and Energy, on Government Operations and
21	Military Affairs, and on Ways and Means and the Senate Committees on

1	Economic Development, Housing and General Affairs, on Finance, and on
2	Government Operations with a status update on the work of the Council and
3	any recommendations for legislative action. The provisions of 2 V.S.A.
4	§ 20(d) (expiration of required reports) shall not apply to the report to be made
5	under this subsection.
6	(h) Public records act exemption. Any records or information produced or
7	acquired by the Council regarding cybersecurity standards, protocols, and
8	incident responses, if the disclosure would jeopardize public safety, shall be
9	kept confidential and shall be exempt from public inspection or copying under
10	Vermont's Public Records Act. Notwithstanding 1 V.S.A. § 317(e), the Public
11	Records Act exemption created in this section shall continue in effect and shall
12	not be reviewed for repeal.
13	(i) Compensation and reimbursement. Members of the Council who are
14	not otherwise compensated or reimbursed for their attendance shall be entitled
15	to per diem compensation and reimbursement of expenses as permitted under
16	32 V.S.A. § 1010. These payments shall be made from monies appropriated to
17	the Agency of Digital Services.

20	In As used in this chapter:
21	(1) "Critical infrastructure" means property and equipment owned or

1	used by communications networks and electric generation, transmission, and
2	distribution systems; water and wastewater systems; health systems; essential
3	supply chains; thermal fuels and systems; and communications networks,
4	including cellular, broadband, and telecommunications networks.

6	Sec. 3. REPORT
7	On or before January 15, 2024, the Cybersecurity Advisory Council shall
8	include in its report required by 20 V.S.A. § 4662(g) recommendations on
9	whether to amend the definition of "essential supply chain", as defined in 20
10	V.S.A. § 4661, to include additional supply chains.
11	Sec. 4. REPEAL
12	20 V.S.A. chapter 208 (cybersecurity) is repealed on June 30, 2028.
13	Sec. 5. EFFECTIVE DATE
14	This act shall take effect on July 1, 2023.
