4 Subject: Health; COVID-19; health care providers; regulatory flexibility

5 Statement of purpose of bill as introduced: This bill proposes to extend until
6 March 31, 2024 certain provisions of previous acts allowing for health care-
7 related regulatory flexibility during and after the COVID-19 pandemic. The
8 bill would also continue indefinitely pharmacists' authority to order and
9 administer COVID tests and would require the Board of Medical Practice to
10 report on ways to increase efficiency in Vermont's physician licensure process.

12 It is hereby enacted by the General Assembly of the State of Vermont:

3 Sec. 4. HEALTH CARE AND HUMAN SERVICE PROVIDER

4 REGULATION; WAIVER OR VARIANCE PERMITTED

5 Notwithstanding any provision of the Agency of Human Services'
6 administrative rules or standards to the contrary, through March 31, 2023
7 2024, the Secretary of Human Services may waive or permit variances from
8 the following State rules and standards governing providers of health care
9 services and human services as necessary to prioritize and maximize direct
10 patient care, support children and families who receive benefits and services
11 through the Department for Children and Families, and allow for continuation
12 of operations with a reduced workforce and with flexible staffing arrangements
13 that are responsive to evolving needs, to the extent such waivers or variances
14 are permitted under federal law:

15 (1) Hospital Licensing Rule;

16 (2) Hospital Reporting Rule;

17 (3) Nursing Home Licensing and Operating Rule;

18 (4) Home Health Agency Designation and Operation Regulations;

19 (5) Residential Care Home Licensing Regulations;

20 (6) Assisted Living Residence Licensing Regulations;

21 (7) Home for the Terminally Ill Licensing Regulations;

- 1 (8) Standards for Adult Day Services;
- 2 (9) Therapeutic Community Residences Licensing Regulations;

13 (a) Notwithstanding any provision of 18 V.S.A. chapter 220 or 221,

14 8 V.S.A. § 4062, 33 V.S.A. chapter 18, subchapter 1, or the Green Mountain

15 Care Board's administrative rules, guidance, or standards to the contrary,

16 through March 31, ~~2023~~ 2024, the Green Mountain Care Board may waive or

17 permit variances from State laws, guidance, and standards with respect to the

18 following regulatory activities, to the extent permitted under federal law, as

19 necessary to prioritize and maximize direct patient care, safeguard the stability

20 of health care providers, and allow for orderly regulatory processes that are

21 responsive to evolving needs related to the COVID-19 pandemic:

- 1 (1) hospital budget review;
- 2 (2) certificates of need;
- 3 (3) health insurance rate review; and
- 4 (4) accountable care organization certification and budget review.

5 (b) As part of any proceeding conducted on or after February 1, 2022 to
6 establish or enforce a hospital's fiscal year 2022 or 2023 budget, the Green
7 Mountain Care Board shall consider the hospital's extraordinary labor costs
8 and investments, as well as the impacts of those costs and investments on the
9 affordability of health care.

11 ENROLLMENT AND CREDENTIALING

12 Until March 31, ~~2023~~ 2024, and to the extent permitted under federal law,
13 the Department of Vermont Health Access shall relax provider enrollment
14 requirements for the Medicaid program, and the Department of Financial
15 Regulation shall direct health insurers to relax provider credentialing
16 requirements for health insurance plans, in order to allow for individual health
17 care providers to deliver and be reimbursed for services provided across health
18 care settings as needed to respond to Vermonters' evolving health care needs.

21 Sec. 8. ACCESS TO HEALTH CARE SERVICES; DEPARTMENT OF

1 FINANCIAL REGULATION; EMERGENCY RULEMAKING

2 (a) It is the intent of the General Assembly to increase Vermonters' access
3 to medically necessary health care services during and after a declared state of
4 emergency in Vermont as a result of COVID-19.

5 (b)(1) ~~Until April 1, 2023~~ Through March 31, 2024, and notwithstanding
6 any provision of 3 V.S.A. § 844 to the contrary, the Department of Financial
7 Regulation shall consider adopting, and shall have the authority to adopt,
8 emergency rules ~~to address the following through March 31, 2023:~~

9 (A) expanding health insurance coverage for, and waiving or limiting
10 cost-sharing requirements directly related to, the diagnosis of COVID-19,
11 including tests for influenza, pneumonia, and other respiratory viruses
12 performed in connection with making a COVID-19 diagnosis; the treatment of
13 COVID-19 when it is the primary or a secondary diagnosis; and the prevention
14 of COVID-19; and

15 (B) ~~modifying or suspending health insurance plan deductible~~

2 Through March 31, ~~2023~~ 2024, to the extent permitted under federal law, a
3 health care professional authorized to prescribe buprenorphine for treatment of
4 substance use disorder may authorize renewal of a patient’s existing
5 buprenorphine prescription without requiring an office visit.

10 MEDICAL PRACTICE; OUT-OF-STATE HEALTH CARE
11 PROFESSIONALS

12 (a) Notwithstanding any provision of Vermont’s professional licensure
13 statutes or rules to the contrary, through March 31, ~~2023~~ 2024, a health care
14 professional, including a mental health professional, who holds a valid license,
15 certificate, or registration to provide health care services in any other U.S.
16 jurisdiction in a profession regulated by the Board of Medical Practice, or in a
17 profession regulated by the Office of Professional Regulation for which the
18 Office does not provide a pathway to provisional licensure under 3 V.S.A.
19 § 130, shall be deemed to be licensed, certified, or registered to provide health
20 care services, including mental health services, to a patient located in Vermont
21 as a volunteer member of the Medical Reserve Corps or, for a period not to

1 exceed six months, as part of the staff of a licensed facility, other health care
2 facility as defined in 18 V.S.A. § 9432, or federally qualified health center,
3 provided the health care professional:

4 (1) is licensed, certified, or registered in good standing in the other U.S.
5 jurisdiction or jurisdictions in which the health care professional holds a
6 license, certificate, or registration;

7 (2) is not subject to any professional disciplinary proceedings in any
8 other U.S. jurisdiction; and

9 (3) is not affirmatively barred from practice in Vermont for reasons of
10 fraud or abuse, patient care, or public safety.

11 (b) A health care professional who plans to provide health care services in
12 Vermont as a volunteer member of the Medical Reserve Corps or as part of the
13 staff of a licensed facility, other health care facility as defined in 18 V.S.A.
14 § 9432, or federally qualified health center shall submit or have submitted on
15 the individual's behalf the individual's name, contact information, and the
16 location or locations at which the individual will be practicing to:

17 (1) the Board of Medical Practice for medical doctors, physician
18 assistants, and podiatrists; or

19 (2) the Office of Professional Regulation for all other health care
20 professions.

1 (c) A health care professional who delivers health care services in Vermont
2 pursuant to subsection (a) of this section shall be subject to the imputed
3 jurisdiction of the Board of Medical Practice or the Office of Professional
4 Regulation, as applicable based on the health care professional's profession, in
5 accordance with Sec. 19 of this act.

6 (d)(1) This section shall remain in effect through March 31, ~~2023~~ 2024,
7 provided the health care professional remains licensed, certified, or registered
8 in good standing throughout the period the health care professional is
9 practicing in Vermont, which shall not exceed six months for a health care
10 professional providing health care services as part of the staff of a licensed
11 facility, other health care facility as defined in 18 V.S.A. § 9432, or federally
12 qualified health center.

14 Regulation shall provide appropriate notice of the March 31, ~~2023~~ 2024

1 (e) Nothing in this section is intended to limit, restrict, or modify the
2 application of existing or future federal waivers of health care professional
3 licensure requirements to licensed and certified facilities.

4 (f) Health care facilities, health insurers, and Vermont Medicaid shall
5 consider deemed licensure, certification, or registration pursuant this section as
6 sufficient to meet applicable Vermont licensure, certification, or registration
7 requirements for the purpose of health care professional credentialing and
8 enrollment; provided, however, that this deemed satisfaction of the licensure,
9 certification, and registration requirements shall have no impact on any other
10 credentialing or enrollment requirement.

14 Sec. 26. WAIVER OF CERTAIN TELEHEALTH REQUIREMENTS
15 FOR A LIMITED TIME

16 Notwithstanding any provision of 8 V.S.A. § 4100k or 18 V.S.A. § 9361 to
17 the contrary, through March 31, 2023 2024, the following provisions related to
18 the delivery of health care services through telemedicine or by store-and-
19 forward means shall not be required, to the extent their waiver is permitted by
20 federal law or guidance regarding enforcement discretion:

1 (1) delivering health care services, including dental services, using a
2 connection that complies with the requirements of the Health Insurance
3 Portability and Accountability Act of 1996, Pub. L. No. 104-191 in accordance
4 with 8 V.S.A. § 4100k(i), as amended by this act, if it is not practicable to use
5 such a connection under the circumstances;

6 (2) representing to a patient that the health care services, including
7 dental services, will be delivered using a connection that complies with the
8 requirements of the Health Insurance Portability and Accountability Act of
9 1996, Pub. L. No. 104-191 in accordance with 18 V.S.A. § 9361(c), if it is not
10 practicable to use such a connection under the circumstances.

18 (a) Notwithstanding any provision of 26 V.S.A. § 1353(11) to the contrary,
19 the Board of Medical Practice or its Executive Director may issue a temporary
20 license through March 31, ~~2023~~ 2024 to an individual who is licensed to
21 practice as a physician, physician assistant, or podiatrist in another jurisdiction,

1 whose license is in good standing, and who is not subject to disciplinary
2 proceedings in any other jurisdiction. The temporary license shall authorize
3 the holder to practice in Vermont until a date not later than April 1, ~~2023~~ 2024,
4 provided the licensee remains in good standing.

5 (b) Through March 31, ~~2023~~ 2024, the Board of Medical Practice or its
6 Executive Director may waive requirements for physician assistants, including

21 STATE HEALTH CARE PROFESSIONALS

1 (a) Notwithstanding any provision of Vermont’s professional licensure
2 statutes or rules to the contrary, ~~from the period from~~ beginning on April 1,
3 2022 ~~through June 30, 2023~~, the Office of Professional Regulation and Board
4 of Medical Practice shall register a health care professional who is not licensed
5 or registered to practice in Vermont but who seeks to provide health care
6 services to patients or clients located in Vermont using telehealth, provided:

7 (1) the health care professional completes an application in the manner
8 specified by the Director of the Office of Professional Regulation or the Board
9 of Medical Practice, as applicable; and

10 (2)(A) the health care professional holds an active, unencumbered license,
11 certificate, or registration in at least one other U.S. jurisdiction to practice the
