14	(a) The following officers shall be elected by the legal voters of the Town
15	of Barre and voting for the officers shall be by Australian ballot:
16	(1) five Selectboard members;
17	(2) three listers;
18	(3) three auditors;
19	(4) one Constable;
20	(5)(3) one Clerk;
21	(6)(4) one Moderator.

2	§ 13. BOARD OF LISTERS
3	(a) The Board of Listers shall consist of three listers, one elected each year
4	for a term of three years. The Board shall have the same powers and duties
5	prescribed for listers under the laws of the State of Vermont.
6	(b) The Board shall annually review, or cause to be reviewed, its appraisals
7	of all property in the Town that is subject to taxation. The property shall be
8	appraised in accordance with standards established by the laws of the State.
9	(c) If the Town shall vote to replace the Board of Listers with a single
10	assessor in the manner provided in subsection 10(b) of this charter, then the
11	assessor shall perform all of the duties and have all of the powers prescribed

14	§ 15. CONSTABLE
15	A Constable shall be elected to serve for a term of one year. He or she shall
16	have all the powers and duties prescribed for constables under the laws of
17	Vermont, except as provided in this charter. [Repealed.]

19	§ 38. APPOINTED OFFICERS
20	(a) The Selectboard, by majority vote, shall appoint the following Town
21	officers for the terms indicated:

2	(5) An Assessor, who may be hired or contracted upon such terms as the
3	Selectboard shall deem reasonable. The Assessor shall perform all of the
4	duties and have all of the powers prescribed for listers under the laws of
5	<u>Vermont.</u>

7	(7) A Constable, for a term of one year. The appointed Constable shall
8	have all the powers and duties described for constables under Vermont law,
9	except as provided in this charter. The Selectboard may prohibit the Constable

12	authority under 20 V.S.A. § 2358.

14	Sec. 3. TRANSITIONAL PROVISION
15	Upon the effective date of this act:
16	(1) The term of office of an elected Town Constable shall continue until
17	the Selectboard appoints a successor Constable.
18	(2) The Town Board of Listers shall cease to exist and the terms of the
19	elected listers shall expire.
20	Sec. 4. EFFECTIVE DATE
21	This act shall take effect on passage.
